1.19 ~~this section provided the sibling attends the same program as long as funds are available;~~

2.2 a scholarship each year until that child is eligible for kindergarten under section 120A.20
2.3 and as long as funds are available.

2.4 (d) Early learning scholarships may not be counted as earned income for the purposes
2.5 of medical assistance under chapter 256B, MinnesotaCare under chapter 256L, Minnesota
2.6 family investment program under chapter 256J, child care assistance programs under chapter
2.7 119B, or Head Start under the federal Improving Head Start for School Readiness Act of
2.8 2007.

2.9 (e) A child from an adjoining state whose family resides at a Minnesota address as
2.10 assigned by the United States Postal Service, who has received developmental screening
2.11 under sections 121A.16 to 121A.19, who intends to enroll in a Minnesota school district,
2.12 and whose family meets the criteria of paragraph (a) is eligible for an early learning
2.13 scholarship under this section."
