Bill Description

This bill adds a new requirement to the State Building Code (MS 326B) for a minimum number of electric vehicle ready spaces, electric vehicle capable spaces, and electric vehicle charging stations in certain new or significantly remodeled commercial and multifamily structures that provide on-site parking facilities. The bill defines electric vehicle capable space, electric vehicle charging station, and electric vehicle ready space.

Assumptions

The MN Department of Labor & Industry (DLI) will need to amend the current State Building Code by opening rulemaking to implement the bill.

DLI assumes there will likely be some opposition to the new requirement as it will increase costs to new and significantly remodeled projects containing parking facilities and the proposed rulemaking will be contentious. No other significant or controversial rule amendments will be proposed with this rulemaking. Per the MN Rulemaking Manual cost estimates, DLI estimates a Medium Rule for \$133,376.
