Bill Description

This bill amends existing body piercing laws.

Section 1 expands the definition of supervision to include definitions of direct supervision and indirect supervision of piercers who are in training.

Section 2 adds new requirements relative to supervised experience and safety training for all piercers after January 1_{st} 2017.

Section 3 requires the Commissioner of Health to notify a licensed technician 60 days before a license expires.

Section 4 adjusts an internal statutory reference to align with the amendments.

Section 5 requires that person applying for a body piercing technician license or a dual body art technician license must complete a minimum of 250 body piercings under direct supervision and 250 under indirect supervision.

Section 6 clarifies that the identification requirement in subdivision 1 of §146B.01 applies only to clients who state they are over 18 years of age.

Section 7 sets consent and identification requirements when an individual under the age of 18 seeks to be pierced.

Assumptions

It is assumed that the bill takes effective August 1, 2017 except for new licensure requirements, which take effect January 1st, 2017. It is assumed that all body artists renew their license in March.

It is assumed that 60% of persons with temporary licenses will go on to become fully licensed.

Processing applications for licenses will take longer due to the new regulations in the bill. It is estimated that a temporary license will take an additional 30 minutes and other licenses will take an additional 10 minutes per application. The number

of applications have been increasing 8.5% per year. This will take an overall additional .04 FTE to process. Assumptions are:

Additional licensing work will thus require .04 FTE. Support and management of this additional work is estimated to be .014 FTE, for a total FTE impact of .05 FTE.
