1.20 Subd. 3. **Notice of primary to public.** At least 15 days before the date of the presidential
1.21 nomination primary, each municipal clerk shall post a public notice stating the date of the

2.1 presidential nomination primary, the location of each polling place in the municipality, the
 2.2 hours during which the polling places in the municipality will be open, and information
 2.3 about the requirements of section 207A.12, paragraph (b), including a notice that the voter's
 2.4 choice of a political party's ballot will be recorded ~~and is public information~~. The county
 2.5 auditor shall post a similar notice in the auditor's office with information for any polling
 2.6 places in unorganized territory in the county. The governing body of a municipality or
 2.7 county may publish the notice in addition to posting it. Failure to give notice does not
 2.8 invalidate the election."

2.10 "Sec. Minnesota Statutes 2018, section 207A.15, subdivision 2, is amended to read:

2.11 Subd. 2. **Reimbursable local expenses.** (a) The secretary of state shall reimburse the
 2.12 counties and municipalities for expenses incurred in the administration of the presidential
 2.13 nomination primary from money contained in the presidential nomination primary elections
 2.14 account. The following expenses are eligible for reimbursement: preparation and printing
 2.15 of ballots; postage for absentee ballots; publication of the sample ballot; preparation of
 2.16 polling places in an amount not to exceed \$150 per polling place; preparation of electronic
 2.17 voting systems in an amount not to exceed \$100 per precinct; compensation for temporary
 2.18 staff or overtime payments; salaries of election judges; ~~and~~ compensation of county
 2.19 canvassing board members; and other expenses as approved by the secretary of state.

2.20 (b) Within 60 days after the results of a presidential nomination primary are certified
 2.21 by the State Canvassing Board, the county auditor must submit a request for payment of
 2.22 the costs incurred by the county for conducting the presidential nomination primary, and
 2.23 the municipal clerk must submit a request for payment of the costs incurred by the
 2.24 municipality for conducting the presidential nomination primary. The request for payment
 2.25 must be submitted to the secretary of state, and must be accompanied by an itemized
 2.26 description of actual county or municipal expenditures, including copies of invoices. In
 2.27 addition, the county auditor or municipal clerk must certify that the request for reimbursement
 2.28 is based on actual costs incurred by the county or municipality in the presidential nomination
 2.29 primary.

2.30 (c) The secretary of state shall provide each county and municipality with the appropriate
 2.31 forms for requesting payment and certifying expenses under this subdivision. The secretary
 2.32 of state must not reimburse expenses unless the request for payment and certification of
 2.33 costs has been submitted as provided in this subdivision. The secretary of state must complete
 2.34 the issuance of reimbursements to the counties and municipalities no later than 90 days after
