4.5 assessment, the license holder must evaluate the client's ability to: (i) comply with prescribed
4.6 medication regimens; and (ii) store the client's medications safely and in a manner that
4.7 protects other individuals in the facility. Through the assessment process, the license holder
4.8 must assist the client in developing the skills necessary to safely self-administer medication;

4.9 (2) monitor the effectiveness of medications, side effects of medications, and adverse
4.10 reactions to medications for each client. The license holder must address and document any
4.11 concerns about a client's medications;

4.12 (3) ensure that no staff person or client gives a legend drug supply for one client to
4.13 another client;

6.27 ADULT MENTAL HEALTH SERVICES

6.28 Section 1. Minnesota Statutes 2022, section 245.462, subdivision 6, is amended to read:

6.29 Subd. 6. **Community support services program.** "Community support services program"
6.30 means services, other than inpatient or residential treatment services, provided or coordinated
6.31 by an identified program and staff under the treatment supervision of a mental health
6.32 professional designed to help adults with serious and persistent mental illness to function
6.33 and remain in the community. A community support services program includes:

- 7.1 (1) client outreach,
- 7.2 (2) medication monitoring,
- 7.3 (3) assistance in independent living skills,
- 7.4 (4) development of employability and work-related opportunities,
- 7.5 (5) crisis assistance,
- 7.6 (6) psychosocial rehabilitation,
- 7.7 (7) help in applying for government benefits, and
- 7.8 (8) housing support services.

7.9 The community support services program must be coordinated with the case management
7.10 services specified in section 245.4711. A program that meets the accreditation standards
7.11 for Clubhouse International model programs meets the requirements of this subdivision.

7.12 **Sec. 2. [253B.042] ENGAGEMENT SERVICES PILOT GRANTS.**

7.13 Subdivision 1. **Creation.** The engagement services pilot grant program is established
7.14 in the Department of Human Services, to provide grants to counties or certified community
7.15 behavioral health centers to provide engagement services under section 253B.041.
7.16 Engagement services provide culturally responsive, person-centered early interventions to
7.17 prevent an individual from meeting the criteria for civil commitment and promote positive
7.18 outcomes.

7.19 Subd. 2. **Allowable grant activities.** (a) Grantees must use grant funding to:

7.20 (1) develop a system to respond to requests for engagement services;

7.21 (2) provide the following engagement services, taking into account an individual's
7.22 preferences for treatment services and supports:

7.23 (i) assertive attempts to engage an individual in voluntary treatment for mental illness
7.24 for at least 90 days;

7.25 (ii) efforts to engage an individual's existing support systems and interested persons,
7.26 including but not limited to providing education on restricting means of harm and suicide
7.27 prevention, when the provider determines that such engagement would be helpful; and

7.28 (iii) collaboration with the individual to meet the individual's immediate needs, including
7.29 but not limited to housing access, food and income assistance, disability verification,
7.30 medication management, and medical treatment;

8.1 (3) conduct outreach to families and providers; and

8.2 (4) evaluate the impact of engagement services on decreasing civil commitments,
8.3 increasing engagement in treatment, decreasing police involvement with individuals
8.4 exhibiting symptoms of serious mental illness, and other measures.

8.5 (b) Engagement services staff must have completed training on person-centered care.
8.6 Staff may include but are not limited to mobile crisis providers under section 256B.0624,
8.7 certified peer specialists under section 256B.0615, community-based treatment programs
8.8 staff, and homeless outreach workers.

8.9 Subd. 3. **Outcome evaluation.** The commissioner of management and budget must
8.10 formally evaluate outcomes of grants awarded under this section, using an experimental or
8.11 quasi-experimental design. The commissioner shall consult with the commissioner of
8.12 management and budget to ensure that grants are administered to facilitate this evaluation.
8.13 Grantees must collect and provide the information needed to the commissioner of human
8.14 services to complete the evaluation. The commissioner must provide the information collected
8.15 to the commissioner of management and budget to conduct the evaluation. The commissioner
8.16 of management and budget may obtain additional relevant data to support the evaluation
8.17 study pursuant to section 15.08.

8.18 Sec. 3. Minnesota Statutes 2022, section 256B.0622, subdivision 2a, is amended to read:

8.19 Subd. 2a. **Eligibility for assertive community treatment.** (a) An eligible client for
8.20 assertive community treatment is an individual who meets the following criteria as assessed
8.21 by an ACT team:

8.22 (1) is age 18 or older. Individuals ages 16 and 17 may be eligible upon approval by the
8.23 commissioner;

8.24 (2) has a primary diagnosis of schizophrenia, schizoaffective disorder, major depressive
8.25 disorder with psychotic features, other psychotic disorders, or bipolar disorder. Individuals
8.26 with other psychiatric illnesses may qualify for assertive community treatment if they have
8.27 a serious mental illness and meet the criteria outlined in clauses (3) and (4), but no more
8.28 than ten percent of an ACT team's clients may be eligible based on this criteria. Individuals
8.29 with a primary diagnosis of a substance use disorder, intellectual developmental disabilities,
8.30 borderline personality disorder, antisocial personality disorder, traumatic brain injury, or
8.31 an autism spectrum disorder are not eligible for assertive community treatment;

8.32 (3) has significant functional impairment as demonstrated by at least one of the following
8.33 conditions:

9.1 (i) significant difficulty consistently performing the range of routine tasks required for
9.2 basic adult functioning in the community or persistent difficulty performing daily living
9.3 tasks without significant support or assistance;

9.4 (ii) significant difficulty maintaining employment at a self-sustaining level or significant
9.5 difficulty consistently carrying out the head-of-household responsibilities; or

9.6 (iii) significant difficulty maintaining a safe living situation;

9.7 (4) has a need for continuous high-intensity services as evidenced by at least two of the
9.8 following:

9.9 (i) two or more psychiatric hospitalizations or residential crisis stabilization services in
9.10 the previous 12 months;

9.11 (ii) frequent utilization of mental health crisis services in the previous six months;

9.12 (iii) 30 or more consecutive days of psychiatric hospitalization in the previous 24 months;

9.13 (iv) intractable, persistent, or prolonged severe psychiatric symptoms;

9.14 (v) coexisting mental health and substance use disorders lasting at least six months;

9.15 (vi) recent history of involvement with the criminal justice system or demonstrated risk
9.16 of future involvement;

9.17 (vii) significant difficulty meeting basic survival needs;

9.18 (viii) residing in substandard housing, experiencing homelessness, or facing imminent
9.19 risk of homelessness;

9.20 (ix) significant impairment with social and interpersonal functioning such that basic
9.21 needs are in jeopardy;

9.22 (x) coexisting mental health and physical health disorders lasting at least six months;

9.23 (xi) residing in an inpatient or supervised community residence but clinically assessed
9.24 to be able to live in a more independent living situation if intensive services are provided;

9.25 (xii) requiring a residential placement if more intensive services are not available; or

9.26 (xiii) difficulty effectively using traditional office-based outpatient services;

9.27 (5) there are no indications that other available community-based services would be
9.28 equally or more effective as evidenced by consistent and extensive efforts to treat the
9.29 individual; and

10.1 (6) in the written opinion of a licensed mental health professional, has the need for mental
10.2 health services that cannot be met with other available community-based services, or is
10.3 likely to experience a mental health crisis or require a more restrictive setting if assertive
10.4 community treatment is not provided.

10.5 (b) An individual meets the criteria for assertive community treatment under this section
10.6 immediately following participation in a first episode of psychosis program if the individual:

10.9 (2) is currently participating in a first episode of psychosis program under section
10.10 245.4905; and

10.11 (3) needs the level of intensity provided by an ACT team, in the opinion of the individual's
10.12 first episode of psychosis program, in order to prevent crisis services, hospitalization,
10.13 homelessness, and involvement with the criminal justice system.

10.15 Subd. 3a. **Provider certification and contract requirements for assertive community**
10.16 **treatment.** (a) The assertive community treatment provider must:

10.17 ~~(1) have a contract with the host county to provide assertive community treatment~~
10.18 ~~services; and~~

10.19 ~~(2)~~ have each ACT team be certified by the state following the certification process and
10.20 procedures developed by the commissioner. The certification process determines whether
10.21 the ACT team meets the standards for assertive community treatment under this section,
10.22 the standards in chapter 245I as required in section 245I.011, subdivision 5, and minimum
10.23 program fidelity standards as measured by a nationally recognized fidelity tool approved
10.24 by the commissioner. Recertification must occur at least every three years.

11.14 eligible for licensure and are otherwise qualified may also fulfill this role ~~but must obtain~~
11.15 ~~full licensure within 24 months of assuming the role of team leader;~~

11.16 (ii) must be an active member of the ACT team and provide some direct services to
11.17 clients;

11.18 (iii) must be a single full-time staff member, dedicated to the ACT team, who is
11.19 responsible for overseeing the administrative operations of the team, ~~providing treatment~~
11.20 ~~supervision of services in conjunction with the psychiatrist or psychiatric care provider,~~ and
11.21 supervising team members to ensure delivery of best and ethical practices; and

11.22 (iv) must be available to ~~provide~~ ensure that overall treatment supervision to the ACT
11.23 team is available after regular business hours and on weekends and holidays. ~~The team~~

11.26 (2) the psychiatric care provider:

11.27 (i) must be a mental health professional permitted to prescribe psychiatric medications
11.28 as part of the mental health professional's scope of practice. The psychiatric care provider
11.29 must have demonstrated clinical experience working with individuals with serious and
11.30 persistent mental illness;

11.31 (ii) shall collaborate with the team leader in sharing overall clinical responsibility for
11.32 screening and admitting clients; monitoring clients' treatment and team member service

12.1 delivery; educating staff on psychiatric and nonpsychiatric medications, their side effects,
12.2 and health-related conditions; actively collaborating with nurses; and helping provide
12.3 treatment supervision to the team;

12.4 (iii) shall fulfill the following functions for assertive community treatment clients:
12.5 provide assessment and treatment of clients' symptoms and response to medications, including
12.6 side effects; provide brief therapy to clients; provide diagnostic and medication education
12.7 to clients, with medication decisions based on shared decision making; monitor clients'
12.8 nonpsychiatric medical conditions and nonpsychiatric medications; and conduct home and
12.9 community visits;

12.10 (iv) shall serve as the point of contact for psychiatric treatment if a client is hospitalized
12.11 for mental health treatment and shall communicate directly with the client's inpatient
12.12 psychiatric care providers to ensure continuity of care;

12.13 (v) shall have a minimum full-time equivalency that is prorated at a rate of 16 hours per
12.14 50 clients. Part-time psychiatric care providers shall have designated hours to work on the
12.15 team, with sufficient blocks of time on consistent days to carry out the provider's clinical,
12.16 supervisory, and administrative responsibilities. No more than two psychiatric care providers
12.17 may share this role; and

12.18 (vi) shall provide psychiatric backup to the program after regular business hours and on
12.19 weekends and holidays. The psychiatric care provider may delegate this duty to another
12.20 qualified psychiatric provider;

12.21 (3) the nursing staff:

12.22 (i) shall consist of one to three registered nurses or advanced practice registered nurses,
12.23 of whom at least one has a minimum of one-year experience working with adults with
12.24 serious mental illness and a working knowledge of psychiatric medications. No more than
12.25 two individuals can share a full-time equivalent position;

12.26 (ii) are responsible for managing medication, administering and documenting medication
12.27 treatment, and managing a secure medication room; and

12.28 (iii) shall develop strategies, in collaboration with clients, to maximize taking medications
12.29 as prescribed; screen and monitor clients' mental and physical health conditions and
12.30 medication side effects; engage in health promotion, prevention, and education activities;
12.31 communicate and coordinate services with other medical providers; facilitate the development
12.32 of the individual treatment plan for clients assigned; and educate the ACT team in monitoring
12.33 psychiatric and physical health symptoms and medication side effects;

13.1 (4) the co-occurring disorder specialist:

13.2 (i) shall be a full-time equivalent co-occurring disorder specialist who has received
13.3 specific training on co-occurring disorders that is consistent with national evidence-based
13.4 practices. The training must include practical knowledge of common substances and how
13.5 they affect mental illnesses, the ability to assess substance use disorders and the client's
13.6 stage of treatment, motivational interviewing, and skills necessary to provide counseling to
13.7 clients at all different stages of change and treatment. The co-occurring disorder specialist
13.8 may also be an individual who is a licensed alcohol and drug counselor as described in
