- 1.13 and for the purposes specified in this article. The appropriations are from the trunk highway
- 1.14 fund, or another named fund, and are available for the fiscal years indicated for each purpose.
- 1.15 Amounts for "Total Appropriation" and sums shown in the corresponding columns marked
- 1.16 "Appropriations by Fund" are summary only and do not have legal effect. The figures "2020"
- 1.17 and "2021" used in this article mean that the appropriations listed under them are available
- 1.18 for the fiscal year ending June 30, 2020, or June 30, 2021, respectively. "The first year" is
- 1.19 fiscal year 2020. "The second year" is fiscal year 2021. "The biennium" is fiscal years 2020
- 1.20 and 2021. "C.S.A.H." is the county state-aid highway fund. "M.S.A.S." is the municipal
- 1.21 state-aid street fund. "H.U.T.D." is the highway user tax distribution fund.
