1.3 "ARTICLE 1
1.4 REORGANIZATION

1.5 Section 1. [260E.01] POLICY.

1.6 (a) The legislature hereby declares that the public policy of this state is to protect children
1.7 whose health or welfare may be jeopardized through maltreatment. While it is recognized
1.8 that most parents want to keep their children safe, sometimes circumstances or conditions
1.9 interfere with their ability to do so. When this occurs, the health and safety of the children
1.10 must be of paramount concern. Intervention and prevention efforts must address immediate
1.11 concerns for child safety and the ongoing risk of maltreatment and should engage the
1.12 protective capacities of families. In furtherance of this public policy, it is the intent of the
1.13 legislature under this chapter to:

1.14 (1) protect children and promote child safety;

1.15 (2) strengthen the family;

1.16 (3) make the home, school, and community safe for children by promoting responsible
1.17 child care in all settings; and

1.18 (4) provide, when necessary, a safe temporary or permanent home environment for
1.19 maltreated children.

1.20 (b) In addition, it is the policy of this state to:

1.21 (1) require the reporting of maltreatment of children in the home, school, and community
1.22 settings;

1.23 (2) provide for the voluntary reporting of maltreatment of children;

2.1 (3) require an investigation when the report alleges sexual abuse or substantial child
 2.2 endangerment;

2.3 (4) provide a family assessment, if appropriate, when the report does not allege sexual
 2.4 abuse or substantial child endangerment; and

2.5 (5) provide protective, family support, and family preservation services when needed
 2.6 in appropriate cases.

2.7 **Sec. 2. [260E.02] MULTIDISCIPLINARY CHILD PROTECTION TEAM.**

2.8 Subdivision 1. **Establishment of team.** A county shall establish a multidisciplinary
 2.9 child protection team that may include, but not be limited to, the director of the local welfare
 2.10 agency or designees, the county attorney or designees, the county sheriff or designees,
 2.11 representatives of health and education, representatives of mental health or other appropriate
 2.12 human service or community-based agencies, and parent groups. As used in this section, a
 2.13 "community-based agency" may include, but is not limited to, schools, social service
 2.14 agencies, family service and mental health collaboratives, children's advocacy centers, early
 2.15 childhood and family education programs, Head Start, or other agencies serving children
 2.16 and families. A member of the team must be designated as the lead person of the team
 2.17 responsible for the planning process to develop standards for the team's activities with
 2.18 battered women's and domestic abuse programs and services.

2.19 Subd. 2. **Duties of team.** A multidisciplinary child protection team may provide public
 2.20 and professional education, develop resources for prevention, intervention, and treatment,
 2.21 and provide case consultation to the local welfare agency or other interested community-based
 2.22 agencies. The community-based agencies may request case consultation from the
 2.23 multidisciplinary child protection team regarding a child or family for whom the
 2.24 community-based agency is providing services. As used in this section, "case consultation"
 2.25 means a case review process in which recommendations are made concerning services to
 2.26 be provided to the identified children and family. Case consultation may be performed by
 2.27 a committee or subcommittee of members representing human services, including mental
 2.28 health and chemical dependency; law enforcement, including probation and parole; the
 2.29 county attorney; a children's advocacy center; health care; education; community-based
 2.30 agencies and other necessary agencies; and persons directly involved in an individual case
 2.31 as designated by other members performing case consultation.

2.32 Subd. 3. **Sexually exploited youth outreach program.** A multidisciplinary child
 2.33 protection team may assist the local welfare agency, local law enforcement agency, or an
 2.34 appropriate private organization in developing a program of outreach services for sexually

3.1 exploited youth, including homeless, runaway, and truant youth who are at risk of sexual
3.2 exploitation. For the purposes of this subdivision, at least one representative of a youth
3.3 intervention program or, where this type of program is unavailable, one representative of a
3.4 nonprofit agency serving youth in crisis shall be appointed to and serve on the
3.5 multidisciplinary child protection team in addition to the standing members of the team.
3.6 These services may include counseling, medical care, short-term shelter, alternative living
3.7 arrangements, and drop-in centers. A juvenile's receipt of intervention services under this
3.8 subdivision may not be conditioned upon the juvenile providing any evidence or testimony.

3.9 Subd. 4. **Information sharing.** (a) The local welfare agency may make available to the
3.10 case consultation committee or subcommittee all records collected and maintained by the
3.11 agency under this chapter and in connection with case consultation. A case consultation
3.12 committee or subcommittee member may share information acquired in the member's
3.13 professional capacity with the committee or subcommittee to assist in case consultation.

3.14 (b) Case consultation committee or subcommittee members must annually sign a data
3.15 sharing agreement, approved by the commissioner of human services, assuring compliance
3.16 with chapter 13. Not public data, as defined in section 13.02, subdivision 8a, may be shared
3.17 with members appointed to the committee or subcommittee in connection with an individual
3.18 case when the members have signed the data sharing agreement.

3.19 (c) All data acquired by the case consultation committee or subcommittee in exercising
3.20 case consultation duties are confidential as defined in section 13.02, subdivision 3, and shall
3.21 not be disclosed except to the extent necessary to perform case consultation, and shall not
3.22 be subject to subpoena or discovery.

3.23 (d) No members of a case consultation committee or subcommittee meeting shall disclose
3.24 what transpired at a case consultation meeting, except to the extent necessary to carry out
3.25 the case consultation plan. The proceedings and records of the case consultation meeting
3.26 are not subject to discovery, and may not be introduced into evidence in any civil or criminal
3.27 action against a professional or local welfare agency arising out of the matter or matters
3.28 which are the subject of consideration of the case consultation meeting. Information,
3.29 documents, or records otherwise available from original sources are not immune from
3.30 discovery or use in any civil or criminal action merely because they were presented during
3.31 a case consultation meeting. Any person who presented information before the consultation
3.32 committee or subcommittee or who is a member shall not be prevented from testifying as
3.33 to matters within the person's knowledge. However, in a civil or criminal proceeding a
3.34 person shall not be questioned about the person's presentation of information before the

4.1 case consultation committee or subcommittee or about opinions formed as a result of the
 4.2 case consultation meetings.

4.3 (e) A person who violates this subdivision is subject to the civil remedies and penalties
 4.4 provided under chapter 13.

4.5 Subd. 5. **Children's advocacy center; definition.** (a) For purposes of this section,
 4.6 "children's advocacy center" means an organization using a multidisciplinary team approach
 4.7 whose primary purpose is to provide children who have been the victims of abuse and their
 4.8 nonoffending family members with:

4.9 (1) support and advocacy;

4.10 (2) specialized medical evaluation;

4.11 (3) trauma-focused mental health services; and

4.12 (4) forensic interviews.

4.13 (b) Children's advocacy centers provide multidisciplinary case review and the tracking
 4.14 and monitoring of case progress.

4.15 Sec. 3. **[260E.03] DEFINITIONS.**

4.16 Subdivision 1. **Scope.** As used in this chapter, the following terms have the meanings
 4.17 given them unless the specific content indicates otherwise.

4.18 Subd. 2. **Accidental.** "Accidental" means a sudden, not reasonably foreseeable, and
 4.19 unexpected occurrence or event that:

4.20 (1) is not likely to occur and could not have been prevented by exercise of due care; and

4.21 (2) if occurring while a child is receiving services from a facility, happens when the
 4.22 facility and the employee or person providing services in the facility are in compliance with
 4.23 the laws and rules relevant to the occurrence or event.

4.24 Subd. 3. **Child fatality.** "Child fatality" means the death of a child from maltreatment.

4.25 Subd. 4. **Commissioner.** "Commissioner" means the commissioner of human services
 4.26 unless otherwise indicated in this chapter.

4.27 Subd. 5. **Egregious harm.** "Egregious harm" means harm under section 260C.007,
 4.28 subdivision 14, or a similar law of another jurisdiction.

4.29 Subd. 6. **Facility.** "Facility" means:

5.1 (1) a licensed or unlicensed day care facility, certified license-exempt child care center,
5.2 residential facility, agency, hospital, sanitarium, or other facility or institution required to
5.3 be licensed under sections 144.50 to 144.58, 241.021, or 245A.01 to 245A.16, or chapter
5.4 144H, 245D, or 245H;

5.5 (2) a school as defined in section 120A.05, subdivisions 9, 11, and 13; and chapter 124E;
5.6 or

5.7 (3) a nonlicensed personal care provider organization as defined in section 256B.0625,
5.8 subdivision 19a.

5.9 Subd. 7. **Family assessment.** "Family assessment" means a comprehensive assessment
5.10 of child safety, risk of subsequent maltreatment, and family strengths and needs that is
5.11 applied to a maltreatment report that does not allege sexual abuse or substantial child
5.12 endangerment. Family assessment does not include a determination as to whether
5.13 maltreatment occurred but does determine the need for services to address the safety of
5.14 family members and the risk of subsequent maltreatment.

5.15 Subd. 8. **Findings and information.** "Findings and information" means a written
5.16 summary described in section 260E.35, subdivision 7, paragraph (b), of actions taken or
5.17 services rendered by a local welfare agency following receipt of a report.

5.18 Subd. 9. **Immediately.** "Immediately" means as soon as possible but in no event longer
5.19 than 24 hours.

5.20 Subd. 10. **Interested person acting on behalf of the child.** "Interested person acting
5.21 on behalf of the child" means a parent or legal guardian; stepparent; grandparent; guardian
5.22 ad litem; adult stepbrother, stepsister, or sibling; or adult aunt or uncle; unless the person
5.23 has been determined to be the offender who committed the maltreatment.

5.24 Subd. 11. **Investigation.** "Investigation" means fact gathering conducted during:

5.25 (1) a family investigation related to the current safety of a child and the risk of subsequent
5.26 maltreatment that determines whether maltreatment occurred and whether child protective
5.27 services are needed; or

5.28 (2) a facility investigation related to duties under section 260E.28.

5.29 Subd. 12. **Maltreatment.** "Maltreatment" means any of the following acts or omissions:

5.30 (1) egregious harm under subdivision 5;

5.31 (2) neglect under subdivision 15;

5.32 (3) physical abuse under subdivision 18;

6.1 (4) sexual abuse under subdivision 20;

6.2 (5) substantial child endangerment under subdivision 22;

6.3 (6) threatened injury under subdivision 23;

6.4 (7) mental injury under subdivision 13; and

6.5 (8) maltreatment of a child in a facility.

6.6 Subd. 13. **Mental injury.** "Mental injury" means an injury to the psychological capacity
6.7 or emotional stability of a child as evidenced by an observable or substantial impairment
6.8 in the child's ability to function within a normal range of performance and behavior with
6.9 due regard to the child's culture.

6.10 Subd. 14. **Near fatality.** "Near fatality" means a case in which a physician, advanced
6.11 practice registered nurse, or physician assistant determines that a child is in serious or critical
6.12 condition as the result of sickness or injury caused by maltreatment.

6.13 Subd. 15. **Neglect.** (a) "Neglect" means the commission or omission of any of the acts
6.14 specified under clauses (1) to (8), other than by accidental means:

6.15 (1) failure by a person responsible for a child's care to supply a child with necessary
6.16 food, clothing, shelter, health, medical, or other care required for the child's physical or
6.17 mental health when reasonably able to do so;

6.18 (2) failure to protect a child from conditions or actions that seriously endanger the child's
6.19 physical or mental health when reasonably able to do so, including a growth delay, which
6.20 may be referred to as a failure to thrive, that has been diagnosed by a physician and is due
6.21 to parental neglect;

6.22 (3) failure to provide for necessary supervision or child care arrangements appropriate
6.23 for a child after considering factors as the child's age, mental ability, physical condition,
6.24 length of absence, or environment, when the child is unable to care for the child's own basic
6.25 needs or safety, or the basic needs or safety of another child in their care;

6.26 (4) failure to ensure that the child is educated as defined in sections 120A.22 and
6.27 260C.163, subdivision 11, which does not include a parent's refusal to provide the parent's
6.28 child with sympathomimetic medications, consistent with section 125A.091, subdivision
6.29 5;

6.30 (5) prenatal exposure to a controlled substance, as defined in section 253B.02, subdivision
6.31 2, used by the mother for a nonmedical purpose, as evidenced by withdrawal symptoms in
6.32 the child at birth, results of a toxicology test performed on the mother at delivery or the

7.1 child at birth, medical effects or developmental delays during the child's first year of life
7.2 that medically indicate prenatal exposure to a controlled substance, or the presence of a
7.3 fetal alcohol spectrum disorder;

7.4 (6) medical neglect, as defined in section 260C.007, subdivision 6, clause (5);

7.5 (7) chronic and severe use of alcohol or a controlled substance by a person responsible
7.6 for the child's care that adversely affects the child's basic needs and safety; or

7.7 (8) emotional harm from a pattern of behavior that contributes to impaired emotional
7.8 functioning of the child, which may be demonstrated by a substantial and observable effect
7.9 in the child's behavior, emotional response, or cognition that is not within the normal range
7.10 for the child's age and stage of development, with due regard to the child's culture.

7.11 (b) Nothing in this chapter shall be construed to mean that a child is neglected solely
7.12 because the child's parent, guardian, or other person responsible for the child's care in good
7.13 faith selects and depends upon spiritual means or prayer for treatment or care of disease or
7.14 remedial care of the child in lieu of medical care.

7.15 (c) This chapter does not impose upon persons not otherwise legally responsible for
7.16 providing a child with necessary food, clothing, shelter, education, or medical care a duty
7.17 to provide that care.

7.18 Subd. 16. **Person in a current or recent position of authority.** "Person in a current or
7.19 recent position of authority" means an individual in a position of authority over a child and
7.20 includes but is not limited to any person who is a parent or acting in the place of a parent
7.21 and charged with any of a parent's rights, duties, or responsibilities to a child, or a person
7.22 who is charged with any duty or responsibility for the health, welfare, or supervision of a
7.23 child, either independently or through another, no matter how brief, within 120 days
7.24 immediately preceding the act. Person in a position of authority includes a psychotherapist.

7.25 Subd. 17. **Person responsible for the child's care.** "Person responsible for the child's
7.26 care" means (1) an individual functioning within the family unit and having responsibilities
7.27 for the care of the child such as a parent, guardian, or other person having similar care
7.28 responsibilities, or (2) an individual functioning outside the family unit and having
7.29 responsibilities for the care of the child such as a teacher, school administrator, other school
7.30 employee or agent, or other lawful custodian of a child having either full-time or short-term
7.31 care responsibilities including, but not limited to, day care, babysitting whether paid or
7.32 unpaid, counseling, teaching, and coaching.

8.1 Subd. 18. **Physical abuse.** (a) "Physical abuse" means any physical injury, mental injury
8.2 under subdivision 14, or threatened injury under subdivision 23, inflicted by a person
8.3 responsible for the child's care on a child other than by accidental means, or any physical
8.4 or mental injury that cannot reasonably be explained by the child's history of injuries, or
8.5 any aversive or deprivation procedures, or regulated interventions, that have not been
8.6 authorized under section 125A.0942 or 245.825.

8.7 (b) Abuse does not include reasonable and moderate physical discipline of a child
8.8 administered by a parent or legal guardian that does not result in an injury. Abuse does not
8.9 include the use of reasonable force by a teacher, principal, or school employee as allowed
8.10 by section 121A.582.

8.11 (c) For the purposes of this subdivision, actions that are not reasonable and moderate
8.12 include, but are not limited to, any of the following:

8.13 (1) throwing, kicking, burning, biting, or cutting a child;

8.14 (2) striking a child with a closed fist;

8.15 (3) shaking a child under age three;

8.16 (4) striking or other actions that result in any nonaccidental injury to a child under 18
8.17 months of age;

8.18 (5) unreasonable interference with a child's breathing;

8.19 (6) threatening a child with a weapon, as defined in section 609.02, subdivision 6;

8.20 (7) striking a child under age one on the face or head;

8.21 (8) striking a child who is at least age one but under age four on the face or head, which
8.22 results in an injury;

8.23 (9) purposely giving a child:

8.24 (i) poison, alcohol, or dangerous, harmful, or controlled substances that were not
8.25 prescribed for the child by a practitioner in order to control or punish the child; or

8.26 (ii) other substances that substantially affect the child's behavior, motor coordination,
8.27 or judgment; that result in sickness or internal injury; or that subject the child to medical
8.28 procedures that would be unnecessary if the child were not exposed to the substances;

8.29 (10) unreasonable physical confinement or restraint not permitted under section 609.379,
8.30 including but not limited to tying, caging, or chaining; or

9.1 (11) in a school facility or school zone, an act by a person responsible for the child's
9.2 care that is a violation under section 121A.58.

9.3 Subd. 19. **Report.** "Report" means any communication received by the local welfare
9.4 agency, police department, county sheriff, or agency responsible for child protection pursuant
9.5 to this section that describes maltreatment of a child and contains sufficient content to
9.6 identify the child and any person believed to be responsible for the maltreatment, if known.

9.7 Subd. 20. **Sexual abuse.** "Sexual abuse" means the subjection of a child by a person
9.8 responsible for the child's care, by a person who has a significant relationship to the child,
9.9 or by a person in a current or recent position of authority, to any act that constitutes a
9.10 violation of section 609.342 (criminal sexual conduct in the first degree), 609.343 (criminal
9.11 sexual conduct in the second degree), 609.344 (criminal sexual conduct in the third degree),
9.12 609.345 (criminal sexual conduct in the fourth degree), 609.3451 (criminal sexual conduct
9.13 in the fifth degree), or 609.352 (solicitation of children to engage in sexual conduct;
9.14 communication of sexually explicit materials to children). Sexual abuse also includes any
9.15 act involving a child that constitutes a violation of prostitution offenses under sections
9.16 609.321 to 609.324 or 617.246. Sexual abuse includes all reports of known or suspected
9.17 child sex trafficking involving a child who is identified as a victim of sex trafficking. Sexual
9.18 abuse includes child sex trafficking as defined in section 609.321, subdivisions 7a and 7b.
9.19 Sexual abuse includes threatened sexual abuse, which includes the status of a parent or
9.20 household member who has committed a violation that requires registration as an offender
9.21 under section 243.166, subdivision 1b, paragraph (a) or (b), or required registration under
9.22 section 243.166, subdivision 1b, paragraph (a) or (b).

9.23 Subd. 21. **Significant relationship.** "Significant relationship" means a situation in which
9.24 the alleged offender is:

9.25 (1) the child's parent, stepparent, or guardian;

9.26 (2) any of the following persons related to the child by blood, marriage, or adoption:
9.27 brother, sister, stepbrother, stepsister, first cousin, aunt, uncle, nephew, niece, grandparent,
9.28 great-grandparent, great-uncle, great-aunt; or

9.29 (3) an adult who jointly resides intermittently or regularly in the same dwelling as the
9.30 child and who is not the child's spouse.

9.31 Subd. 22. **Substantial child endangerment.** "Substantial child endangerment" means
9.32 that a person responsible for a child's care, by act or omission, commits or attempts to
9.33 commit an act against a child under their care that constitutes any of the following:

- 10.1 (1) egregious harm under subdivision 5;
- 10.2 (2) abandonment under section 260C.301, subdivision 2;
- 10.3 (3) neglect under subdivision 15, paragraph (a), clause (2), that substantially endangers
10.4 the child's physical or mental health, including a growth delay, which may be referred to
10.5 as failure to thrive, that has been diagnosed by a physician and is due to parental neglect;
- 10.6 (4) murder in the first, second, or third degree under section 609.185, 609.19, or 609.195;
- 10.7 (5) manslaughter in the first or second degree under section 609.20 or 609.205;
- 10.8 (6) assault in the first, second, or third degree under section 609.221, 609.222, or 609.223;
- 10.9 (7) solicitation, inducement, and promotion of prostitution under section 609.322;
- 10.10 (8) criminal sexual conduct under sections 609.342 to 609.3451;
- 10.11 (9) solicitation of children to engage in sexual conduct under section 609.352;
- 10.12 (10) malicious punishment or neglect or endangerment of a child under section 609.377
10.13 or 609.378;
- 10.14 (11) use of a minor in sexual performance under section 617.246; or
- 10.15 (12) parental behavior, status, or condition that mandates that the county attorney file a
10.16 termination of parental rights petition under section 260C.503, subdivision 2.
- 10.17 Subd. 23. **Threatened injury.** (a) "Threatened injury" means a statement, overt act,
10.18 condition, or status that represents a substantial risk of physical or sexual abuse or mental
10.19 injury.
- 10.20 (b) Threatened injury includes, but is not limited to, exposing a child to a person
10.21 responsible for the child's care, as defined in subdivision 17, who has:
- 10.22 (1) subjected a child to, or failed to protect a child from, an overt act or condition that
10.23 constitutes egregious harm under subdivision 5 or a similar law of another jurisdiction;
- 10.24 (2) been found to be palpably unfit under section 260C.301, subdivision 1, paragraph
10.25 (b), clause (4), or a similar law of another jurisdiction;
- 10.26 (3) committed an act that resulted in an involuntary termination of parental rights under
10.27 section 260C.301, or a similar law of another jurisdiction; or
- 10.28 (4) committed an act that resulted in the involuntary transfer of permanent legal and
10.29 physical custody of a child to a relative under Minnesota Statutes 2010, section 260C.201,

11.1 subdivision 11, paragraph (d), clause (1), section 260C.515, subdivision 4, or a similar law
11.2 of another jurisdiction.

11.3 (c) A child is the subject of a report of threatened injury when the local welfare agency
11.4 receives birth match data under section 260E.14, subdivision 4, from the Department of
11.5 Human Services.

11.6 Sec. 4. **[260E.04] EVIDENCE.**

11.7 No evidence relating to the maltreatment of a child or to any prior incident of
11.8 maltreatment involving any of the same persons accused of maltreatment shall be excluded
11.9 in any proceeding arising out of the alleged maltreatment on the grounds of privilege set
11.10 forth in section 595.02, subdivision 1, paragraph (a), (d), or (g).

11.11 Sec. 5. **[260E.05] CULTURAL PRACTICES.**

11.12 A person who conducts an assessment or investigation under this chapter shall take into
11.13 account accepted child-rearing practices of the culture in which a child participates and
11.14 accepted teacher discipline practices that are not injurious to the child's health, welfare, and
11.15 safety.

11.16 Sec. 6. **[260E.06] MALTREATMENT REPORTING.**

11.17 Subdivision 1. **Mandatory reporters.** (a) A person who knows or has reason to believe
11.18 a child is being maltreated, as defined in section 260E.03, or has been maltreated within
11.19 the preceding three years, shall immediately report the information to the local welfare
11.20 agency, agency responsible for assessing or investigating the report, police department,
11.21 county sheriff, tribal social services agency, or tribal police department if the person is:

11.22 (1) a professional or professional's delegate who is engaged in the practice of the healing
11.23 arts, social services, hospital administration, psychological or psychiatric treatment, child
11.24 care, education, correctional supervision, probation and correctional services, or law
11.25 enforcement; or

11.26 (2) employed as a member of the clergy and received the information while engaged in
11.27 ministerial duties, provided that a member of the clergy is not required by this subdivision
11.28 to report information that is otherwise privileged under section 595.02, subdivision 1,
11.29 paragraph (c).

12.1 (b) "Practice of social services," for the purposes of this subdivision, includes but is not
 12.2 limited to employee assistance counseling and the provision of guardian ad litem and
 12.3 parenting time expeditor services.

12.4 Subd. 2. **Voluntary reporters.** Any person may voluntarily report to the local welfare
 12.5 agency, agency responsible for assessing or investigating the report, police department,
 12.6 county sheriff, tribal social services agency, or tribal police department if the person knows,
 12.7 has reason to believe, or suspects a child is being or has been maltreated.

12.8 Subd. 3. **Reporting in cases where selection of spiritual means or prayer for**
 12.9 **treatment or care may cause serious danger to child's health.** If the child's parent,
 12.10 guardian, or other person responsible for the child's care in good faith selects and depends
 12.11 upon spiritual means or prayer for treatment or care of disease or remedial care of the child
 12.12 in lieu of medical care, the parent, guardian, or caretaker, or a person mandated to report
 12.13 pursuant to subdivision 1, has a duty to report if a lack of medical care may cause serious
 12.14 danger to the child's health.

12.15 Subd. 4. **Licensing board duty to report.** A board or other entity whose licensees
 12.16 perform work within a school facility, upon receiving a complaint of alleged maltreatment,
 12.17 shall report the alleged maltreatment to the commissioner of education.

12.18 Sec. 7. **[260E.07] RETALIATION PROHIBITED.**

12.19 (a) An employer of any person required to make reports under section 260E.06,
 12.20 subdivision 1, or 260E.11, subdivision 1, shall not retaliate against the person for reporting
 12.21 in good faith maltreatment pursuant to this chapter or against a child with respect to whom
 12.22 a report is made, because of the report.

12.23 (b) The employer of any person required to report under section 260E.06, subdivision
 12.24 1, or 260E.11, subdivision 1, who retaliates against the person because of a report of
 12.25 maltreatment is liable to that person for actual damages and, in addition, a penalty of up to
 12.26 \$10,000.

12.27 (c) There shall be a rebuttable presumption that any adverse action within 90 days of a
 12.28 report is retaliatory. For purposes of this paragraph, the term "adverse action" refers to action
 12.29 taken by an employer of a person required to report under section 260E.06, subdivision 1,
 12.30 or 260E.11, subdivision 1, which is involved in a report against the person making the report
 12.31 or the child with respect to whom the report was made because of the report, and includes,
 12.32 but is not limited to:

13.1 (1) discharge, suspension, termination, or transfer from the facility, institution, school,
 13.2 or agency;

13.3 (2) discharge from or termination of employment;

13.4 (3) demotion or reduction in remuneration for services; or

13.5 (4) restriction or prohibition of access to the facility, institution, school, agency, or
 13.6 persons affiliated with it.

13.7 **Sec. 8. [260E.08] CRIMINAL PENALTIES FOR FAILURE TO REPORT; CIVIL**
 13.8 **PENALTY FOR MAKING FALSE REPORT.**

13.9 (a) A person mandated by section 260E.06, subdivision 1, to report who knows or has
 13.10 reason to believe that a child is maltreated, as defined in section 260E.03, or has been
 13.11 maltreated within the preceding three years, and fails to report is guilty of a misdemeanor.

13.12 (b) A person mandated by section 260E.06, subdivision 1, to report who knows or has
 13.13 reason to believe that two or more children not related to the offender have been maltreated,
 13.14 as defined in section 260E.03, by the same offender within the preceding ten years, and
 13.15 fails to report is guilty of a gross misdemeanor.

13.16 (c) A parent, guardian, or caretaker who knows or reasonably should know that the
 13.17 child's health is in serious danger and who fails to report as required by section 260E.06,
 13.18 subdivision 3, is guilty of a gross misdemeanor if the child suffers substantial or great bodily
 13.19 harm because of the lack of medical care. If the child dies because of the lack of medical
 13.20 care, the person is guilty of a felony and may be sentenced to imprisonment for not more
 13.21 than two years or to payment of a fine of not more than \$4,000, or both. The provision in
 13.22 section 609.378, subdivision 1, paragraph (a), clause (1), providing that a parent, guardian,
 13.23 or caretaker may, in good faith, select and depend on spiritual means or prayer for treatment
 13.24 or care of a child, does not exempt a parent, guardian, or caretaker from the duty to report
 13.25 under this chapter.

13.26 (d) Any person who knowingly or recklessly makes a false report under the provisions
 13.27 of this chapter shall be liable in a civil suit for any actual damages suffered by the person
 13.28 or persons so reported and for any punitive damages set by the court or jury, plus costs and
 13.29 reasonable attorney fees.

13.30 **Sec. 9. [260E.09] REPORTING REQUIREMENTS.**

13.31 (a) An oral report shall be made immediately by telephone or otherwise. An oral report
 13.32 made by a person required under section 260E.06, subdivision 1, to report shall be followed

14.1 within 72 hours, exclusive of weekends and holidays, by a report in writing to the appropriate
14.2 police department, the county sheriff, the agency responsible for assessing or investigating
14.3 the report, or the local welfare agency.

14.4 (b) Any report shall be of sufficient content to identify the child, any person believed
14.5 to be responsible for the maltreatment of the child if the person is known, the nature and
14.6 extent of the maltreatment, and the name and address of the reporter. The local welfare
14.7 agency or agency responsible for assessing or investigating the report shall accept a report
14.8 made under section 260E.06 notwithstanding refusal by a reporter to provide the reporter's
14.9 name or address as long as the report is otherwise sufficient under this paragraph.

14.10 **Sec. 10. [260E.10] NOTIFICATION TO REPORTERS.**

14.11 Subdivision 1. **Screening notification.** If requested, the agency responsible for assessing
14.12 or investigating a report shall inform the reporter within ten days after the report was made,
14.13 either orally or in writing, whether the report was accepted or not. If the responsible agency
14.14 determines the report does not constitute a report under this chapter, the agency shall advise
14.15 the reporter that the report was screened out.

14.16 Subd. 2. **Final notification.** Any person mandated to report shall receive a summary of
14.17 the disposition of any report made by that reporter, including whether the case has been
14.18 opened for child protection or other services, or if a referral has been made to a community
14.19 organization, unless release would be detrimental to the best interests of the child. Any
14.20 person who is not mandated to report shall, upon request to the local welfare agency, receive
14.21 a concise summary of the disposition of any report made by that reporter, unless release
14.22 would be detrimental to the best interests of the child.

14.23 **Sec. 11. [260E.11] AGENCY DESIGNATED TO RECEIVE REPORTS.**

14.24 Subdivision 1. **Reports of maltreatment in facility.** A person mandated to report child
14.25 maltreatment occurring within a licensed facility shall report the information to the agency
14.26 responsible for licensing or certifying the facility under sections 144.50 to 144.58, 241.021,
14.27 and 245A.01 to 245A.16; or chapter 144H, 245D, or 245H; or a nonlicensed personal care
14.28 provider organization as defined in section 256B.0625, subdivision 19a.

14.29 Subd. 2. **Reporting deprivation of parental rights or kidnapping to law**
14.30 **enforcement.** A person mandated to report under section 260E.06, subdivision 1, who
14.31 knows or has reason to know of a violation of section 609.25 or 609.26 shall report the
14.32 information to the local police department or the county sheriff.

15.1 Subd. 3. Report to medical examiner or coroner; notification to local agency and
 15.2 law enforcement; report ombudsman. (a) A person mandated to report maltreatment who
 15.3 knows or has reason to believe a child has died as a result of maltreatment shall report that
 15.4 information to the appropriate medical examiner or coroner instead of the local welfare
 15.5 agency, police department, or county sheriff.

15.6 (b) The medical examiner or coroner shall notify the local welfare agency, police
 15.7 department, or county sheriff in instances in which the medical examiner or coroner believes
 15.8 that the child has died as a result of maltreatment. The medical examiner or coroner shall
 15.9 complete an investigation as soon as feasible and report the findings to the police department
 15.10 or county sheriff and the local welfare agency.

15.11 (c) If the child was receiving services or treatment for mental illness, developmental
 15.12 disability, chemical dependency, or emotional disturbance from an agency, facility, or
 15.13 program as defined in section 245.91, the medical examiner or coroner shall also notify and
 15.14 report findings to the ombudsman established under sections 245.91 to 245.97.

15.15 **Sec. 12. [260E.12] REQUIRED ACTIONS OF THE RESPONSIBLE AGENCY AND**
 15.16 **LAW ENFORCEMENT UPON RECEIVING REPORT.**

15.17 Subdivision 1. Police department or county sheriff. (a) The police department or the
 15.18 county sheriff shall immediately notify the local welfare agency or agency responsible for
 15.19 child protection reports under this chapter orally and in writing when a report is received.

15.20 (b) Written reports received by a police department or the county sheriff shall be
 15.21 forwarded immediately to the local welfare agency or the agency responsible for assessing
 15.22 or investigating the report. The police department or the county sheriff may keep copies of
 15.23 reports received by them.

15.24 (c) The county sheriff and the head of each local welfare agency, agency responsible
 15.25 for child protection reports, and police department shall designate a person within the agency,
 15.26 department, or office who is responsible for ensuring that the notification duties of this
 15.27 section are carried out. If the alleged maltreatment occurs on tribal land, the local welfare
 15.28 agency or agency responsible for child protection reports and the local police department
 15.29 or county sheriff shall immediately notify the tribe's social services agency and tribal law
 15.30 enforcement orally and in writing when a report is received. When a police department or
 15.31 county determines that a child has been the subject of maltreatment by a person licensed
 15.32 by the Professional Educator Licensing and Standards Board or the Board of School
 15.33 Administrators, the department or sheriff shall, in addition to other duties under this section,
 15.34 immediately inform the licensing board.

16.1 (d) If a child is the victim of an alleged crime under subdivision 2, paragraph (c), the
16.2 law enforcement agency shall immediately notify the local welfare agency, which shall
16.3 offer appropriate social services for the purpose of safeguarding and enhancing the welfare
16.4 of the maltreated child.

16.5 Subd. 2. Local welfare agency or agency responsible for maltreatment report. (a)
16.6 The local welfare agency or agency responsible for child protection reports shall immediately
16.7 notify the local police department or the county sheriff orally and in writing when a report
16.8 is received.

16.9 (b) Copies of written reports received by a local welfare agency or the agency responsible
16.10 for assessing or investigating the report shall be forwarded immediately to the local police
16.11 department or the county sheriff.

16.12 (c) Receipt by a local welfare agency of a report or notification of a report of kidnapping
16.13 under section 609.25 or depriving another of custodial or parental rights under section
16.14 609.26 shall not be construed to invoke the duties under this chapter except notification of
16.15 law enforcement and the offer of services under section 260E.20, subdivision 1, paragraph
16.16 (a), as appropriate.

16.17 Subd. 3. Penalties for failure to cross notify. (a) If a local welfare agency receives a
16.18 report under section 260E.06 and fails to notify the local police department or county sheriff
16.19 as required by subdivision 2, the person within the agency who is responsible for ensuring
16.20 that notification is made shall be subject to disciplinary action in keeping with the agency's
16.21 existing policy or collective bargaining agreement on discipline of employees.

16.22 (b) If a local police department or a county sheriff receives a report under section 260E.06
16.23 and fails to notify the local welfare agency as required by subdivision 1, the person within
16.24 the police department or county sheriff's office who is responsible for ensuring that
16.25 notification is made shall be subject to disciplinary action in keeping with the agency's
16.26 existing policy or collective bargaining agreement on discipline of employees.

16.27 **Sec. 13. [260E.13] REPORT TO OMBUDSMAN.**

16.28 When a local welfare agency receives a report or otherwise has information indicating
16.29 that a child who is a client, as defined in section 245.91, has been the subject of maltreatment
16.30 at an agency, facility, or program, as defined in section 245.91, the local welfare agency
16.31 shall, in addition to its other duties under this chapter, immediately inform the ombudsman
16.32 established under sections 245.91 to 245.97. The commissioner of education shall inform
16.33 the ombudsman established under sections 245.91 to 245.97 of reports regarding a child

17.1 who is a client, as defined in section 245.91, that maltreatment occurred at a school as
17.2 defined in section 120A.05, subdivisions 9, 11, and 13, and chapter 124E.

17.3 Sec. 14. **[260E.14] AGENCY RESPONSIBLE FOR SCREENING AND**
17.4 **ASSESSMENT OR INVESTIGATION.**

17.5 Subdivision 1. **Facilities and schools.** (a) The local welfare agency is the agency
17.6 responsible for investigating allegations of maltreatment in child foster care, family child
17.7 care, legally nonlicensed child care, and reports involving children served by an unlicensed
17.8 personal care provider organization under section 256B.0659. Copies of findings related to
17.9 personal care provider organizations under section 256B.0659 must be forwarded to the
17.10 Department of Human Services provider enrollment.

17.11 (b) The Department of Human Services is the agency responsible for screening and
17.12 investigating allegations of maltreatment in juvenile correctional facilities listed under
17.13 section 241.021 located in the local welfare agency's county and in facilities licensed or
17.14 certified under chapters 245A, 245D, and 245G, except for child foster care and family
17.15 child care.

17.16 (c) The Department of Health is the agency responsible for screening and investigating
17.17 allegations of maltreatment in facilities licensed under sections 144.50 to 144.58 and 144A.43
17.18 to 144A.482 or chapter 144H.

17.19 (d) The Department of Education is the agency responsible for screening and investigating
17.20 allegations of maltreatment in a school as defined in section 120A.05, subdivisions 9, 11,
17.21 and 13, and chapter 124E. The Department of Education's responsibility to screen and
17.22 investigate includes allegations of maltreatment involving students 18 to 21 years of age,
17.23 including students receiving special education services, up to and including graduation and
17.24 the issuance of a secondary or high school diploma.

17.25 (e) A health or corrections agency receiving a report may request the local welfare agency
17.26 to provide assistance pursuant to this section and sections 260E.19 and 260E.22.

17.27 Subd. 2. **Sexual abuse.** (a) The local welfare agency is the agency responsible for
17.28 investigating an allegation of sexual abuse if the alleged offender is the parent, guardian,
17.29 sibling, or an individual functioning within the family unit as a person responsible for the
17.30 child's care, or a person with a significant relationship to the child if that person resides in
17.31 the child's household.

17.32 (b) The local welfare agency is also responsible for investigating when a child is identified
17.33 as a victim of sex trafficking.

18.1 Subd. 3. **Neglect or physical abuse.** The local welfare agency is responsible for
18.2 immediately conducting a family assessment or investigation if the report alleges neglect
18.3 or physical abuse by a parent, guardian, or individual functioning within the family unit as
18.4 a person responsible for the child's care.

18.5 Subd. 4. **Birth match.** (a) Upon receiving data under section 144.225, subdivision 2b,
18.6 contained in a birth record or recognition of parentage identifying a child who is subject to
18.7 threatened injury under section 260E.03, subdivision 23, the Department of Human Services
18.8 shall send the data to the responsible local welfare agency. The data is known as "birth
18.9 match data."

18.10 (b) Unless the responsible local welfare agency has already begun an investigation or
18.11 assessment of the report due to the birth of the child or execution of the recognition of
18.12 parentage and the parent's previous history with child protection, the agency shall accept
18.13 the birth match data as a report under section 260E.03, subdivision 23.

18.14 Subd. 5. **Law enforcement.** (a) The local law enforcement agency is the agency
18.15 responsible for investigating a report of maltreatment if a violation of a criminal statute is
18.16 alleged.

18.17 (b) Law enforcement and the responsible agency must coordinate their investigations
18.18 or assessments as required under this chapter when the report alleges maltreatment that is
18.19 a violation of a criminal statute by a person who is a parent, guardian, sibling, person
18.20 responsible for the child's care functioning within the family unit, or person who lives in
18.21 the child's household and who has a significant relationship to the child, in a setting other
18.22 than a facility as defined in section 260E.03.

18.23 Sec. 15. **[260E.15] SCREENING GUIDELINES.**

18.24 (a) Child protection staff, supervisors, and others involved in child protection screening
18.25 shall follow the guidance provided in the maltreatment screening guidelines issued by the
18.26 commissioner and, when notified by the commissioner, shall immediately implement updated
18.27 procedures and protocols.

18.28 (b) Any modification to the screening guidelines must be preapproved by the
18.29 commissioner and must not be less protective of children than is mandated by statute. The
18.30 county agency must consult with the county attorney before proposing modifications to the
18.31 commissioner. The guidelines may provide additional protection for children but must not
18.32 limit reports that are screened in or provide additional limits on consideration of reports
18.33 that were screened out in making a screening determination.

19.1 Sec. 16. [260E.16] TIMELINE FOR SCREENING.

19.2 (a) The local welfare agency shall determine if the report is to be screened in or out as
19.3 soon as possible but in no event longer than 24 hours after the report is received.

19.4 (b) When determining whether a report will be screened in or out, the agency receiving
19.5 the report must consider, when relevant, all previous history, including reports that were
19.6 screened out. The agency may communicate with treating professionals and individuals
19.7 specified under section 260E.35, subdivision 4, paragraph (b).

19.8 Sec. 17. [260E.17] RESPONSE PATH ASSIGNMENT.

19.9 Subdivision 1. Local welfare agency. (a) Upon receipt of a report, the local welfare
19.10 agency shall determine whether to conduct a family assessment or an investigation as
19.11 appropriate to prevent or provide a remedy for maltreatment.

19.12 (b) The local welfare agency shall conduct an investigation when the report involves
19.13 sexual abuse or substantial child endangerment.

19.14 (c) The local welfare agency shall begin an immediate investigation if, at any time when
19.15 the local welfare agency is using a family assessment response, the local welfare agency
19.16 determines that there is reason to believe that sexual abuse or substantial child endangerment
19.17 or a serious threat to the child's safety exists.

19.18 (d) The local welfare agency may conduct a family assessment for reports that do not
19.19 allege sexual abuse or substantial child endangerment. In determining that a family
19.20 assessment is appropriate, the local welfare agency may consider issues of child safety,
19.21 parental cooperation, and the need for an immediate response.

19.22 (e) The local welfare agency may conduct a family assessment on a report that was
19.23 initially screened and assigned for an investigation. In determining that a complete
19.24 investigation is not required, the local welfare agency must document the reason for
19.25 terminating the investigation and notify the local law enforcement agency if the local law
19.26 enforcement agency is conducting a joint investigation.

19.27 Subd. 2. Responsible social service agency. The responsible agency shall conduct an
19.28 investigation when the report alleges maltreatment in a facility required to be licensed under
19.29 chapter 144H, 245A, 245D, or 245H; under sections 144.50 to 144.58 and 241.021; in a
19.30 school as defined in section 120A.05, subdivisions 9, 11, and 13, and chapter 124E; or in
19.31 a nonlicensed personal care provider association as defined in section 256B.0625, subdivision
19.32 19a.

20.1 Sec. 18. [260E.18] NOTICE TO CHILD'S TRIBE.

20.2 The local welfare agency shall provide immediate notice, according to section 260.761,
20.3 subdivision 2, to an Indian child's tribe when the agency has reason to believe the family
20.4 assessment or investigation may involve an Indian child. For purposes of this section,
20.5 "immediate notice" means notice provided within 24 hours.

20.6 Sec. 19. [260E.19] CONFLICT OF INTEREST.

20.7 (a) A potential conflict of interest related to assisting in an investigation or assessment
20.8 under this chapter resulting in a direct or shared financial interest with a child maltreatment
20.9 treatment provider or resulting from a personal or family relationship with a party in the
20.10 investigation must be considered by the local welfare agency in an effort to prevent unethical
20.11 relationships.

20.12 (b) A person who conducts an investigation or assessment under this chapter may not
20.13 have:

20.14 (1) any direct or shared financial interest or referral relationship resulting in a direct
20.15 shared financial gain with a child maltreatment treatment provider; or

20.16 (2) a personal or family relationship with a party in the assessment or investigation.

20.17 (c) If an independent assessor is not available, the person responsible for making the
20.18 determination under this chapter may use the services of an assessor with a financial interest,
20.19 referral, or personal or family relationship.

20.20 Sec. 20. [260E.20] AGENCY DUTIES REGARDING INVESTIGATION AND
20.21 ASSESSMENT.

20.22 Subdivision 1. General duties. (a) The local welfare agency shall offer services to
20.23 prevent future maltreatment, safeguarding and enhancing the welfare of the maltreated child,
20.24 and supporting and preserving family life whenever possible.

20.25 (b) If the report alleges a violation of a criminal statute involving maltreatment or child
20.26 endangerment under section 609.378, the local law enforcement agency and local welfare
20.27 agency shall coordinate the planning and execution of their respective investigation and
20.28 assessment efforts to avoid a duplication of fact-finding efforts and multiple interviews.
20.29 Each agency shall prepare a separate report of the results of the agency's investigation or
20.30 assessment.

21.1 (c) In cases of alleged child maltreatment resulting in death, the local agency may rely
21.2 on the fact-finding efforts of a law enforcement investigation to make a determination of
21.3 whether or not maltreatment occurred.

21.4 (d) When necessary, the local welfare agency shall seek authority to remove the child
21.5 from the custody of a parent, guardian, or adult with whom the child is living.

21.6 (e) In performing any of these duties, the local welfare agency shall maintain an
21.7 appropriate record.

21.8 (f) In conducting a family assessment or investigation, the local welfare agency shall
21.9 gather information on the existence of substance abuse and domestic violence.

21.10 (g) If the family assessment or investigation indicates there is a potential for abuse of
21.11 alcohol or other drugs by the parent, guardian, or person responsible for the child's care,
21.12 the local welfare agency shall conduct a chemical use assessment pursuant to Minnesota
21.13 Rules, part 9530.6615.

21.14 (h) The agency may use either a family assessment or investigation to determine whether
21.15 the child is safe when responding to a report resulting from birth match data under section
21.16 260E.03, subdivision 23, paragraph (c). If the child subject of birth match data is determined
21.17 to be safe, the agency shall consult with the county attorney to determine the appropriateness
21.18 of filing a petition alleging the child is in need of protection or services under section
21.19 260C.007, subdivision 6, clause (16), in order to deliver needed services. If the child is
21.20 determined not to be safe, the agency and the county attorney shall take appropriate action
21.21 as required under section 260C.503, subdivision 2.

21.22 Subd. 2. **Face-to-face contact.** (a) Upon receipt of a screened in report, the local welfare
21.23 agency shall conduct a face-to-face contact with the child reported to be maltreated and
21.24 with the child's primary caregiver sufficient to complete a safety assessment and ensure the
21.25 immediate safety of the child.

21.26 (b) The face-to-face contact with the child and primary caregiver shall occur immediately
21.27 if sexual abuse or substantial child endangerment is alleged and within five calendar days
21.28 for all other reports. If the alleged offender was not already interviewed as the primary
21.29 caregiver, the local welfare agency shall also conduct a face-to-face interview with the
21.30 alleged offender in the early stages of the assessment or investigation.

21.31 (c) At the initial contact with the alleged offender, the local welfare agency or the agency
21.32 responsible for assessing or investigating the report must inform the alleged offender of the
21.33 complaints or allegations made against the individual in a manner consistent with laws

22.1 protecting the rights of the person who made the report. The interview with the alleged
22.2 offender may be postponed if it would jeopardize an active law enforcement investigation.

22.3 (d) The local welfare agency or the agency responsible for assessing or investigating
22.4 the report must provide the alleged offender with an opportunity to make a statement. The
22.5 alleged offender may submit supporting documentation relevant to the assessment or
22.6 investigation.

22.7 Subd. 3. **Collection of information.** (a) The local welfare agency responsible for
22.8 conducting a family assessment or investigation shall collect available and relevant
22.9 information to determine child safety, risk of subsequent maltreatment, and family strengths
22.10 and needs and share not public information with an Indian's tribal social services agency
22.11 without violating any law of the state that may otherwise impose a duty of confidentiality
22.12 on the local welfare agency in order to implement the tribal state agreement.

22.13 (b) The local welfare agency or the agency responsible for investigating the report shall
22.14 collect available and relevant information to ascertain whether maltreatment occurred and
22.15 whether protective services are needed.

22.16 (c) Information collected includes, when relevant, information with regard to the person
22.17 reporting the alleged maltreatment, including the nature of the reporter's relationship to the
22.18 child and to the alleged offender, and the basis of the reporter's knowledge for the report;
22.19 the child allegedly being maltreated; the alleged offender; the child's caretaker; and other
22.20 collateral sources having relevant information related to the alleged maltreatment.

22.21 (d) Information relevant to the assessment or investigation must be asked for, and may
22.22 include:

22.23 (1) the child's sex and age; prior reports of maltreatment, including any maltreatment
22.24 reports that were screened out and not accepted for assessment or investigation; information
22.25 relating to developmental functioning; credibility of the child's statement; and whether the
22.26 information provided under this clause is consistent with other information collected during
22.27 the course of the assessment or investigation;

22.28 (2) the alleged offender's age, a record check for prior reports of maltreatment, and
22.29 criminal charges and convictions;

22.30 (3) collateral source information regarding the alleged maltreatment and care of the
22.31 child. Collateral information includes, when relevant: (i) a medical examination of the child;
22.32 (ii) prior medical records relating to the alleged maltreatment or the care of the child
22.33 maintained by any facility, clinic, or health care professional and an interview with the

23.1 treating professionals; and (iii) interviews with the child's caretakers, including the child's
 23.2 parent, guardian, foster parent, child care provider, teachers, counselors, family members,
 23.3 relatives, and other persons who may have knowledge regarding the alleged maltreatment
 23.4 and the care of the child; and

23.5 (4) information on the existence of domestic abuse and violence in the home of the child,
 23.6 and substance abuse.

23.7 (e) Nothing in this subdivision precludes the local welfare agency, the local law
 23.8 enforcement agency, or the agency responsible for assessing or investigating the report from
 23.9 collecting other relevant information necessary to conduct the assessment or investigation.

23.10 (f) Notwithstanding section 13.384 or 144.291 to 144.298, the local welfare agency has
 23.11 access to medical data and records for purposes of paragraph (d), clause (3).

23.12 Subd. 4. **Consultation regarding alleged medical neglect.** If the report alleges medical
 23.13 neglect as defined in section 260C.007, subdivision 6, clause (5), the local welfare agency
 23.14 shall, in addition to its other duties under this section, immediately consult with designated
 23.15 hospital staff and with the parents of the infant to verify that appropriate nutrition, hydration,
 23.16 and medication are being provided; and shall immediately secure an independent medical
 23.17 review of the infant's medical charts and records and, if necessary, seek a court order for
 23.18 an independent medical examination of the infant.

23.19 Subd. 5. **Law enforcement fact finding.** If the report alleges maltreatment by a person
 23.20 who is not a parent, guardian, sibling, person responsible for the child's care functioning
 23.21 within the family unit, or a person who lives in the child's household and who has a
 23.22 significant relationship to the child, in a setting other than a facility as defined in section
 23.23 260E.03, the local welfare agency may rely on the fact-finding efforts of the law enforcement
 23.24 investigation to make a determination whether or not threatened injury or other maltreatment
 23.25 has occurred under section 260E.03, subdivision 12, if an alleged offender has minor children
 23.26 or lives with minors.

23.27 Sec. 21. **[260E.21] SCREENED OUT REPORTS.**

23.28 Subdivision 1. **Records.** A report that is screened out must be maintained according to
 23.29 section 260E.35, subdivision 6, paragraph (b).

23.30 Subd. 2. **Offer of social services.** A local welfare agency or agency responsible for
 23.31 investigating or assessing a report may use a screened out report for making an offer of
 23.32 social services to the subjects of the screened out report.

24.1 Sec. 22. **[260E.22] INTERVIEWS.**

24.2 **Subdivision 1. Authority to interview.** (a) The agency responsible for assessing or
24.3 investigating reports of maltreatment has the authority to interview the child, the person or
24.4 persons responsible for the child's care, the alleged offender, and any other person with
24.5 knowledge of the maltreatment for the purpose of gathering facts, assessing safety and risk
24.6 to the child, and formulating a plan.

24.7 (b) Authority of the local welfare agency responsible for assessing or investigating the
24.8 maltreatment report, the agency responsible for assessing or investigating the report, and
24.9 the local law enforcement agency responsible for investigating the alleged maltreatment
24.10 includes but is not limited to authority to interview, without parental consent, the alleged
24.11 victim and any other children who currently reside with or who have resided with the alleged
24.12 offender.

24.13 **Subd. 2. Interview procedure.** (a) The interview may take place at school or at any
24.14 facility or other place where the alleged victim or other children might be found or the child
24.15 may be transported to, and the interview may be conducted at a place appropriate for the
24.16 interview of a child designated by the local welfare agency or law enforcement agency.

24.17 (b) The interview may take place outside the presence of the alleged offender or parent,
24.18 legal custodian, guardian, or school official.

24.19 (c) For a family assessment, it is the preferred practice to request a parent or guardian's
24.20 permission to interview the child before conducting the child interview, unless doing so
24.21 would compromise the safety assessment.

24.22 **Subd. 3. Notification after interview.** (a) Except as provided in this subdivision, the
24.23 parent, legal custodian, or guardian shall be notified by the responsible agency or local law
24.24 enforcement agency no later than the conclusion of the investigation or assessment that this
24.25 interview has occurred.

24.26 (b) Notwithstanding notice required under the Minnesota Rules of Juvenile Protection,
24.27 the juvenile court may, after hearing on an ex parte motion by the local welfare agency,
24.28 order that, where reasonable cause exists, the agency withhold notification of this interview
24.29 from the parent, legal custodian, or guardian. If the interview took place or is to take place
24.30 on school property, the order shall specify that school officials may not disclose to the
24.31 parent, legal custodian, or guardian the contents of the notification of intent to interview
24.32 the child on school property, as provided under this subdivision, and any other related
24.33 information regarding the interview that may be a part of the child's school record. A copy

25.1 of the order shall be sent by the local welfare or law enforcement agency to the appropriate
25.2 school official.

25.3 Subd. 4. **Tennessee notice not required.** In conducting investigations and assessments
25.4 pursuant to this chapter, the notice required by section 13.04, subdivision 2, need not be
25.5 provided to a child under the age of ten who is the alleged victim of maltreatment.

25.6 Subd. 5. **Court order for interview.** (a) Where the alleged offender or a person
25.7 responsible for the care of the alleged victim or other child prevents access to the victim or
25.8 other child by the local welfare agency, the juvenile court may order the parent, legal
25.9 custodian, or guardian to produce the alleged victim or other child for questioning by the
25.10 local welfare agency or the local law enforcement agency outside the presence of the alleged
25.11 offender or any person responsible for the child's care at reasonable places and times as
25.12 specified by court order.

25.13 (b) Before making an order under paragraph (a), the court shall issue an order to show
25.14 cause, either upon its own motion or upon a verified petition, specifying the basis for the
25.15 requested interview and fixing the time and place of the hearing. The order to show cause
25.16 shall be served personally and shall be heard in the same manner as provided in other cases
25.17 in the juvenile court. The court shall consider the need for appointment of a guardian ad
25.18 litem to protect the best interests of the child. If appointed, the guardian ad litem shall be
25.19 present at the hearing on the order to show cause.

25.20 Subd. 6. **Interview format.** (a) When conducting an investigation, the local welfare
25.21 agency shall use a question and answer interviewing format with questioning as nondirective
25.22 as possible to elicit spontaneous responses.

25.23 (b) For investigations only, the following interviewing methods and procedures must
25.24 be used whenever possible when collecting information:

25.25 (1) audio recording of all interviews with witnesses and collateral sources; and

25.26 (2) in a case of alleged sexual abuse, audio-video recording of each interview with the
25.27 alleged victim and a child witness.

25.28 Subd. 7. **Interviews on school property.** (a) When the local welfare agency, local law
25.29 enforcement agency, or the agency responsible for assessing or investigating a report of
25.30 maltreatment determines that an interview should take place on school property, written
25.31 notification of intent to interview the child on school property must be received by school
25.32 officials before the interview. The notification shall include the name of the child to be
25.33 interviewed, the purpose of the interview, and a reference to the statutory authority to conduct

26.1 an interview on school property. For an interview conducted by the local welfare agency,
 26.2 the notification shall be signed by the chair of the local welfare agency or the chair's designee.
 26.3 The notification shall be private data on individuals subject to the provisions of this
 26.4 subdivision. School officials may not disclose to the parent, legal custodian, or guardian
 26.5 the contents of the notification or any other related information regarding the interview until
 26.6 notified in writing by the local welfare agency or local law enforcement agency that the
 26.7 investigation or assessment has been concluded, unless a school employee or agent is alleged
 26.8 to have maltreated the child. Until that time, the local welfare agency, local law enforcement
 26.9 agency, or the agency responsible for assessing or investigating a report of maltreatment
 26.10 shall be solely responsible for any disclosure regarding the nature of the assessment or
 26.11 investigation.

26.12 (b) Except where the alleged offender is believed to be a school official or employee,
 26.13 the time, place, and manner of the interview on school premises shall be within the discretion
 26.14 of school officials, but the local welfare agency or local law enforcement agency shall have
 26.15 the exclusive authority to determine who may attend the interview. The conditions as to
 26.16 time, place, and manner of the interview set by the school officials shall be reasonable, and
 26.17 the interview shall be conducted not more than 24 hours after the receipt of the notification
 26.18 unless another time is considered necessary by agreement between the school officials and
 26.19 the local welfare agency or local law enforcement agency. Where the school fails to comply
 26.20 with the provisions of this paragraph, the juvenile court may order the school to comply.
 26.21 Every effort must be made to reduce the disruption of the educational program of the child,
 26.22 other students, or school staff when an interview is conducted on school premises.

26.23 **Sec. 23. [260E.23] DOCUMENTING INTERVIEWS WITH CHILD**
 26.24 **MALTREATMENT VICTIMS.**

26.25 Subdivision 1. **Policy.** It is the policy of this state to encourage adequate and accurate
 26.26 documentation of the number and content of interviews conducted with alleged child
 26.27 maltreatment victims during the course of a child maltreatment assessment or investigation,
 26.28 criminal investigation, or prosecution, and to discourage interviews that are unnecessary,
 26.29 duplicative, or otherwise not in the best interests of the child.

26.30 Subd. 2. **Definitions.** As used in this section:

26.31 (1) "government employee" means an employee of a state or local agency, and any
 26.32 person acting as an agent of a state or local agency;

27.1 (2) "interview" means a statement of an alleged maltreatment victim which is given or
 27.2 made to a government employee during the course of a maltreatment assessment or
 27.3 investigation, criminal investigation, or prosecution; and

27.4 (3) "record" means an audio or video recording of an interview, or a written record of
 27.5 an interview.

27.6 Subd. 3. **Record required.** Whenever an interview is conducted, the interviewer must
 27.7 make a record of the interview. The record must contain the following information:

27.8 (1) the date, time, place, and duration of the interview;

27.9 (2) the identity of the persons present at the interview; and

27.10 (3) if the record is in writing, a summary of the information obtained during the interview.

27.11 Subd. 4. **Records maintained.** The records shall be maintained by the interviewer in
 27.12 accordance with applicable provisions of section 260E.35 and chapter 13.

27.13 Subd. 5. **Guidelines on tape recording of interviews.** Every county attorney's office
 27.14 shall be responsible for developing written guidelines on the tape recording of interviews
 27.15 by government employees who conduct child maltreatment assessments or investigations,
 27.16 criminal investigations, or prosecutions. The guidelines are public data as defined in section
 27.17 13.02, subdivision 14.

27.18 Sec. 24. **[260E.24] CONCLUSION OF FAMILY ASSESSMENT OR FAMILY**
 27.19 **INVESTIGATION BY LOCAL WELFARE AGENCY.**

27.20 Subdivision 1. **Timing.** The local welfare agency shall conclude the family assessment
 27.21 or the investigation within 45 days of the receipt of a report. The conclusion of the assessment
 27.22 or investigation may be extended to permit the completion of a criminal investigation or
 27.23 the receipt of expert information requested within 45 days of the receipt of the report.

27.24 Subd. 2. **Determination after family assessment.** After conducting a family assessment,
 27.25 the local welfare agency shall determine whether child protective services are needed to
 27.26 address the safety of the child and other family members and the risk of subsequent
 27.27 maltreatment.

27.28 Subd. 3. **Determinations after family investigation.** (a) After conducting an
 27.29 investigation, the local welfare agency shall make two determinations: (1) whether
 27.30 maltreatment occurred; and (2) whether child protective services are needed.

27.31 (b) No determination of maltreatment shall be made when the alleged offender is a child
 27.32 under the age of ten.

28.1 (c) The local welfare agency or the agency responsible for investigating the report may
28.2 make a determination of no maltreatment early in an investigation, and close the case and
28.3 retain immunity, if the collected information shows no basis for a full investigation.

28.4 Subd. 4. **Child protective services.** For the purposes of this chapter, except for section
28.5 260E.37, a determination that child protective services are needed means that the local
28.6 welfare agency documented conditions during the assessment or investigation sufficient to
28.7 cause a child protection worker, as defined in section 260E.37, to conclude that a child is
28.8 at significant risk of maltreatment if protective intervention is not provided and that the
28.9 individual or individuals responsible for the child's care have not taken or are not likely to
28.10 take action to protect the child from maltreatment or risk of maltreatment.

28.11 Subd. 5. **Notifications at conclusion of family investigation.** (a) Within ten working
28.12 days of the conclusion of an investigation, the local welfare agency or agency responsible
28.13 for investigating the report shall notify the parent or guardian of the child and the person
28.14 determined to be maltreating the child, if not the parent or guardian of the child, of the
28.15 determination and a summary of the specific reasons for the determination.

28.16 (b) The notice must include a certification that the information collection procedures
28.17 under section 260E.20 were followed and a notice of the right of a data subject to obtain
28.18 access to other private data on the subject collected, created, or maintained under this section.

28.19 (c) In addition, the notice shall include the length of time that the records will be kept
28.20 under section 260E.35, subdivision 6. The investigating agency shall notify the parent or
28.21 guardian of the child who is the subject of the report, and any person determined to have
28.22 maltreated the child, of their appeal or review rights under this chapter.

28.23 (d) The notice must also state that a finding of maltreatment may result in denial of a
28.24 license or certification application or background study disqualification under chapter 245C
28.25 related to employment or services that are licensed or certified by the Department of Human
28.26 Services under chapter 245A or 245H, the Department of Health under chapter 144 or 144A,
28.27 the Department of Corrections under section 241.021, and from providing services related
28.28 to an unlicensed personal care provider organization under chapter 256B.

28.29 Subd. 6. **Required referral to early intervention services.** A child under age three
28.30 who is involved in a substantiated case of maltreatment shall be referred for screening under
28.31 the Individuals with Disabilities Education Act, part C. Parents must be informed that the
28.32 evaluation and acceptance of services are voluntary. The commissioner of human services
28.33 shall monitor referral rates by county and annually report the information to the legislature.

29.1 Refusal to have a child screened is not a basis for a child in need of protection or services
 29.2 petition under chapter 260C.

29.3 Subd. 7. **Notification at conclusion of family assessment.** Within ten working days of
 29.4 the conclusion of a family assessment, the local welfare agency shall notify the parent or
 29.5 guardian of the child of the need for services to address child safety concerns or significant
 29.6 risk of subsequent maltreatment. The local welfare agency and the family may also jointly
 29.7 agree that family support and family preservation services are needed.

29.8 **Sec. 25. [260E.25] PROVISION OF MEDICAL CARE.**

29.9 (a) If lack of medical care due to a parent's, guardian's, or caretaker's good faith selection
 29.10 and dependence upon spiritual means or prayer for treatment or care of disease or remedial
 29.11 care for the child in lieu of medical care may result in serious danger to the child's health,
 29.12 the local welfare agency may ensure that necessary medical services are provided to the
 29.13 child.

29.14 (b) If the review or examination required under section 260E.20, subdivision 4, leads
 29.15 to a conclusion of medical neglect, the agency shall intervene on behalf of the infant by
 29.16 initiating legal proceedings under section 260C.141 and by filing an expedited motion to
 29.17 prevent the withholding of medically indicated treatment.

29.18 **Sec. 26. [260E.26] PROVISION OF CHILD PROTECTIVE SERVICES.**

29.19 The local welfare agency shall create a written plan, in collaboration with the family
 29.20 whenever possible, within 30 days of the determination that child protective services are
 29.21 needed or upon joint agreement of the local welfare agency and the family that family
 29.22 support and preservation services are needed. Child protective services for a family are
 29.23 voluntary unless ordered by the court.

29.24 **Sec. 27. [260E.27] CONSULTATION WITH THE COUNTY ATTORNEY.**

29.25 The local welfare agency shall consult with the county attorney to determine the
 29.26 appropriateness of filing a petition alleging the child is in need of protection or services
 29.27 under section 260C.007, subdivision 6, if:

29.28 (1) the family does not accept or comply with a plan for child protective services;

29.29 (2) voluntary child protective services may not provide sufficient protection for the child;

29.30 or

29.31 (3) the family is not cooperating with an investigation or assessment.

30.1 Sec. 28. **[260E.28] CONDUCTING INVESTIGATION IN FACILITY OR SCHOOL.**

30.2 **Subdivision 1. Immediate investigation for alleged maltreatment in a facility. (a)**

30.3 The commissioner of human services, health, or education, whichever is responsible for
30.4 investigating the report, shall immediately investigate if the report alleges that:

30.5 (1) a child who is in the care of a facility as defined in section 260E.03 is the victim of
30.6 maltreatment in a facility by an individual in that facility or has been the victim of
30.7 maltreatment in a facility by an individual in that facility within the three years preceding
30.8 the report; or

30.9 (2) a child is the victim of maltreatment in a facility by an individual in a facility defined
30.10 in section 260E.03, subdivision 6, while in the care of that facility within the three years
30.11 preceding the report.

30.12 (b) The commissioner of the agency responsible for investigating the report shall arrange
30.13 for the transmittal to the commissioner of reports received by local agencies and may delegate
30.14 to a local welfare agency the duty to investigate reports. The commissioner of the agency
30.15 responsible for investigating the report or local welfare agency may interview any children
30.16 who are or have been in the care of a facility under investigation and the children's parents,
30.17 guardians, or legal custodians.

30.18 (c) In conducting an investigation under this section, the commissioner has the powers
30.19 and duties specified for a local welfare agency under this chapter.

30.20 **Subd. 2. Preinterview notification for facility investigation.** Before any interview
30.21 related to maltreatment in a facility under the provisions of section 260E.22, the
30.22 commissioner of the agency responsible for investigating the report or local welfare agency
30.23 shall notify the parent, guardian, or legal custodian of a child who will be interviewed in
30.24 the manner provided for in section 260E.22. If reasonable efforts to reach the parent,
30.25 guardian, or legal custodian of a child in an out-of-home placement have failed, the child
30.26 may be interviewed if there is reason to believe the interview is necessary to protect the
30.27 child or other children in the facility. The commissioner of the agency responsible for
30.28 assessing or investigating the report or local agency must provide the information required
30.29 in this subdivision to the parent, guardian, or legal custodian of a child interviewed without
30.30 parental notification as soon as possible after the interview. When the investigation is
30.31 completed, any parent, guardian, or legal custodian notified under this subdivision shall
30.32 receive the written memorandum provided for in section 260E.30, subdivision 5.

30.33 **Subd. 3. Facility records.** The commissioner of human services, the ombudsman for
30.34 mental health and developmental disabilities, the local welfare agencies responsible for

31.1 investigating reports, the commissioner of education, and the local law enforcement agencies
 31.2 have the right to enter a facility as defined in section 260E.03 and to inspect and copy the
 31.3 facility's records, including medical records, as part of the investigation. Notwithstanding
 31.4 the provisions of chapter 13, the commissioner of human services, the ombudsman for
 31.5 mental health and developmental disabilities, the local welfare agencies responsible for
 31.6 investigating reports, the commissioner of education, and the local law enforcement agencies
 31.7 also have the right to inform the facility under investigation that an investigation is being
 31.8 conducted, to disclose to the facility the names of the individuals under investigation for
 31.9 maltreating a child, and to provide the facility with a copy of the report and the investigative
 31.10 findings.

31.11 Subd. 4. **Access to information.** In conducting investigations under this chapter, the
 31.12 commissioner or local welfare agency shall obtain access to information consistent with
 31.13 section 260E.20, subdivision 3. In conducting investigations under this section, the
 31.14 commissioner of education shall obtain access to reports and investigative data that are
 31.15 relevant to a report of maltreatment and are in the possession of a school facility as defined
 31.16 in section 260E.03, subdivision 6, clause (2), notwithstanding the classification of the data
 31.17 as educational or personnel data under chapter 13. This includes but is not limited to school
 31.18 investigative reports, information concerning the conduct of school personnel alleged to
 31.19 have committed maltreatment of students, information about witnesses, and any protective
 31.20 or corrective action taken by the school facility regarding the school personnel alleged to
 31.21 have committed maltreatment.

31.22 Subd. 5. **Investigation involving school facility.** In conducting an investigation involving
 31.23 a school facility as defined in section 260E.03, subdivision 6, clause (2), the commissioner
 31.24 of education shall collect available and relevant information and use the procedures in
 31.25 sections 260E.20, subdivisions 2 and 3, and 260E.22, except that the requirement for
 31.26 face-to-face observation of the child and face-to-face interview of the alleged offender is
 31.27 to occur in the initial stages of the investigation provided that the commissioner may also
 31.28 base the investigation on investigative reports and data received from the school facility
 31.29 and local law enforcement agency, to the extent those investigations satisfy the requirements
 31.30 of sections 260E.20, subdivisions 2 and 3, and 260E.22.

31.31 Sec. 29. **[260E.29] NOTIFICATION REQUIREMENTS FOR SCHOOLS AND**
 31.32 **FACILITIES.**

31.33 Subdivision 1. **Notification requirements for school facility.** (a) Notwithstanding
 31.34 section 260E.09, the commissioner of education must inform the parent, guardian, or legal

32.1 custodian of the child who is the subject of a report of alleged maltreatment in a school
 32.2 facility within ten days of receiving the report, either orally or in writing, whether the
 32.3 commissioner is investigating the report of alleged maltreatment.

32.4 (b) Regardless of whether a report is made under section 260E.09, as soon as practicable
 32.5 after a school receives information regarding an incident that may constitute maltreatment
 32.6 of a child in a school facility, the school shall inform the parent, legal guardian, or custodian
 32.7 of the child that an incident occurred that may constitute maltreatment of the child, when
 32.8 the incident occurred, and the nature of the conduct that may constitute maltreatment.

32.9 Subd. 2. **Notification requirements for other types of facilities.** When a report is
 32.10 received that alleges maltreatment of a child while in the care of a licensed or unlicensed
 32.11 day care facility, residential facility, agency, hospital, sanitarium, or other facility or
 32.12 institution required to be licensed or certified according to sections 144.50 to 144.58;
 32.13 241.021; or 245A.01 to 245A.16; or chapter 144H, 245D, or 245H; or a school as defined
 32.14 in section 120A.05, subdivisions 9, 11, and 13; and chapter 124E; or a nonlicensed personal
 32.15 care provider organization as defined in section 256B.0625, subdivision 19a, the
 32.16 commissioner of the agency responsible for investigating the report or local welfare agency
 32.17 investigating the report shall provide the following information to the parent, guardian, or
 32.18 legal custodian of a child alleged to have been the victim of maltreatment in the facility;
 32.19 the name of the facility; the fact that a report alleging maltreatment in the facility has been
 32.20 received; the nature of the alleged maltreatment in the facility; that the agency is conducting
 32.21 an investigation; any protective or corrective measures being taken pending the outcome
 32.22 of the investigation; and that a written memorandum will be provided when the investigation
 32.23 is completed.

32.24 Subd. 3. **Discretionary notification.** The commissioner of the agency responsible for
 32.25 investigating the report or local welfare agency may also provide the information in
 32.26 subdivision 2 to the parent, guardian, or legal custodian of any other child in the facility if
 32.27 the investigative agency knows or has reason to believe the alleged maltreatment of a child
 32.28 in the facility occurred. In determining whether to exercise this authority, the commissioner
 32.29 of the agency responsible for investigating the report or local welfare agency shall consider
 32.30 the seriousness of the alleged maltreatment of a child in the facility; the number of alleged
 32.31 victims of maltreatment of a child in the facility; the number of alleged offenders; and the
 32.32 length of the investigation. The facility shall be notified whenever this discretion is exercised.

33.1 Sec. 30. **[260E.30] CONCLUSION OF SCHOOL OR FACILITY INVESTIGATION.**

33.2 Subdivision 1. **Investigation involving a school facility.** If the commissioner of education
 33.3 conducts an investigation, the commissioner shall determine whether maltreatment occurred
 33.4 and what corrective or protective action was taken by the school facility. If a determination
 33.5 is made that maltreatment occurred, the commissioner shall report to the employer, the
 33.6 school board, and any appropriate licensing entity the determination that maltreatment
 33.7 occurred and what corrective or protective action was taken by the school facility. In all
 33.8 other cases, the commissioner shall inform the school board or employer that a report was
 33.9 received; the subject of the report; the date of the initial report; the category of maltreatment
 33.10 alleged as defined in section 260E.03, subdivision 12; the fact that maltreatment was not
 33.11 determined; and a summary of the specific reasons for the determination.

33.12 Subd. 2. **Investigation involving a facility.** (a) When maltreatment is determined in an
 33.13 investigation involving a facility, the investigating agency shall also determine whether the
 33.14 facility or individual was responsible, or whether both the facility and the individual were
 33.15 responsible for the maltreatment using the mitigating factors in subdivision 4. Determinations
 33.16 under this subdivision must be made based on a preponderance of the evidence and are
 33.17 private data on individuals or nonpublic data as maintained by the commissioner of education.

33.18 (b) Any operator, employee, or volunteer worker at any facility who intentionally
 33.19 maltreats any child in the care of that facility may be charged with a violation of section
 33.20 609.255, 609.377, or 609.378. Any operator of a facility who knowingly permits conditions
 33.21 to exist that result in maltreatment of a child in a facility while in the care of that facility
 33.22 may be charged with a violation of section 609.378. The facility operator shall inform all
 33.23 mandated reporters employed by or otherwise associated with the facility of the duties
 33.24 required of mandated reporters and shall inform all mandatory reporters of the prohibition
 33.25 against retaliation for reports made in good faith under this section.

33.26 Subd. 3. **Nonmaltreatment mistake.** (a) If paragraph (b) applies, rather than making a
 33.27 determination of substantiated maltreatment by the individual, the commissioner of human
 33.28 services shall determine that a nonmaltreatment mistake was made by the individual.

33.29 (b) A nonmaltreatment mistake occurs when:

33.30 (1) at the time of the incident, the individual was performing duties identified in the
 33.31 center's child care program plan required under Minnesota Rules, part 9503.0045;

33.32 (2) the individual has not been determined responsible for a similar incident that resulted
 33.33 in a finding of maltreatment for at least seven years;

34.1 (3) the individual has not been determined to have committed a similar nonmaltreatment
34.2 mistake under this paragraph for at least four years;

34.3 (4) any injury to a child resulting from the incident, if treated, is treated only with
34.4 remedies that are available over the counter, whether ordered by a medical professional or
34.5 not; and

34.7 providing services were both in compliance with all licensing requirements relevant to the
34.8 incident.

34.9 (c) This subdivision only applies to child care centers licensed under Minnesota Rules,
34.10 chapter 9503.

34.11 Subd. 4. **Mitigating factors in investigating facilities.** (a) When determining whether
34.12 the facility or individual is the responsible party, or whether both the facility and the
34.13 individual are responsible for determined maltreatment in a facility, the investigating agency
34.14 shall consider at least the following mitigating factors:

34.15 (1) whether the actions of the facility or the individual caregivers were according to,
34.16 and followed the terms of, an erroneous physician order, prescription, individual care plan,
34.17 or directive; however, this is not a mitigating factor when the facility or caregiver was
34.18 responsible for the issuance of the erroneous order, prescription, individual care plan, or
34.19 directive or knew or should have known of the errors and took no reasonable measures to
34.20 correct the defect before administering care;

34.21 (2) comparative responsibility between the facility, other caregivers, and requirements
34.22 placed upon an employee, including the facility's compliance with related regulatory standards
34.23 and the adequacy of facility policies and procedures, facility training, an individual's
34.24 participation in the training, the caregiver's supervision, and facility staffing levels and the
34.25 scope of the individual employee's authority and discretion; and

34.26 (3) whether the facility or individual followed professional standards in exercising
34.27 professional judgment.

34.28 (b) The evaluation of the facility's responsibility under paragraph (a), clause (2), must
34.29 not be based on the completeness of the risk assessment or risk reduction plan required
34.30 under section 245A.66, but must be based on the facility's compliance with the regulatory
34.31 standards for policies and procedures, training, and supervision as cited in Minnesota Statutes
34.32 and Minnesota Rules.

35.1 (c) Notwithstanding paragraphs (a) and (b), when maltreatment is determined to have
35.2 been committed by an individual who is also the facility license holder, both the individual
35.3 and the facility must be determined responsible for the maltreatment, and both the background
35.4 study disqualification standards under section 245C.15, subdivision 4, and the licensing or
35.5 certification actions under sections 245A.06, 245A.07, 245H.06, or 245H.07 apply.

35.6 Subd. 5. Notification when school or facility investigation is completed. (a) When
35.7 the commissioner of the agency responsible for investigating the report or local welfare
35.8 agency has completed its investigation, every parent, guardian, or legal custodian previously
35.9 notified of the investigation by the commissioner or local welfare agency shall be provided
35.10 with the following information in a written memorandum: the name of the facility
35.11 investigated; the nature of the alleged maltreatment of a child in the facility; the investigator's
35.12 name; a summary of the investigation findings; a statement of whether maltreatment was
35.13 found; and the protective or corrective measures that are being or will be taken.

35.14 (b) The memorandum shall be written in a manner that protects the identity of the reporter
35.15 and the child and shall not contain the name or, to the extent possible, reveal the identity
35.16 of the alleged offender or the identity of individuals interviewed during the investigation.

35.17 (c) If maltreatment is determined to exist, the commissioner or local welfare agency
35.18 shall also provide the written memorandum to the parent, guardian, or legal custodian of
35.19 each child in the facility who had contact with the individual responsible for the maltreatment.

35.20 (d) When the facility is the responsible party for maltreatment, the commissioner or
35.21 local welfare agency shall also provide the written memorandum to the parent, guardian,
35.22 or legal custodian of each child who received services in the population of the facility where
35.23 the maltreatment occurred.

35.24 (e) This notification must be provided to the parent, guardian, or legal custodian of each
35.25 child receiving services from the time the maltreatment occurred until either the individual
35.26 responsible for maltreatment is no longer in contact with a child or children in the facility
35.27 or the conclusion of the investigation.

35.28 (f) In the case of maltreatment within a school facility, as defined in section 120A.05,
35.29 subdivisions 9, 11, and 13, and chapter 124E, the commissioner of education need not
35.30 provide notification to parents, guardians, or legal custodians of each child in the facility,
35.31 but shall, within ten days after the investigation is completed, provide written notification
35.32 to the parent, guardian, or legal custodian of any student alleged to have been maltreated.

35.33 (g) The commissioner of education may notify the parent, guardian, or legal custodian
35.34 of any student involved as a witness to alleged maltreatment.

36.1 Subd. 6. Notification to parent, child, or offender following investigation. (a) Within
36.2 ten working days of the conclusion of an investigation, the local welfare agency or agency
36.3 responsible for investigating the report of maltreatment in a facility shall notify the parent
36.4 or guardian of the child, the person determined to be maltreating the child, and the director
36.5 of the facility of the determination and a summary of the specific reasons for the
36.6 determination.

36.7 (b) When the investigation involves a child foster care setting that is monitored by a
36.8 private licensing agency under section 245A.16, the local welfare agency responsible for
36.9 investigating the report shall notify the private licensing agency of the determination and
36.10 shall provide a summary of the specific reasons for the determination. The notice to the
36.11 private licensing agency must include identifying private data, but not the identity of the
36.12 reporter of maltreatment.

36.13 (c) The notice must also include a certification that the information collection procedures
36.14 under section 260E.20, subdivision 3, were followed and a notice of the right of a data
36.15 subject to obtain access to other private data on the subject collected, created, or maintained
36.16 under this section.

36.17 (d) In addition, the notice shall include the length of time that the records will be kept
36.18 under section 260E.35, subdivision 6.

36.19 (e) The investigating agency shall notify the parent or guardian of the child who is the
36.20 subject of the report, and any person or facility determined to have maltreated a child, of
36.21 their appeal or review rights under this section.

36.22 (f) The notice must also state that a finding of maltreatment may result in denial of a
36.23 license or certification application or background study disqualification under chapter 245C
36.24 related to employment or services that are licensed by the Department of Human Services
36.25 under chapter 245A or 245H, the Department of Health under chapter 144 or 144A, the
36.26 Department of Corrections under section 241.021, and from providing services related to
36.27 an unlicensed personal care provider organization under chapter 256B.

36.28 Sec. 31. [260E.31] REPORTING OF PRENATAL EXPOSURE TO CONTROLLED
36.29 SUBSTANCES.

36.30 Subdivision 1. Reports required. (a) Except as provided in paragraph (b), a person
36.31 mandated to report under this chapter shall immediately report to the local welfare agency
36.32 if the person knows or has reason to believe that a woman is pregnant and has used a
36.33 controlled substance for a nonmedical purpose during the pregnancy, including but not

37.1 limited to tetrahydrocannabinol, or has consumed alcoholic beverages during the pregnancy
 37.2 in any way that is habitual or excessive.

37.3 (b) A health care professional or a social service professional who is mandated to report
 37.4 under this chapter is exempt from reporting under paragraph (a) a woman's use or
 37.5 consumption of tetrahydrocannabinol or alcoholic beverages during pregnancy if the
 37.6 professional is providing the woman with prenatal care or other health care services.

37.7 (c) Any person may make a voluntary report if the person knows or has reason to believe
 37.8 that a woman is pregnant and has used a controlled substance for a nonmedical purpose
 37.9 during the pregnancy, including but not limited to tetrahydrocannabinol, or has consumed
 37.10 alcoholic beverages during the pregnancy in any way that is habitual or excessive.

37.11 (d) An oral report shall be made immediately by telephone or otherwise. An oral report
 37.12 made by a person required to report shall be followed within 72 hours, exclusive of weekends
 37.13 and holidays, by a report in writing to the local welfare agency. Any report shall be of
 37.14 sufficient content to identify the pregnant woman, the nature and extent of the use, if known,
 37.15 and the name and address of the reporter. The local welfare agency shall accept a report
 37.16 made under paragraph (c) notwithstanding refusal by a voluntary reporter to provide the
 37.17 reporter's name or address as long as the report is otherwise sufficient.

37.18 (e) For purposes of this section, "prenatal care" means the comprehensive package of
 37.19 medical and psychological support provided throughout the pregnancy.

37.20 Subd. 2. **Local welfare agency.** Upon receipt of a report of prenatal exposure to a
 37.21 controlled substance required under subdivision 1, the local welfare agency shall immediately
 37.22 conduct an appropriate assessment and offer services indicated under the circumstances.
 37.23 Services offered may include but are not limited to a referral for chemical dependency
 37.24 assessment, a referral for chemical dependency treatment if recommended, and a referral
 37.25 for prenatal care. The local welfare agency may also take any appropriate action under
 37.26 chapter 253B, including seeking an emergency admission under section 253B.05. The local
 37.27 welfare agency shall seek an emergency admission under section 253B.05 if the pregnant
 37.28 woman refuses recommended voluntary services or fails recommended treatment.

37.29 Subd. 3. **Related provisions.** Reports under this section are governed by sections
 37.30 260E.05, 260E.06, 260E.34, and 260E.35.

37.31 Subd. 4. **Controlled substances.** For purposes of this section and section 260E.32,
 37.32 "controlled substance" means a controlled substance listed in section 253B.02, subdivision
 37.33 2.

38.1 **Sec. 32. [260E.32] TOXICOLOGY TESTS REQUIRED.**

38.2 Subdivision 1. **Test; report.** (a) A physician shall administer a toxicology test to a
38.3 pregnant woman under the physician's care or to a woman under the physician's care within
38.4 eight hours after delivery to determine whether there is evidence that she has ingested a
38.5 controlled substance, if the woman has obstetrical complications that are a medical indication
38.6 of possible use of a controlled substance for a nonmedical purpose.

38.7 (b) If the test results are positive, the physician shall report the results under section
38.8 260E.31. A negative test result does not eliminate the obligation to report under section
38.9 260E.31 if other evidence gives the physician reason to believe the patient has used a
38.10 controlled substance for a nonmedical purpose.

38.11 Subd. 2. **Newborns.** (a) A physician shall administer to each newborn infant born under
38.12 the physician's care a toxicology test to determine whether there is evidence of prenatal
38.13 exposure to a controlled substance, if the physician has reason to believe based on a medical
38.14 assessment of the mother or the infant that the mother used a controlled substance for a
38.15 nonmedical purpose during the pregnancy.

38.16 (b) If the test results are positive, the physician shall report the results as neglect under
38.17 section 260E.03. A negative test result does not eliminate the obligation to report under this
38.18 chapter if other medical evidence of prenatal exposure to a controlled substance is present.

38.19 Subd. 3. **Report to Department of Health.** Physicians shall report to the Department
38.20 of Health the results of tests performed under subdivisions 1 and 2. A report shall be made
38.21 on the certificate of live birth medical supplement or the report of fetal death medical
38.22 supplement filed on or after February 1, 1991. The reports are medical data under section
38.23 13.384.

38.24 Subd. 4. **Reliability of tests.** A positive test result reported under this section must be
38.25 obtained from a confirmatory test performed by a drug testing laboratory that meets the
38.26 requirements of section 181.953 and must be performed according to the requirements for
38.27 performance of confirmatory tests imposed by the licensing, accreditation, or certification
38.28 program listed in section 181.953, subdivision 1, in which the laboratory participates.

38.29 **Sec. 33. [260E.33] RECONSIDERATION AND APPEAL OF MALTREATMENT**
38.30 **DETERMINATION FOLLOWING INVESTIGATION.**

38.31 Subdivision 1. **Following family assessment.** Administrative reconsideration is not
38.32 applicable in a family assessment since no determination concerning maltreatment is made.

39.1 Subd. 2. Request for reconsideration. (a) Except as provided under subdivision 5, an
39.2 individual or facility that the commissioner of human services, a local welfare agency, or
39.3 the commissioner of education determines has maltreated a child, an interested person acting
39.4 on behalf of the child, regardless of the determination, who contests the investigating agency's
39.5 final determination regarding maltreatment, may request the investigating agency to
39.6 reconsider its final determination regarding maltreatment. The request for reconsideration
39.7 must be submitted in writing to the investigating agency within 15 calendar days after receipt
39.8 of notice of the final determination regarding maltreatment or, if the request is made by an
39.9 interested person who is not entitled to notice, within 15 days after receipt of the notice by
39.10 the parent or guardian of the child. If mailed, the request for reconsideration must be
39.11 postmarked and sent to the investigating agency within 15 calendar days of the individual's
39.12 or facility's receipt of the final determination. If the request for reconsideration is made by
39.13 personal service, it must be received by the investigating agency within 15 calendar days
39.14 after the individual's or facility's receipt of the final determination.

39.15 (b) An individual who was determined to have maltreated a child under this chapter and
39.16 who was disqualified on the basis of serious or recurring maltreatment under sections
39.17 245C.14 and 245C.15 may request reconsideration of the maltreatment determination and
39.18 the disqualification. The request for reconsideration of the maltreatment determination and
39.19 the disqualification must be submitted within 30 calendar days of the individual's receipt
39.20 of the notice of disqualification under sections 245C.16 and 245C.17. If mailed, the request
39.21 for reconsideration of the maltreatment determination and the disqualification must be
39.22 postmarked and sent to the investigating agency within 30 calendar days of the individual's
39.23 receipt of the maltreatment determination and notice of disqualification. If the request for
39.24 reconsideration is made by personal service, it must be received by the investigating agency
39.25 within 30 calendar days after the individual's receipt of the notice of disqualification.

39.26 Subd. 3. Request for fair hearing. (a) Except as provided under subdivisions 5 and 6,
39.27 if the investigating agency denies the request or fails to act upon the request within 15
39.28 working days after receiving the request for reconsideration, the person or facility entitled
39.29 to a fair hearing under section 256.045 may submit to the commissioner of human services
39.30 or the commissioner of education a written request for a hearing under section 256.045.
39.31 Section 256.045 also governs hearings requested to contest a final determination of the
39.32 commissioner of education. The investigating agency shall notify persons who request
39.33 reconsideration of their rights under this paragraph. The hearings specified under this section
39.34 are the only administrative appeal of a decision issued under subdivision 2. Determinations

40.1 under this section are not subject to accuracy and completeness challenges under section
40.2 13.04.

40.3 (b) Except as provided under subdivision 6, if an individual or facility contests the
40.4 investigating agency's final determination regarding maltreatment by requesting a fair
40.5 hearing under section 256.045, the commissioner of human services shall ensure that the
40.6 hearing is conducted and a decision is reached within 90 days of receipt of the request for
40.7 a hearing. The time for action on the decision may be extended for as many days as the
40.8 hearing is postponed or the record is held open for the benefit of either party.

40.9 Subd. 4. **Change of maltreatment determination.** If, as a result of a reconsideration
40.10 or fair hearing, the investigating agency changes the determination of maltreatment, that
40.11 agency shall notify every parent, guardian, or legal custodian previously notified of the
40.12 investigation, the commissioner of the agency responsible for assessing or investigating the
40.13 report, the local welfare agency, and, if applicable, the director of the facility and the private
40.14 licensing agency.

40.15 Subd. 5. **Consolidation.** If an individual was disqualified under sections 245C.14 and
40.16 245C.15 on the basis of a determination of maltreatment which was serious or recurring,
40.17 and the individual requested reconsideration of the maltreatment determination under
40.18 subdivision 2 and requested reconsideration of the disqualification under sections 245C.21
40.19 to 245C.27, reconsideration of the maltreatment determination and reconsideration of the
40.20 disqualification shall be consolidated into a single fair hearing. If reconsideration of the
40.21 maltreatment determination is denied and the individual remains disqualified following a
40.22 reconsideration decision, the individual may request a fair hearing under section 256.045.
40.23 If an individual requests a fair hearing on the maltreatment determination and the
40.24 disqualification, the scope of the fair hearing shall include both the maltreatment
40.25 determination and the disqualification.

40.26 Subd. 6. **Contested case hearing.** If a maltreatment determination or a disqualification
40.27 based on serious or recurring maltreatment is the basis for a denial of a license under section
40.28 245A.05 or a licensing sanction under section 245A.07, the license holder has the right to
40.29 a contested case hearing under chapter 14 and Minnesota Rules, parts 1400.8505 to
40.30 1400.8612. As provided for under section 245A.08, subdivision 2a, the scope of the contested
40.31 case hearing shall include the maltreatment determination, disqualification, and licensing
40.32 sanction or denial of a license. In such cases, a fair hearing regarding the maltreatment
40.33 determination and disqualification shall not be conducted under section 256.045. Except
40.34 for family child care and child foster care, reconsideration of a maltreatment determination

41.1 as provided under this subdivision, and reconsideration of a disqualification as provided
41.2 under section 245C.22, shall also not be conducted when:

41.3 (1) a denial of a license under section 245A.05 or a licensing sanction under section
41.4 245A.07 is based on a determination that the license holder is responsible for maltreatment
41.5 or the disqualification of a license holder based on serious or recurring maltreatment;

41.6 (2) the denial of a license or licensing sanction is issued at the same time as the
41.7 maltreatment determination or disqualification; and

41.8 (3) the license holder appeals the maltreatment determination or disqualification and
41.9 denial of a license or licensing sanction.

41.10 Notwithstanding clauses (1) to (3), if the license holder appeals the maltreatment
41.11 determination or disqualification, but does not appeal the denial of a license or a licensing
41.12 sanction, reconsideration of the maltreatment determination shall be conducted under
41.13 subdivision 2 and section 626.557, subdivision 9d, and reconsideration of the disqualification
41.14 shall be conducted under section 245C.22. In such cases, a fair hearing shall also be
41.15 conducted as provided under subdivision 2 and sections 245C.27 and 626.557, subdivision
41.16 9d.

41.17 If the disqualified subject is an individual other than the license holder and upon whom
41.18 a background study must be conducted under chapter 245C, the hearings of all parties may
41.19 be consolidated into a single contested case hearing upon consent of all parties and the
41.20 administrative law judge.

41.21 Subd. 7. **Process for correction order or decertification.** If a maltreatment determination
41.22 is the basis for a correction order under section 245H.06 or decertification under section
41.23 245H.07, the certification holder has the right to request reconsideration under sections
41.24 245H.06 and 245H.07. If the certification holder appeals the maltreatment determination
41.25 or disqualification, but does not appeal the correction order or decertification, reconsideration
41.26 of the maltreatment determination shall be conducted under subdivision 2 and reconsideration
41.27 of the disqualification shall be conducted under section 245C.22.

41.28 Sec. 34. **[260E.34] IMMUNITY.**

41.29 (a) The following persons are immune from any civil or criminal liability that otherwise
41.30 might result from the person's actions, if the person is acting in good faith:

41.31 (1) a person making a voluntary or mandated report under this chapter or assisting in an
41.32 assessment under this chapter;

42.1 (2) a person with responsibility for performing duties under this section or supervisor
42.2 employed by a local welfare agency, the commissioner of an agency responsible for operating
42.3 or supervising a licensed or unlicensed day care facility, residential facility, agency, hospital,
42.4 sanitarium, or other facility or institution required to be licensed or certified under sections
42.5 144.50 to 144.58; 241.021; 245A.01 to 245A.16; or chapter 245B or 245H; or a school as
42.6 defined in section 120A.05, subdivisions 9, 11, and 13; and chapter 124E; or a nonlicensed
42.7 personal care provider organization as defined in section 256B.0625, subdivision 19a,
42.8 complying with sections 260E.23, subdivisions 2 and 3, and 260E.30; and

42.9 (3) a public or private school, facility as defined in section 260E.03, or the employee of
42.10 any public or private school or facility who permits access by a local welfare agency, the
42.11 Department of Education, or a local law enforcement agency and assists in an investigation
42.12 or assessment pursuant to this chapter.

42.13 (b) A person who is a supervisor or person with responsibility for performing duties
42.14 under this chapter employed by a local welfare agency, the commissioner of human services,
42.15 or the commissioner of education complying with this chapter or any related rule or provision
42.16 of law is immune from any civil or criminal liability that might otherwise result from the
42.17 person's actions, if the person is (1) acting in good faith and exercising due care, or (2)
42.18 acting in good faith and following the information collection procedures established under
42.19 section 260E.20, subdivision 3.

42.20 (c) Any physician or other medical personnel administering a toxicology test under
42.21 section 260E.32 to determine the presence of a controlled substance in a pregnant woman,
42.22 in a woman within eight hours after delivery, or in a child at birth or during the first month
42.23 of life is immune from civil or criminal liability arising from administration of the test, if
42.24 the physician ordering the test believes in good faith that the test is required under this
42.25 section and the test is administered in accordance with an established protocol and reasonable
42.26 medical practice.

42.27 (d) This section does not provide immunity to any person for failure to make a required
42.28 report or for committing maltreatment.

42.29 (e) If a person who makes a voluntary or mandatory report under section 260E.06 prevails
42.30 in a civil action from which the person has been granted immunity under this section, the
42.31 court may award the person attorney fees and costs.

43.1 Sec. 35. [260E.35] DATA PRACTICES.

43.2 Subdivision 1. Maintaining data. Notwithstanding the data's classification in the
43.3 possession of any other agency, data acquired by the local welfare agency or the agency
43.4 responsible for assessing or investigating the report during the course of the assessment or
43.5 investigation are private data on individuals and must be maintained according to this section.

43.6 Subd. 2. Data collected during investigation of maltreatment in school. (a) Data of
43.7 the commissioner of education collected or maintained during and for the purpose of an
43.8 investigation of alleged maltreatment in a school are governed by this chapter,
43.9 notwithstanding the data's classification as educational, licensing, or personnel data under
43.10 chapter 13.

43.11 (b) In conducting an investigation involving a school facility as defined in section
43.12 260E.03, subdivision 6, clause (2), the commissioner of education shall collect investigative
43.13 reports and data that are relevant to a report of maltreatment from local law enforcement
43.14 and the school facility.

43.15 Subd. 3. Classification and release of data. (a) A written copy of a report maintained
43.16 by personnel of agencies, other than welfare or law enforcement agencies, which are subject
43.17 to chapter 13 shall be confidential. An individual subject of the report may obtain access
43.18 to the original report as provided by paragraphs (g) to (o).

43.19 (b) All reports and records created, collected, or maintained under this chapter by a local
43.20 welfare agency or law enforcement agency may be disclosed to a local welfare or other
43.21 child welfare agency of another state when the agency certifies that:

43.22 (1) the reports and records are necessary to conduct an investigation of actions that would
43.23 qualify as maltreatment under this chapter; and

43.24 (2) the reports and records will be used only for purposes of a child protection assessment
43.25 or investigation and will not be further disclosed to any other person or agency.

43.26 (c) The local social service agency or law enforcement agency in this state shall keep a
43.27 record of all records or reports disclosed pursuant to this subdivision and of any agency to
43.28 which the records or reports are disclosed. If in any case records or reports are disclosed
43.29 before a determination is made under section 260E.24, subdivision 3, paragraph (a), or a
43.30 disposition of a criminal proceeding is reached, the local social service agency or law
43.31 enforcement agency in this state shall forward the determination or disposition to any agency
43.32 that has received a report or record under this subdivision.

44.1 (d) The responsible authority of a local welfare agency or the responsible authority's
44.2 designee may release private or confidential data on an active case involving assessment
44.3 or investigation of actions that are defined as maltreatment under this chapter to a court
44.4 services agency if:

44.5 (1) the court services agency has an active case involving a common client who is the
44.6 subject of the data; and

44.7 (2) the data are necessary for the court services agency to effectively process the court
44.8 services agency's case, including investigating or performing other duties relating to the
44.9 case required by law.

44.10 (e) The data disclosed under paragraph (d) may be used only for purposes of the active
44.11 court services case described in paragraph (d), clause (1), and may not be further disclosed
44.12 to any other person or agency, except as authorized by law.

44.13 (f) Records maintained under subdivision 4, paragraph (b), may be shared with another
44.14 local welfare agency that requests the information because it is conducting an assessment
44.15 or investigation under this section of the subject of the records.

44.16 (g) Except as provided in paragraphs (b), (h), (i), (p), and (q); subdivision 1; and sections
44.17 260E.22, subdivision 2; and 260E.23, all records concerning individuals maintained by a
44.18 local welfare agency or agency responsible for assessing or investigating the report under
44.19 this chapter, including any written reports filed under sections 260E.06 and 260E.09, shall
44.20 be private data on individuals, except insofar as copies of reports are required by section
44.21 260E.12, subdivision 1 or 2, to be sent to the local police department or the county sheriff.

44.22 (h) All records concerning determinations of maltreatment by a facility are nonpublic
44.23 data as maintained by the Department of Education, except insofar as copies of reports are
44.24 required by section 260E.12, subdivision 1 or 2, to be sent to the local police department
44.25 or the county sheriff.

44.26 (i) Reports maintained by any police department or the county sheriff shall be private
44.27 data on individuals, except the reports shall be made available to the investigating, petitioning,
44.28 or prosecuting authority, including a county medical examiner or county coroner.

44.29 (j) Section 13.82, subdivisions 8, 9, and 14, apply to law enforcement data other than
44.30 the reports.

44.31 (k) The local welfare agency or agency responsible for assessing or investigating the
44.32 report shall make available to the investigating, petitioning, or prosecuting authority,

45.9 intentionally discloses the identity of a reporter before the completion of the investigation
45.10 or assessment is guilty of a misdemeanor. After the assessment or investigation is completed,
45.11 the name of the reporter shall be confidential. The subject of the report may compel disclosure
45.12 of the name of the reporter only with the consent of the reporter or upon a written finding
45.13 by the court that the report was false and that there is evidence that the report was made in
