Bill Description

This bill would change the fees for exploratory borings from one fee per boring to one fee per map. A map with a specific scale is required to be submitted for each project as part of the notification before installing borings. This fee per boring was passed last session, prior to that there was no fee for exploratory borings. This impacts the Well Management Section in the Environmental Health Division. It does not include an appropriation.

Assumptions

The agency expenditures and workload would not change appreciably as the result of this legislation. There would be a minor reduction in costs for processing the fees but it would be negligible. It would reduce the revenue by reducing the number of fees for exploratory borings. There are approximately 160 exploratory borings per year which generates \$44,000 in revenue (\$275 x 160). There are an average of approximately 10 borings per map (project). The bill proposes to have one fee per map (~10 borings), therefore revenue would be reduced to \$4,400 (\$275 x 16). A reduction of \$39,600 per year, ongoing.

Bill Description

House File 3856-2A modifies certain well notification requirements. The bill allows a single site fee of \$275 to apply to all exploratory borings marked on a borings map and submitted to the commissioner of health, instead of the fee applying for single boring. The bill also clarifies that an exploratory boring is not an environmental well and that the map for proposed borings must be submitted on an 8-1/2 x 11 inch sheet of paper.

Assumptions

MnDOT does not perform these types of exploratory borings for state highway projects or for our facilities. Therefore, there is no fiscal impact to MnDOT.
