### **Bill Description**

#### Section 1.

<u>Subdivisions 1-2</u> of the bill requires the establishment of a Palliative Care Advisory Council to advise and assist the commissioner of health regarding improving the quality and delivery of patient-centered and family-focused palliative care.

Membership of the Council shall consist of 18 public members and 4 members of the legislature. The commissioner of health shall appoint 18 public members. Council membership must include, where possible, representation that is racially, culturally, linguistically, geographically, and economically diverse. The Council also must include at least six members who reside outside Anoka, Carver, Chisago, Dakota, Hennepin, Isanti, Mille Lacs, Ramsey, Scott, Sherburne, Sibley, Stearns, Washington, or Wright Counties.

Council membership must include health professionals who have palliative care work experience or expertise in palliative care delivery models in a variety of settings. Membership must also include persons who have experience in palliative care research, palliative care instruction in medical or nursing school setting, palliative care services for veterans as a provider or recipient, or pediatric care.

<u>Subdivision 3</u> of this bill requires that members of the Council serve for a term of three years and they may be reappointed.

<u>Subdivision 4</u> of this bill requires the commissioner (or designee) to provide meeting space and administrative services for the Council.

<u>Subdivision 5</u> requires the appointing authorities to appoint the first members of the Council by July 1, 2017. The commissioner shall convene the first meeting by September 15, 2017, and the commissioner or the commissioner's designee shall act as chair until the Council elects a chair at the first meeting.

<u>Subdivisions 6-7</u> require, at the Council's first meeting, and biannually thereafter, that the members elect a chair and a vice-chair whose duties shall be established by the Council. The Council chair shall fix a time and place for regular meetings of the Council, which shall meet at least twice yearly.

<u>Subdivision 8</u> requires that public members of the Council serve without compensation, except for reimbursement from the commissioner for allowed actual and necessary expenses incurred in the performance of Council duties.

<u>Subdivision 9</u> requires the Council shall consult with and advise the commissioner on matters related to the establishment, maintenance, operation, and outcomes evaluation of palliative care initiatives in the state.

By February 15 of each year, the Council shall prepare and submit a report containing: (1) the advisory committee's assessment of the availability of palliative care in the state; (2) the advisory committee's analysis of barriers to greater access to palliative care; and (3) recommendations for legislative action. The Department of health is required to publish the report each year on the department's web site.

This section is effective the day following final enactment.

This legislation does not contain an appropriation.

### **Assumptions**

Based on the legislative requirements in the bill, and our experience with supporting similar advisory Councils and Committees, we have the following assumptions:

- The Council will consist of 22 members.
- · MDH will provide administrative services to support the Council.
- · Meetings will occur at least **2** *times per year*; and some of these meetings will take place in Greater Minnesota.
- $\cdot$  Refreshments are required for 22 Council members; and meeting space (rent) may be necessary for meetings in Greater Minnesota.
- · Cost estimates do not include any reimbursement for Council member travel expenses.
- · MDH will be required to develop and maintain new web content about palliative care, including annual reports and information about the Council.
- MDH staff also will help compile and prepare annual reports.

The cost of 0.5 FTE Planner Senior State position will be necessary, along with related operational expenses, to coordinate and manage this activity. Specifically, this staff person will:

- $\cdot$  Coordinate with the Minnesota Secretary of State's Office to manage legislative appointments for the Council (when the Council is newly established, and as member terms conclude or expire).
- Develop and implement a process and materials for making non-legislative appointments to the Council; this includes an appointment form, instructions, and evaluation criteria for reviewing/selecting members.
- · Prepare and distribute letters for the Commissioner's signature to appoint new members; and to thank members whose terms have concluded.
- · Prepare agendas and schedule quarterly meetings of the Council.
- · Coordinate with Council members and partners to compile background materials for Council meetings; distribute materials to the Council.
- · Complete RAISE forms for refreshments; meeting rooms.
- Set up meetings and provide technical assistance for laptops and projectors; gather presentations.
- · Prepare meeting notes/summaries and distribute to the Council.
- · Compile annual reports for the Council; evaluate and incorporate comments from members; ensure the reports meets state IT web accessibility standards; publish the final report on MDH's web site.
- Develop and maintain web content to host reports and information about the Council.
- Respond to inquiries from the Council and public, as needed (email, phone).
