1.3 "Section 1. Minnesota Statutes 2015 Supplement, section 103B.101, subdivision 12a,  
1.4 is amended to read:

1.5 Subd. 12a. **Authority to issue penalty orders.** (a) A county or watershed  
1.6 district with jurisdiction or the Board of Water and Soil Resources may issue an order  
1.7 requiring violations of the water resources riparian protection requirements under sections  
1.8 103F.415, 103F.421, and 103F.48 to be corrected and administratively assessing monetary  
1.9 penalties up to \$500 for noncompliance commencing on day one of the 11th month  
1.10 after the noncompliance notice was issued. One-half of the proceeds collected from an  
1.11 administrative penalty order issued under this section must be remitted to the county or  
1.12 watershed district with jurisdiction over the noncompliant site.

1.13 (b) Administrative penalties may be reissued and appealed under paragraph (a)  
1.14 according to section 103F.48, subdivision 9.

1.15 (c) For the purposes of this section, "with jurisdiction" means that the county or  
1.16 watershed district has adopted a rule or ordinance providing procedures for the issuance of  
1.17 administrative penalty orders, enforcement, and appeals for purposes of this section and  
1.18 section 103F.48. A county or watershed district that has not adopted a rule or ordinance  
1.19 for purposes of this section and section 103F.48 is not considered to be "with jurisdiction."

1.21 Subd. 8. **Extent of damages.** (a) Damages to be paid may include:

1.22 (1) the fair market value of the property required for the channel of an open ditch  
1.23 and the permanent strip of perennial vegetation under section 103E.021;

1.24 (2) the diminished value of a farm due to severing a field by an open ditch;

1.25 (3) loss of crop production during drainage project construction;

1.26 (4) the diminished productivity or land value from increased overflow; and

2.1 (5) costs to restore a perennial vegetative cover or structural practice existing  
2.2 under a federal or state conservation program adjacent to the permanent drainage system  
2.3 right-of-way and damaged by the drainage project.

2.4 (b) When damages are determined to acquire or otherwise provide compensation for  
2.5 buffer strips or alternative riparian water quality practices previously installed as required  
2.6 by section 103F.48, subdivision 3, the viewers and drainage authority shall consider the  
2.7 land use prior to buffer strip or alternative practice installation in determining the fair

2.11 Subdivision 1. **Definitions.** (a) For the purposes of this section, the following terms

2.13 (b) "Board" means the Board of Water and Soil Resources.

2.14 (c) "Buffer" means an area consisting of perennial vegetation, excluding invasive  
2.15 plants and noxious weeds, adjacent to all bodies of water within the state and that protects  
2.16 the water resources of the state from runoff pollution; stabilizes soils, shores, and banks;  
2.17 and protects or provides riparian corridors.

2.18 (d) "Buffer protection map" means buffer maps established and maintained by the  
2.19 commissioner of natural resources.

2.20 (e) "Commissioner" means the commissioner of natural resources.

2.21 (f) "Executive director" means the executive director of the Board of Water and  
2.22 Soil Resources.

2.23 (g) "Local water management authority" means a watershed district, metropolitan  
2.24 water management organization, or county operating separately or jointly in its role as  
2.25 local water management authority under chapter 103B or 103D.

2.26 (h) "Normal water level" means the level evidenced by the long-term presence of  
2.27 surface water as indicated directly by hydrophytic plants or hydric soils or indirectly

3.2 amended to read:

3.3 Subd. 3. **Water resources riparian protection requirements on public waters**  
3.4 **and public drainage systems.** (a) Except as provided in paragraph (b), landowners  
3.5 owning property adjacent to a water body identified and mapped on a buffer protection  
3.6 map must maintain a buffer to protect the state's water resources as follows:

3.7 (1) for all public waters with a shoreland management classification, the more  
3.8 restrictive of:

3.9 (i) a 50-foot average width, 30-foot minimum width, continuous buffer of  
3.10 perennially rooted vegetation; or

3.11 (ii) ~~the state shoreland standards and criteria adopted by the commissioner~~ contained  
3.12 in locally adopted and commissioner-approved shoreland ordinances under section  
3.13 103F.211; and

3.14 (2) for public drainage systems established under chapter 103E, a 16.5-foot  
3.15 minimum width continuous buffer of ~~perennially rooted vegetation on ditches within the~~  
3.16 ~~benefited area of public drainage systems~~ permanent grass, other than invasive plants and  
3.17 noxious weeds, or other perennially rooted vegetation measured outward from the top  
3.18 edge of the constructed channel of the public drainage system. The buffer vegetation shall

3.20 (b) A landowner owning property adjacent to a water body identified in a buffer  
3.21 protection map and whose property is used for cultivation farming may meet the  
3.22 requirements under paragraph (a) by adopting an alternative riparian water quality  
3.23 practice, or combination of structural, vegetative, and management practices, based on the  
3.24 Natural Resources Conservation Service Field Office Technical Guide or other practices  
3.25 approved by the board, that provide water quality protection comparable to the buffer  
3.26 protection for the water body that the property abuts. These practices must include  
3.27 retention ponds and alternative measures that prevent overland flow to the water resource.

3.28 (c) The width of a buffer must be measured from the top or crown of the bank. Where  
3.29 there is no defined bank, measurement must be from the edge of the normal water level.

3.30 (d) Upon request by a landowner or authorized agent or operator of a landowner,  
3.31 a technical professional employee or contractor of the soil and water conservation  
3.32 district or its delegate may issue a validation of compliance with the requirements of  
3.33 this subdivision. The soil and water conservation district validation may be appealed to  
3.34 the board as described in subdivision 9.

4.19 watershed district with jurisdiction must provide the landowner with a list of corrective  
4.20 actions needed to come into compliance and a practical timeline to meet the requirements  
4.21 in this section. The county or watershed district with jurisdiction must provide a copy of  
4.22 the corrective action notice to the board. If no county or watershed district has jurisdiction

5.20 aid, a natural resources block grant, and other project or program funding.~~ Funding may  
5.21 be restored upon the board's approval of a corrective action plan.

5.26 for information on how to apply for local, state, or federal cost-share grants, contracts, or  
5.27 loans that are available to establish buffers or other water resource protection measures.

6.2            (a) Each county is eligible to receive aid under this section to enforce and implement  
6.3 the riparian protection and water quality practices under section 103F.48. Aid to each  
6.4 county shall equal: (1) the number of miles of public waters, as defined in section 103F.48,  
6.5 subdivision 1, paragraph (i), in the county; multiplied by (2) the number of acres in the  
6.6 county classified as class 2a under section 273.13; multiplied by ..... If one or more  
6.7 watershed districts assumes responsibility for the riparian protection and water quality  
6.8 practices under section 103F.48, the county shall proportionately allocate funds received
