1.4 "Sec. 2. Minnesota Statutes 2014, section 62U.04, subdivision 4, is amended to read:

1.5 Subd. 4. **Encounter data.** (a) Beginning July 1, 2009, and every six months
1.6 thereafter, all health plan companies and third-party administrators shall submit encounter
1.7 data to a private entity designated by the commissioner of health. The data shall be
1.8 submitted in a form and manner specified by the commissioner subject to the following
1.9 requirements:

1.10 (1) the data must be de-identified data as described under the Code of Federal
1.11 Regulations, title 45, section 164.514;

1.12 (2) the data for each encounter must include an identifier for the patient's health care
1.13 home if the patient has selected a health care home; and

1.14 (3) except for the identifier described in clause (2), the data must not include
1.15 information that is not included in a health care claim or equivalent encounter information
1.16 transaction that is required under section 62J.536.

1.17 (b) The commissioner or the commissioner's designee shall only use the data
1.18 submitted under paragraph (a) to carry out the commissioner's responsibilities in this
1.19 section, including supplying the data to providers so they can verify their results of
1.20 the peer grouping process consistent with the recommendations developed pursuant to
1.21 subdivision 3c, paragraph (d), and adopted by the commissioner and, if necessary, submit
1.22 comments to the commissioner or initiate an appeal.

1.23 (c) Data on providers collected under this subdivision are private data on individuals
1.24 or nonpublic data, as defined in section 13.02. Notwithstanding the definition of summary
1.25 data in section 13.02, subdivision 19, summary data prepared under this subdivision
1.26 may be derived from nonpublic data. The commissioner or the commissioner's designee

2.3 (d) The commissioner or the commissioner's designee shall not publish analyses or
 2.4 reports that identify, or could potentially identify, individual patients.

2.5 (e) The commissioner shall compile summary information on the data submitted
 2.6 under this subdivision. The commissioner shall work with its vendors to assess the
 2.7 data submitted in terms of compliance with the data submission requirements and the
 2.8 completeness of the data submitted by comparing the data with summary information
 2.9 compiled by the commissioner and with established and emerging data quality standards
 2.10 to ensure data quality.

2.11 (f) This subdivision does not apply to data from self-funded companies.

2.14 Subd. 5. **Pricing data.** (a) Beginning July 1, 2009, and annually on January 1
 2.15 thereafter, all health plan companies and third-party administrators shall submit data
 2.16 on their contracted prices with health care providers to a private entity designated by
 2.17 the commissioner of health for the purposes of performing the analyses required under
 2.18 this subdivision. The data shall be submitted in the form and manner specified by the
 2.19 commissioner of health.

2.20 (b) The commissioner or the commissioner's designee shall only use the data
 2.21 submitted under this subdivision to carry out the commissioner's responsibilities under
 2.22 this section, including supplying the data to providers so they can verify their results of
 2.23 the peer grouping process consistent with the recommendations developed pursuant to
 2.24 subdivision 3c, paragraph (d), and adopted by the commissioner and, if necessary, submit
 2.25 comments to the commissioner or initiate an appeal.

2.26 (c) Data collected under this subdivision are nonpublic data as defined in section
 2.27 13.02. Notwithstanding the definition of summary data in section 13.02, subdivision 19,
 2.28 summary data prepared under this section may be derived from nonpublic data. The
 2.29 commissioner shall establish procedures and safeguards to protect the integrity and
 2.30 confidentiality of any data that it maintains.
