- 1.1 A bill for an act
- 1.2 relating to education finance; clarifying the aid and levy amounts for community
- 1.3 education programs; amending Minnesota Statutes 2024, section 124D.20,
- 1.4 subdivisions 3, 4a, 5.
- 1.5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
- 1.6 Section 1. Minnesota Statutes 2024, section 124D.20, subdivision 3, is amended to read:
- 1.7 Subd. 3. **General community education revenue.** The general community education
- 1.8 revenue for a district equals ~~\$5.42 for fiscal year 2007 through fiscal year 2024~~ and \$6.35
- 1.9 for fiscal year 2025 and later, times the greater of 1,335 or the population of the district.
- 1.10 The population of the district is determined according to section 275.14.
- 1.11 Sec. 2. Minnesota Statutes 2024, section 124D.20, subdivision 4a, is amended to read:
- 1.12 Subd. 4a. **Youth after-school enrichment revenue.** ~~In fiscal year 2003 and thereafter,~~
- 1.13 Youth after-school enrichment revenue for a district operating a youth after-school
- 1.14 enrichment program under section 124D.19, subdivision 12, equals:
- 1.15 (1) \$1.85 times the greater of 1,335 or the population of the district, as defined in section
- 1.16 275.14, not to exceed 10,000; and
- 1.17 (2) \$0.43 times the population of the district, as defined in section 275.14, in excess of
- 1.18 10,000. Youth after-school enrichment revenue must be reserved for youth after-school
- 1.19 enrichment programs.

2.1 Sec. 3. Minnesota Statutes 2024, section 124D.20, subdivision 5, is amended to read:

2.2 Subd. 5. **Total community education levy.** To obtain total community education revenue,
2.3 a district may levy the amount raised by a maximum tax rate of ~~0.94 percent through fiscal~~
2.4 ~~year 2024~~, 0.375 percent in fiscal year 2025, 0.3298 percent in fiscal year 2026, and 0.3128
2.5 percent in fiscal year 2027 and later, times the adjusted net tax capacity of the district. If
2.6 the amount of the total community education levy would exceed the total community
2.7 education revenue, the total community education levy shall be determined according to
2.8 subdivision 6.
