1.15 defined under section 168B.011, subdivision 12a; a freeway service patrol vehicle; a road
1.16 maintenance vehicle; a utility company vehicle; a construction vehicle; a solid waste vehicle;
1.17 or a recycling vehicle.

1.18 (b) When approaching and before passing an authorized ~~emergency~~ vehicle with its
1.19 emergency, flashing, or warning lights activated that is parked or otherwise stopped on or

2.4 a vehicle shall safely move the vehicle so as to leave a full lane vacant between the driver
2.5 and any lane in which the ~~emergency~~ authorized vehicle is completely or partially parked
2.6 or otherwise stopped, if it is possible to do so.

2.18 violation was not committed in the presence of the peace officer.
