1.13 permit when the court imposes a firearm prohibition, the permit holder must surrender the  
1.14 permit to the assigned probation officer, if applicable. When a probation officer is assigned  
1.15 upon disposition of the case, the court shall inform the probation agent of the permit holder's  
1.16 obligation to surrender the permit. Upon surrender, the probation officer must send the  
1.17 permit to the issuing law enforcement agency. If a probation officer is not assigned to the  
1.18 permit holder, the holder shall surrender the permit as provided for in paragraph (a)."
