Family Child Care Incorporated and the undersigned family child care providers, strongly support HF 904/SF 935 which exempts family child care providers and child care centers from the positive supports rule. The reasons we support this exemption include the following;

- Licensed child care providers are already prohibited from using the majority of prohibited practices outlined in the positive supports rule with only a few small but meaningful exceptions such as the use of time outs. Expanding all prohibited practices in the Positive Supports Rule to child care programs would eliminate safe and practical tools used to ensure the health, safety and wellbeing of *all* children in care
- The additional training hours and cost would create a significant hardship for child care providers who are already required to take ongoing education that includes child care specific training on appropriate behavior guidance techniques for children who may have intellectual or developmental disabilities.
- Because the Positive Supports Training was developed for programs that exclusively serve adults and individuals with intellectual or developmental disabilities, many of whom are residents of the program, a large portion of the training material would be irrelevant for child care programs.
- The Jensen settlement agreement does not require expansion of the Positive Supports Rule to child care.

Family Child Care Inc. and the undersigned licensed family child care providers of southeastern Minnesota support exemption from the Positive Supports Rule and urge the Minnesota Legislature to pass HF 904 and SF 935.
