1.10 shall establish a license and a Minnesota identification card that does not meet all  
1.11 requirements of the REAL ID Act, as provided in subdivision 3.

1.12 Subd. 4. **Data-sharing limitations.** (a) In the procedures and requirements for  
1.13 issuance of a noncompliant license or identification card, the commissioner may not:

1.14 (1) electronically disseminate outside the state personally identifiable data that is not  
1.15 disseminated as of the effective date of this act;

1.16 (2) utilize any electronic validation or verification system accessible from or  
1.17 maintained outside of the state that is not in use as of the effective date of this act; and

1.18 (3) share any firearms safety data the department maintains under section 171.07,  
1.19 subdivision 13.

1.20 (b) The limitations in paragraph (a) do not apply as directly necessary to maintain  
1.21 compliance with the driver's license compact under section 171.50.

1.22 (c) For purposes of this subdivision, "outside the state" includes federal agencies,  
1.23 states other than Minnesota, organizations operating under agreement among the states,  
1.24 and private entities.

1.25 Subd. 5. **Statutory construction.** (a) For purposes of this chapter, unless specifically  
1.26 provided otherwise, a driver's license, instruction permit, or provisional license includes

2.1 any noncompliant license. For purposes of this chapter, unless specifically provided  
2.2 otherwise, a Minnesota identification card includes any noncompliant identification card.

2.3 (b) A noncompliant license does not include an enhanced driver's license, and a  
2.4 noncompliant identification card does not include an enhanced identification card."

2.8 "Sec. 8. Minnesota Statutes 2014, section 171.07, is amended by adding a subdivision

2.10 Subd. 1c. **Design for noncompliant licenses or identification cards.** A  
2.11 noncompliant license or identification card, as provided under section 171.019, must:

2.12 (1) be printed with "Not for Federal Purposes" on the face; and

2.13 (2) meet the requirements under Code of Federal Regulations, title 6, section 37.71."
