Bill Description

This bill provides \$1,386,534 annually ongoing for a grant for a statewide voice response system to address suicide and mental health crisis prevention. It also provides \$657,313 annually for a grant for a statewide text message system to address suicide and mental health crisis prevention.

The bill allows funds to be used for operation and education. The recipient would need to provide immediate suicide prevention counseling and referrals to local resources when appropriate. The recipient would need to maximize availability of the services and provide community education on the availability of the programs.

Assumptions

In addition to the direct appropriations proposed in this bill, DHS requests one FTE who will oversee the fiscal, grant, and data management components of the new funds. This position's duties will include tasks such as administering Requests for Proposals (RFPs) and managing contracts, providing oversight of the funds allocated, and collecting and analyzing outcome and trend data to support continuous improvement of the program. A dedicated FTE to oversee these functions will make the program more efficient and ensure that the program will be successfully implemented. This position will be in the Mental Health Division, Community Supports Administration.
