 2.34 school shall meet all federal, state, and local health and safety requirements applicable
 2.35 to school districts.

6.1 Subd. 3. **Application process.** (a) An eligible authorizer under this section must
 6.2 apply to the commissioner for approval as an authorizer before submitting any affidavit to
 6.3 the commissioner to charter a school. The application for approval as a charter school
 6.4 authorizer must ~~demonstrate~~ show the applicant's ability to implement the procedures
 6.5 and satisfy the criteria for chartering a school under this chapter. The commissioner
 6.6 must approve or disapprove ~~an~~ the application within 45 business days of the ~~application~~
 6.7 deadline for that application period. If the commissioner disapproves the application, the
