1.5 Subd. 15. **Special skill.** "Special skill" means one of the following eight categories:

1.6 (a) **Excavation.** Excavation includes work in any of the following areas:

1.7 (1) excavation;

1.8 (2) trenching;

1.9 (3) grading; and

1.10 (4) site grading.

1.11 (b) **Masonry and concrete.** Masonry and concrete includes work in any of the following
1.12 areas:

1.13 (1) drain systems;

1.14 (2) poured walls;

1.15 (3) slabs and poured-in-place footings;

1.16 (4) masonry walls;

1.17 (5) masonry fireplaces;

1.18 (6) masonry veneer; and

1.19 (7) water resistance and waterproofing.

1.20 (c) **Carpentry.** Carpentry includes work in any of the following areas:

- 2.1 (1) rough framing;
- 2.2 (2) finish carpentry;
- 2.3 (3) doors, windows, and skylights;
- 2.4 (4) porches and decks, excluding footings;
- 2.5 (5) wood foundations; and
- 2.6 (6) drywall installation, excluding taping and finishing.
- 2.7 (d) **Interior finishing.** Interior finishing includes work in any of the following areas:
- 2.8 (1) floor covering;
- 2.9 (2) wood floors;
- 2.10 (3) cabinet and counter top installation;
- 2.11 (4) insulation and vapor barriers;
- 2.12 (5) interior or exterior painting;
- 2.13 (6) ceramic, marble, and quarry tile;
- 2.14 (7) ornamental guardrail and installation of prefabricated stairs; and
- 2.15 (8) wallpapering.
- 2.16 (e) **Exterior finishing.** Exterior finishing includes work in any of the following areas:
- 2.17 (1) siding;
- 2.18 (2) soffit, fascia, and trim;
- 2.19 (3) exterior plaster and stucco;
- 2.20 (4) painting; and
- 2.21 (5) rain carrying systems, including gutters and down spouts.
- 2.22 (f) **Drywall and plaster.** Drywall and plaster includes work in any of the following
- 2.23 areas:
- 2.24 (1) installation;
- 2.25 (2) taping;
- 2.26 (3) finishing;
- 2.27 (4) interior plaster;

- 3.1 (5) painting; and
- 3.2 (6) wallpapering.
- 3.3 (g) **Residential roofing.** Residential roofing includes work in any of the following areas:
- 3.4 (1) roof coverings;
- 3.5 (2) roof sheathing;
- 3.6 (3) roof weatherproofing and insulation; ~~and~~
- 3.7 (4) repair of roof support system, but not construction of new roof support system; and
- 3.8 (5) penetration of roof covering for purposes of attaching a solar photovoltaic system.
- 3.9 (h) **General installation specialties.** Installation includes work in any of the following
- 3.10 areas:
- 3.11 (1) garage doors and openers;
- 3.12 (2) pools, spas, and hot tubs;
- 3.13 (3) fireplaces and wood stoves;
- 3.14 (4) asphalt paving and seal coating; ~~and~~
- 3.15 (5) ornamental guardrail and prefabricated stairs; and
- 3.16 (6) assembly of the support system for a solar photovoltaic system."
