Tragically, the average age of entry into sex trafficking is just 12 to 14 years old, a heartbreaking reality we witness firsthand.

While Minnesota has made tremendous progress through bipartisan support of the Safe Harbor Law, more resources are urgently needed to address the alarming number of children being trafficked across our state. HF 2707 would provide essential funding to expand services, emergency shelter, and housing for victims—helping more young people escape exploitation and rebuild their lives.

Sex trafficking remains a devastating reality in Minnesota. The 2022 Minnesota Student Survey found that at least 4,800 ninth and 11th graders had experienced sexual exploitation—and this is likely an undercount, as it only reflects two grade levels and those comfortable disclosing on a school survey. As one of the state's Safe Harbor-funded grantees, the YMCA serves more than 150 trafficking victims annually, yet waitlists persist due to limited resources. Equally distressing is the fact that victims are increasingly young—the average age of entry into trafficking is just 12 to 14, a trend we witness daily in our work.

Minnesota's children deserve safety, stability, and the chance to heal. No child should ever be bought or sold for profit. By supporting HF 2707 and its Senate counterpart, we have a powerful opportunity to combat trafficking and provide survivors with the support they need to thrive.

Women's Foundation of Minnesota Supports SF 3001/HF 2707

Minnesota House Human Services Finance and Policy committee members,

As the President and CEO of the Women's Foundation of Minnesota, I am writing to express our support for HF 2707, a bill that would appropriate money for sexually exploited youth for Safe Harbor shelter and housing. For over 40 years, the Women's Foundation has invested more than \$54 million in organizations across the state, and advanced policies to create a state where women, girls, and their families can thrive. The Women's Foundation advocated for the original 2011 Safe Harbor legislation and paid the \$12,000 fiscal note that helped enable its passage. Almost a decade and a half later, we're here again to advocate for this funding.

In the 2017 report we funded, <u>Mapping the Demand: Sex Buyers in the State of Minnesota</u>, we know that youth exploitation is a crisis happening in <u>all of our communities</u>. A 2019 study on Safe Harbor found that the vast majority of participants were female, six percent were male, and three percent were transgender or gender-expansive. The National Human Trafficking Hotline received 335 calls from Minnesotans in 2021. A total of 98 cases were identified with 148 victims. Seventy-seven percent of cases involved sex trafficking. Responses to a question in the Minnesota Student Survey also funded by our organization revealed that almost two percent of Minnesota eleventh grade girls and five percent of nonbinary and transgender students surveyed in Minnesota public schools reported having traded sexual activity to receive money, food, drugs, alcohol, a place to stay, or anything else.

Youth exploitation can have far-reaching impacts on housing. Our 2024 Status of Women and Girls+ report found 42 percent of unhoused Minnesota women experienced sexual abuse as a child. Nationwide, approximately one in three homeless women experienced childhood sexual trauma. Youth in Minnesota who have survived sexual exploitation are often trapped in violent cycles unless critical interventions are made. Without expanded outreach services, too many will find themselves in unstable housing or unhoused, struggling with mental health issues including addiction, anxiety and post-traumatic stress disorder or even back in the hands of those who are exploiting them. Survivors, and those at risk of exploitation, need safe housing, care, respect and dignity to rebuild their lives. We appreciate the work of Representative Keeler and the many co-authors of HF 2707 for bringing this bill forward and we urge you to support the crucial funding in HF 2707.
