1.6 preparation programs include traditional programs delivered by postsecondary institutions,  
1.7 alternative teacher preparation programs, and nonconventional teacher preparation programs.

1.9 provider" or "unit" means an entity that has primary responsibility for overseeing and  
1.10 delivering a teacher preparation program."
