The presidential electors and alternate presidential electors, before 12:00 M. on the 33.25 33.26 day before that fixed by Congress for the electors to vote for president and vice president of the United States, shall notify the governor that they are at the State Capitol and ready 33.27 at the proper time to fulfill their duties as electors. The governor shall deliver to the 33.28 electors present a certificate of the names of all the electors. If any elector named therein 33.29 fails to appear before 9:00 a.m. on the day, and at the place, fixed for voting for president 33.30 and vice president of the United States, an alternate, chosen from among the alternates by 33.31 lot, shall be appointed to act for that elector. If more than eight alternates are necessary, 33.32

35.11	before the end of the meeting at which elector votes are cast, in which case a substitute
35.12	elector will fill the vacancy; and
35.13	(2) if a substitute elector is appointed to fill a vacancy, the governor will submit an
35.14	amended certificate of ascertainment stating the names on the final list of this state's
35.15	electors.

35.17	(a) The secretary of state shall preside at the meeting of electors described in section
35.18	<u>208.06.</u>
35.19	(b) The position of an elector not present to vote is vacant. The secretary of state
35.20	shall appoint an individual as a substitute elector to fill a vacancy as follows:
35.21	(1) if the alternate elector is present to vote, by appointing the alternate elector
35.22	for the vacant position;
35.23	(2) if the alternate elector for the vacant position is not present to vote, by appointing
35.24	an elector chosen by lot from among the alternate electors present to vote who were
35.25	nominated by the same political party or unaffiliated presidential candidate;
35.26	(3) if the number of alternate electors present to vote is insufficient to fill any
35.27	vacant position pursuant to clauses (1) and (2), by appointing any immediately available
35.28	individual who is qualified to serve as an elector and chosen through nomination by a
35.29	plurality vote of the remaining electors, including nomination and vote by a single elector
35.30	if only one remains;
35.31	(4) if there is a tie between at least two nominees for substitute elector in a vote
35.32	conducted under clause (3), by appointing an elector chosen by lot from among those
35.33	nominees; or

(a) At the time designated for elector voting in section 208.06, and after all vacant
positions have been filled under section 208.45, the secretary of state shall provide each
elector with a presidential and a vice-presidential ballot. The elector shall mark the
elector's presidential and vice-presidential ballots with the elector's votes for the offices
of president and vice president, respectively, along with the elector's signature and the
elector's legibly printed name.

(b) Except as otherwise provided by law of this state other than this chapter, each 36.15 elector shall present both completed ballots to the secretary of state, who shall examine 36.16 36.17 the ballots and accept as cast all ballots of electors whose votes are consistent with their pledges executed under section 208.43 or 208.45, paragraph (c). Except as otherwise 36.18 provided by law of this state other than this chapter, the secretary of state may not accept 36.19 and may not count either an elector's presidential or vice-presidential ballot if the elector 36.20 has not marked both ballots or has marked a ballot in violation of the elector's pledge. 36.21 36.22 (c) An elector who refuses to present a ballot, presents an unmarked ballot, or presents a ballot marked in violation of the elector's pledge executed under section 208.43 36.23 or 208.45, paragraph (c), vacates the office of elector, creating a vacant position to be 36.24 36.25 filled under section 208.45.

36.26 (d) The secretary of state shall distribute ballots to and collect ballots from a
 36.27 substitute elector and repeat the process under this section of examining ballots, declaring
 36.28 and filling vacant positions as required, and recording appropriately completed ballots from
 36.29 the substituted electors, until all of this state's electoral votes have been cast and recorded.

 36.31 (a) After the vote of this state's electors is completed, if the final list of electors
 36.32 differs from any list that the governor previously included on a certificate of ascertainment
 36.33 prepared and transmitted under United States Code, title 3, section 6, the secretary of state

37.12	Sec. 13. [208.48] UNIFORMITY OF APPLICATION AND CONSTRUCTION.
37.13	In applying and construing sections 208.40 to 208.48, consideration must be given
37.14	to the need to promote uniformity of the law with respect to their subject matter among
37.15	states that enact the Uniform Faithful Presidential Electors Act or similar law.
37.16	Sec. 14. Minnesota Statutes 2014, section 209.01, subdivision 2, is amended to read:
37.17	Subd. 2. Statewide office. For purposes of this chapter, "statewide office" means the
37.18	office of governor, lieutenant governor, attorney general, state auditor, secretary of state,
37.19	chief justice or associate justice of the Supreme Court, judge of the Court of Appeals,
37.20	United States senator, or presidential elector or alternate.
