1.5 Subd. 2. **Boring.** "Boring" means a hole or excavation that ~~is not used to extract water~~
1.6 ~~and~~ includes exploratory borings, bored geothermal heat exchangers, temporary borings,
1.7 and elevator borings.

1.8 Sec. 5. Minnesota Statutes 2018, section 103I.005, subdivision 8a, is amended to read:

1.9 Subd. 8a. **Environmental well.** "Environmental well" means an excavation 15 or more
1.10 feet in depth that is drilled, cored, bored, washed, driven, dug, jetted, or otherwise constructed
1.11 to:

1.12 (1) conduct physical, chemical, or biological testing of groundwater, and includes a
1.13 groundwater quality monitoring or sampling well;

1.14 (2) lower a groundwater level to control or remove contamination in groundwater, and
1.15 includes a remedial well and excludes horizontal trenches; or

1.16 (3) monitor or measure physical, chemical, radiological, or biological parameters of the
1.17 earth and earth fluids, or for vapor recovery or venting systems. An environmental well
1.18 includes an excavation used to:

1.19 (i) measure groundwater levels, including a piezometer;

1.20 (ii) determine groundwater flow direction or velocity;

1.21 (iii) measure earth properties such as hydraulic conductivity, bearing capacity, or
1.22 resistance;

2.6 Subd. 17a. **Temporary ~~environmental well~~ boring.** ~~"Temporary environmental well"~~

2.7 ~~means an environmental well as defined in section 103I.005, subdivision 8a, that is sealed~~

2.8 ~~within 72 hours of the time construction on the well begins.~~ "Temporary boring" means an

2.9 excavation that is 15 feet or more in depth, is sealed within 72 hours of the time of

2.10 construction, and is drilled, cored, washed, driven, dug, jetted, or otherwise constructed to:

2.11 (1) conduct physical, chemical, or biological testing of groundwater, including

2.19 Subdivision 1. **Notification required.** (a) Except as provided in paragraph (d), a person

2.20 may not construct a water-supply, dewatering, or environmental well until a notification of

2.21 the proposed well on a form prescribed by the commissioner is filed with the commissioner

2.22 with the filing fee in section 103I.208, and, when applicable, the person has met the

2.23 requirements of paragraph (e). If after filing the well notification an attempt to construct a

2.24 well is unsuccessful, a new notification is not required unless the information relating to

2.25 the successful well has substantially changed. A notification is not required prior to

2.26 construction of a temporary ~~environmental well~~ boring.

2.27 (b) The property owner, the property owner's agent, or the licensed contractor where a

2.28 well is to be located must file the well notification with the commissioner.

2.29 (c) The well notification under this subdivision preempts local permits and notifications,

2.30 and counties or home rule charter or statutory cities may not require a permit or notification

3.1 for wells unless the commissioner has delegated the permitting or notification authority
3.2 under section 103I.111.

3.3 (d) A person who is an individual that constructs a drive point water-supply well on
3.4 property owned or leased by the individual for farming or agricultural purposes or as the
3.5 individual's place of abode must notify the commissioner of the installation and location of
3.6 the well. The person must complete the notification form prescribed by the commissioner
3.7 and mail it to the commissioner by ten days after the well is completed. A fee may not be
3.8 charged for the notification. A person who sells drive point wells at retail must provide
3.9 buyers with notification forms and informational materials including requirements regarding
3.10 wells, their location, construction, and disclosure. The commissioner must provide the
3.11 notification forms and informational materials to the sellers.

3.21 paragraph (c).

3.22 The person may begin construction after receiving preliminary approval from the
3.23 commissioner of natural resources.

3.24 Sec. 8. Minnesota Statutes 2018, section 103I.205, subdivision 4, is amended to read:

3.25 Subd. 4. **License required.** (a) Except as provided in paragraph (b), (c), (d), or (e),
3.26 section 103I.401, subdivision 2, or 103I.601, subdivision 2, a person may not drill, construct,
3.27 repair, or seal a well or boring unless the person has a well contractor's license in possession.

3.28 (b) A person may construct, repair, and seal an environmental well or temporary boring
3.29 if the person:

3.30 (1) is a professional engineer licensed under sections 326.02 to 326.15 in the branches
3.31 of civil or geological engineering;

3.32 (2) is a hydrologist or hydrogeologist certified by the American Institute of Hydrology;

4.1 (3) is a professional geoscientist licensed under sections 326.02 to 326.15;

4.2 (4) is a geologist certified by the American Institute of Professional Geologists; or

4.3 (5) meets the qualifications established by the commissioner in rule.

4.4 A person must be licensed by the commissioner as an environmental well contractor on
4.5 forms provided by the commissioner.

4.6 (c) A person may do the following work with a limited well/boring contractor's license
4.7 in possession. A separate license is required for each of the four activities:

4.8 (1) installing, repairing, and modifying well screens, pitless units and pitless adaptors,
4.9 well pumps and pumping equipment, and well casings from the pitless adaptor or pitless
4.10 unit to the upper termination of the well casing;

4.11 (2) sealing wells and borings;

4.12 (3) constructing, repairing, and sealing dewatering wells; or

4.13 (4) constructing, repairing, and sealing bored geothermal heat exchangers.

4.14 (d) A person may construct, repair, and seal an elevator boring with an elevator boring

4.16 (e) Notwithstanding other provisions of this chapter requiring a license, a license is not
4.17 required for a person who complies with the other provisions of this chapter if the person

4.19 (1) an individual who constructs a water-supply well on land that is owned or leased by

5.2 Subd. 9. **Report of work.** Within ~~30~~ 60 days after completion or sealing of a well or
5.3 boring, the person doing the work must submit a verified report to the commissioner
5.4 containing the information specified by rules adopted under this chapter.

5.5 Within 30 days after receiving the report, the commissioner shall send or otherwise
5.6 provide access to a copy of the report to the commissioner of natural resources, to the local
5.7 soil and water conservation district where the well is located, and to the director of the
5.8 Minnesota Geological Survey.

5.10 Subdivision 1. **Well notification fee.** The well notification fee to be paid by a property

5.13 fee;

5.14 (2) for a well sealing, \$75 for each well or temporary boring, which includes the state
5.15 core function fee, except that: (i) a single notification and fee of \$75 is required for all
5.16 temporary environmental wells recorded on the sealing notification for borings on a single
5.17 property, having depths within a 25-foot range, and sealed within 72 hours of start of
5.18 construction; and (ii) temporary borings less than 25 feet in depth are exempt from the
5.19 notification and fee requirements in this chapter;
