2.1 **501C.0402 REQUIREMENTS FOR CREATION.**

2.2 (a) A trust is created only if:

2.3 (1) the settlor has capacity to transfer property free from trust, except that if a trust is
2.4 a revocable trust, the settlor has capacity as required under section 501C.0601;

2.5 (2) the settlor indicates an intention to create the trust;

2.6 (3) the trust has a definite beneficiary or is:

2.7 (i) a charitable trust;

2.8 (ii) trust for the care of an animal, as provided in section 501C.0408; or

2.9 ~~(ii)~~ (iii) a trust for a noncharitable purpose, as provided in section 501C.0409; and

2.10 (4) the trustee has duties to perform.

2.11 (b) A beneficiary is definite if the beneficiary can be ascertained now or in the

2.22 Subdivision 1. **Creation of an animal trust authorized; termination.** A trust
2.23 may be created to provide for the care of an animal alive during the settlor's lifetime.
2.24 The trust terminates upon the death of the animal or, if the trust was created to provide
2.25 for the care of more than one animal alive during the settlor's lifetime, upon the death of
2.26 the last surviving animal. Notwithstanding the foregoing, the trust may not be enforced
2.27 for more than 90 years.

2.28 Subd. 2. **Enforcement of trust.** A trust authorized by this section may be enforced
2.29 by a person appointed in the terms of the trust or, if no person is appointed, by a person
2.30 appointed by a court. A person having an interest in the welfare of the animal may request
2.31 the court to appoint a person to enforce the trust or to remove an appointed person.

2.32 Subd. 3. **Application of trust property.** Property of a trust authorized by this
2.33 section may be applied only to its intended use, except to the extent a court determines
2.34 that the value of the trust property exceeds the amount required for the intended use. Upon
2.35 termination of the trust, or if the court determines the trust has excess funds, the trustee

 3.13 ascertainable beneficiary or for a noncharitable but otherwise valid purpose to be selected

4.1 Subject to additional definitions contained in the subsequent articles which are

4.4 (1) "Adoptee" means an individual who is adopted.

4.5 (2) "Application" means a written request to the registrar for an order of informal
4.6 probate or appointment under article III, part 3.

4.7 (3) "Assisted reproduction" means a method of causing pregnancy other than sexual
4.8 intercourse.

4.9 (4) "Beneficiary," as it relates to trust beneficiaries, includes a person who has any

4.11 by assignment or other transfer and as it relates to a charitable trust, includes any person
4.12 entitled to enforce the trust.

4.13 (5) "Birth mother" means a woman who gives birth to a child, including a woman
4.14 who is the child's genetic mother and including a woman who gives birth to a child of
4.15 assisted reproduction. "Birth mother" does not include a woman who gives birth pursuant
4.16 to a gestational agreement.

4.17 (6) "Child" includes any individual entitled to take as a child under law by intestate
4.18 succession from the parent whose relationship is involved and excludes any person who is
4.19 only a stepchild, a foster child, a grandchild or any more remote descendant.

4.20 (7) "Child of assisted reproduction" means a child conceived by means of assisted
4.21 reproduction by a woman other than a child conceived pursuant to a gestational agreement.

4.22 (8) "Claims" includes liabilities of the decedent whether arising in contract or
4.23 otherwise and liabilities of the estate which arise after the death of the decedent including
4.24 funeral expenses and expenses of administration. The term does not include taxes, demands
4.25 or disputes regarding title of a decedent to specific assets alleged to be included in the
4.26 estate, tort claims, foreclosure of mechanic's liens, or to actions pursuant to section 573.02.

4.27 (9) "Court" means the court or branch having jurisdiction in matters relating to the
4.28 affairs of decedents. This court in this state is known as the district court.

4.29 (10) "Conservator" means a person who is appointed by a court to manage the
4.30 estate of a protected person.

4.31 (11) "Descendant" of an individual means all of the individual's descendants of all
4.32 generations, with the relationship of parent and child at each generation being determined
4.33 by the definition of child and parent contained in this section.

4.34 (12) "Devise," when used as a noun, means a testamentary disposition of real or
4.35 personal property and when used as a verb, means to dispose of real or personal property
4.36 by will.

5.1 (13) "Devisee" means any person designated in a will to receive a devise. In the case
5.2 of a devise to an existing trust or trustee, or to a trustee on trust described by will, the trust
5.3 or trustee is the devisee and the beneficiaries are not devisees.

5.4 (14) "Disability" means cause for appointment of a conservator as described in
5.5 section 524.5-401, or a protective order as described in section 524.5-412.

5.6 (15) "Distributee" means any person who has received or who will receive property
5.7 of a decedent from the decedent's personal representative other than as a creditor or
5.8 purchaser. A testamentary trustee is a distributee with respect to property which the trustee
5.9 has received from a personal representative only to the extent of distributed assets or their
5.10 increment remaining in the trustee's hands. A beneficiary of a testamentary trust to whom
5.11 the trustee has distributed property received from a personal representative is a distributee
5.12 of the personal representative. For purposes of this provision, "testamentary trustee"
5.13 includes a trustee to whom assets are transferred by will, to the extent of the devised assets.

5.14 (16) "Divorce" includes an annulment, dissolution, and declaration of invalidity of
5.15 marriage.

5.16 (17) "Estate" includes all of the property of the decedent, trust, or other person
5.17 whose affairs are subject to this chapter as originally constituted and as it exists from
5.18 time to time during administration.

5.19 (18) "Fiduciary" includes personal representative, guardian, conservator and trustee.

5.20 (19) "Foreign personal representative" means a personal representative of another
5.21 jurisdiction.

5.22 (20) "Formal proceedings" means those conducted before a judge with notice to
5.23 interested persons.

5.24 (21) "Functioned as a parent of the child" means behaving toward a child in a manner
5.25 consistent with being the child's parent and performing functions that are customarily
5.26 performed by a parent, including fulfilling parental responsibilities toward the child,
5.27 recognizing or holding out the child as the individual's child, materially participating in
5.28 the child's upbringing, and residing with the child in the same household as a regular
5.29 member of that household.

5.30 (22) "Genetic father" means the man whose sperm fertilized the egg of a child's
5.31 genetic mother. If the father-child relationship is established under the presumption
5.32 of paternity under chapter 257, "genetic father" means only the man for whom that
5.33 relationship is established.

5.34 (23) "Genetic mother" means the woman whose egg was fertilized by the sperm
5.35 of a child's genetic father.

5.36 (24) "Genetic parent" means a child's genetic father or genetic mother.

6.2 a woman agrees to carry a child to birth for an intended parent or intended parents.

6.3 (26) "Governing instrument" means a deed; will; trust; insurance or annuity policy;
