Bill Description

H.F. 1233 makes changes to Minnesota Statutes 241.021 regarding the licensing and supervision of facilities.

Sections 1 & 2: Make technical and conforming changes.

Section 3: Adds a subdivision that prohibits the commissioner from granting a license to any county, municipality, or agency to operate a facility for the detention, care, and training of delinquent children and youth unless the county, municipality, or agency institutes a policy strictly prohibiting the visual inspection of breasts, buttocks, or genitals or children and youth received by the facility except during a health care procedure conducted by a medically licensed person.

Section 4: Adds a subdivision that prohibits the commissioner from granting a license to any county, municipality, or agency to operate a facility for the detention, care, and training of delinquent children and youth unless the county, municipality, or agency institutes a policy strictly prohibiting the use of disciplinary room time for children and youth received by the facility.

Assumptions

The Department of Corrections assumes that (1) there are no new criminal penalties or penalty enhancements in the bill;(2) there would be no impact on the number of state prison beds of supervision caseloads statewide; and (3) the additional review needed before granting a license to correctional facilities for the detention, care, and training of delinquent children and youth will be provided by existing staff.
