Bill Description

This bill would establish a comprehensive school mental health services lead at the Minnesota Department of Education (MDE). The purpose of this position would be to work with districts to implement comprehensive school mental health services. MDE would coordinate with other agencies to develop resources, maintain a list of best practices, and provide training and technical assistance through the MDE website and school site visits.

Assumptions

One FTE (Education Specialist II) would be required to implement this bill (Lead position). The lead will serve as the cross-agency spokesperson, manage the delivery of direct supports to schools and charters, and serve as the primary liaison to school leaders and counselors on best practices in school based mental health services. This position would utilize the nationally recognized School Health and Performance Evaluation System, or the SHAPE System, to help schools measure the quality and sustainability of their mental health programs as well as their level of trauma responsiveness. This person, in collaboration with other MDE staff will coordinate delivery of resource and training materials in print and online, maintain best practices information and coordinate registration for trainings, both in person and online. Budget includes funding for trainer fees to conduct a train-the-trainer in Minnesota on the SHAPE System and accompanying curriculum, as well as contracts to develop and maintain a train-the-trainer network. This network would provide training and technical assistance to schools regionally. Budget also includes funds for supplies and room rental for regional trainings. Significant travel will be required and reflected in the budget.
