## **Bill Description**

This bill contains technical language modifications to the provisions for permitting of Eurasian Wild pigs and their hybrids (restricted species).

#### **Assumptions**

The Minnesota Department of Agriculture (MDA) currently only has one permitted operation for Eurasian Wild Boar, which is the Minnesota Zoo. Other operations that were previously permitted are out of business. The MDA does not expect to need to permit other operations and as a result, expects to have no financial impact to these changes.
