2.5 Subdivision 1. **Description.** Effective July 1, 1959, the state is divided into ten judicial

2.7 judges shall be chosen as hereinafter specified:

2.8 1. Goodhue, Dakota, Carver, Le Sueur, McLeod, Scott, and Sibley; 36 judges; and four

2.10 and one other shall be maintained at the place designated by the chief judge of the district;
