

## WHAT IS A MAGNET SCHOOL?


#### Magnet schools:

- Administered by local public school districts;
- Have a specialized curriculum or theme;
- Attract students from different racial, ethnic, and socioeconomic backgrounds;
- Provide parents with choices for their child's education within the public school system.1

### MAGNET SCHOOL FUNDING

Finding resources to operate specialized theme-based magnet programs can be a challenge for school districts. Magnet schools are generally funded with local dollars, and a small number of states provide additional support. The federal government also plays a role by awarding competitive grants through the Magnet Schools Assistance Program.<sup>1</sup>

Magnet schools need continued support at the federal, state and local levels. With sustained – and increased – funding, they can continue to provide high-quality public education to more students.1
