1.4 Subdivision 1. **Policy requirements.** No individual or group policy, certificate, subscriber
1.5 contract issued by a health service plan corporation regulated under chapter 62C, or other
1.6 evidence of accident and health insurance the effect or purpose of which is to supplement
1.7 Medicare coverage, including to supplement coverage under Medicare Advantage plans
1.8 established under Medicare Part C, issued or delivered in this state or offered to a resident
1.9 of this state shall be sold or issued to an individual covered by Medicare unless the
1.10 requirements in subdivisions 1a to ~~1v~~ 1w are met.

1.11 Sec. 2. Minnesota Statutes 2022, section 62A.31, subdivision 1f, is amended to read:

1.12 Subd. 1f. **Suspension based on entitlement to medical assistance.** (a) The policy or
1.13 certificate must provide that benefits and premiums under the policy or certificate shall be
1.14 suspended for any period that may be provided by federal regulation at the request of the
1.15 policyholder or certificate holder for the period, not to exceed 24 months, in which the
1.16 policyholder or certificate holder has applied for and is determined to be entitled to medical
1.17 assistance under title XIX of the Social Security Act, but only if the policyholder or certificate
1.18 holder notifies the issuer of the policy or certificate within 90 days after the date the
1.19 individual becomes entitled to this assistance.

1.20 (b) If suspension occurs and if the policyholder or certificate holder loses entitlement
1.21 to this medical assistance, the policy or certificate shall be automatically reinstated, effective
1.22 as of the date of termination of this entitlement, if the policyholder or certificate holder
1.23 provides notice of loss of the entitlement within 90 days after the date of the loss and pays
1.24 the premium attributable to the period, effective as of the date of termination of entitlement.

2.1 (c) The policy must provide that upon reinstatement (1) there is no ~~additional~~ waiting
2.2 period with respect to treatment of preexisting conditions, (2) coverage is provided which
2.3 is substantially equivalent to coverage in effect before the date of the suspension. If the
2.4 suspended policy provided coverage for outpatient prescription drugs, reinstatement of the
2.5 policy for Medicare Part D enrollees must be without coverage for outpatient prescription
2.6 drugs and must otherwise provide coverage substantially equivalent to the coverage in effect
2.7 before the date of suspension, and (3) premiums are classified on terms that are at least as
2.8 favorable to the policyholder or certificate holder as the premium classification terms that

2.11 Subd. 1h. **Limitations on denials, conditions, and pricing of coverage.** No health
2.12 carrier issuing Medicare-related coverage in this state may impose preexisting condition
2.13 limitations or otherwise deny or condition the issuance or effectiveness of any such coverage
2.14 available for sale in this state, nor may it discriminate in the pricing of such coverage,
2.15 because of the health status, claims experience, receipt of health care, medical condition,
2.16 or age of an applicant where an application for such coverage is submitted: (1) prior to or
2.17 during the six-month period beginning with the first day of the month in which an individual
2.18 first enrolled for benefits under Medicare Part B; or (2) during the open enrollment period.
2.19 This subdivision applies to each Medicare-related coverage offered by a health carrier
2.20 regardless of whether the individual has attained the age of 65 years. If an individual who
2.21 is enrolled in Medicare Part B due to disability status is involuntarily disenrolled due to loss
2.22 of disability status, the individual is eligible for another six-month enrollment period provided
2.23 under this subdivision beginning the first day of the month in which the individual later
2.24 becomes eligible for and enrolls again in Medicare Part B and during the open enrollment
2.25 period. An individual who is or was previously enrolled in Medicare Part B due to disability
2.26 status is eligible for another six-month enrollment period under this subdivision beginning
2.27 the first day of the month in which the individual has attained the age of 65 years and either
2.28 maintains enrollment in, or enrolls again in, Medicare Part B and during the open enrollment
2.29 period. If an individual enrolled in Medicare Part B voluntarily disenrolls from Medicare
2.30 Part B because the individual becomes enrolled under an employee welfare benefit plan,
2.31 the individual is eligible for another six-month enrollment period, as provided in this
2.32 subdivision, beginning the first day of the month in which the individual later becomes
2.33 eligible for and enrolls again in Medicare Part B and during the open enrollment period.

3.2 Subd. 1p. **Renewal or continuation provisions.** Medicare supplement policies and
3.3 certificates shall include a renewal or continuation provision. The language or specifications
3.4 of the provision shall be consistent with the type of contract issued. The provision shall be
3.5 appropriately captioned and shall appear on the first page of the policy or certificate, and
3.6 shall include any reservation by the issuer of the right to change premiums. Except for riders
3.7 or endorsements by which the issuer effectuates a request made in writing by the insured,
3.8 exercises a specifically reserved right under a Medicare supplement policy or certificate,
3.9 or is required to reduce or eliminate benefits to avoid duplication of Medicare benefits, all
3.10 riders or endorsements added to a Medicare supplement policy or certificate after the date
3.11 of issue or at reinstatement or renewal that reduce or eliminate benefits or coverage in the
3.12 policy or certificate shall require a signed acceptance by the insured. After the date of policy
3.13 or certificate issue, a rider or endorsement that increases benefits or coverage with a
3.14 concomitant increase in premium during the policy or certificate term shall be agreed to in
3.15 writing and signed by the insured, unless the benefits are required by the minimum standards

3.17 law. ~~Where a separate additional premium is charged for benefits provided in connection
3.18 with riders or endorsements, the premium charge shall be set forth in the policy, declaration
3.19 page, or certificate. If a Medicare supplement policy or certificate contains limitations with
3.20 respect to preexisting conditions, the limitations shall appear as a separate paragraph of the
3.21 policy or certificate and be labeled as "preexisting condition limitations."~~

3.22 Issuers of accident and sickness policies or certificates that provide hospital or medical
3.23 expense coverage on an expense incurred or indemnity basis to persons eligible for Medicare
3.24 shall provide to those applicants a "Guide to Health Insurance for People with Medicare"
3.25 in the form developed by the Centers for Medicare and Medicaid Services and in a type
3.26 size no smaller than 12-point type. Delivery of the guide must be made whether or not such
3.27 policies or certificates are advertised, solicited, or issued as Medicare supplement policies

4.2 Subd. 1u. **Guaranteed issue for eligible persons.** (a)(1) Eligible persons are those
4.3 individuals described in paragraph (b) who seek to enroll under the policy during the period
4.4 specified in paragraph (c) and who submit evidence of the date of termination or
4.5 disenrollment described in paragraph (b), or of the date of Medicare Part D enrollment, with
4.6 the application for a Medicare supplement policy.

4.7 (2) With respect to eligible persons, an issuer shall not: deny or condition the issuance
4.8 or effectiveness of a Medicare supplement policy described in paragraph (c) that is offered
4.9 and is available for issuance to new enrollees by the issuer; discriminate in the pricing of
4.10 such a Medicare supplement policy because of health status, claims experience, receipt of
4.11 health care, medical condition, or age; or impose an exclusion of benefits based upon a
4.12 preexisting condition under such a Medicare supplement policy.

4.13 (b) An eligible person is an individual described in any of the following:

4.14 (1) the individual is enrolled under an employee welfare benefit plan that provides health
4.15 benefits that supplement the benefits under Medicare; and the plan terminates, or the plan
4.16 ceases to provide all such supplemental health benefits to the individual;

4.17 (2) the individual is enrolled with a Medicare Advantage organization under a Medicare
4.18 Advantage plan under Medicare Part C, and any of the following circumstances apply, or
4.19 the individual is 65 years of age or older and is enrolled with a Program of All-Inclusive
4.20 Care for the Elderly (PACE) provider under section 1894 of the federal Social Security Act,

5.8 (B) the organization, or agent or other entity acting on the organization's behalf, materially

5.12 (A) an eligible organization under a contract under section 1876 of the federal Social
5.13 Security Act, United States Code, title 42, section 1395mm (Medicare cost);

5.14 (B) a similar organization operating under demonstration project authority, effective for
5.15 periods before April 1, 1999;

5.16 (C) an organization under an agreement under section 1833(a)(1)(A) of the federal Social
5.17 Security Act, United States Code, title 42, section 1395l(a)(1)(A) (health care prepayment
5.18 plan); or

5.19 (D) an organization under a Medicare Select policy under section 62A.318 or the similar
5.20 law of another state; and

5.21 (ii) the enrollment ceases under the same circumstances that would permit discontinuance
5.22 of an individual's election of coverage under clause (2);

5.23 (4) the individual is enrolled under a Medicare supplement policy, and the enrollment
5.24 ceases because:

5.25 (i)(A) of the insolvency of the issuer or bankruptcy of the nonissuer organization; or

5.26 (B) of other involuntary termination of coverage or enrollment under the policy;

5.27 (ii) the issuer of the policy substantially violated a material provision of the policy; or

5.30 (5)(i) the individual was enrolled under a Medicare supplement policy and terminates

6.18 outpatient prescription drugs and the individual terminates enrollment in the Medicare

6.21 (c)(1) In the case of an individual described in paragraph (b), clause (1), the guaranteed
6.22 issue period begins on the later of: (i) the date the individual receives a notice of termination
6.23 or cessation of all supplemental health benefits or, if a notice is not received, notice that a
6.24 claim has been denied because of a termination or cessation; or (ii) the date that the applicable
6.25 coverage terminates or ceases; and ends 63 days after the later of those two dates.

6.26 (2) In the case of an individual described in paragraph (b), clause (2), (3), (5), or (6),
6.27 whose enrollment is terminated involuntarily, the guaranteed issue period begins on the
6.28 date that the individual receives a notice of termination and ends 63 days after the date the
6.29 applicable coverage is terminated.

6.30 (3) In the case of an individual described in paragraph (b), clause (4), item (i), the
6.31 guaranteed issue period begins on the earlier of: (i) the date that the individual receives a
6.32 notice of termination, a notice of the issuer's bankruptcy or insolvency, or other such similar
6.33 notice if any; and (ii) the date that the applicable coverage is terminated, and ends on the
6.34 date that is 63 days after the date the coverage is terminated.

7.1 (4) In the case of an individual described in paragraph (b), clause (2), (4), (5), or (6),
7.2 who disenrolls voluntarily, the guaranteed issue period begins on the date that is 60 days
7.3 before the effective date of the disenrollment and ends on the date that is 63 days after the
7.4 effective date.

7.5 (5) In the case of an individual described in paragraph (b), clause (7), the guaranteed
7.6 issue period begins on the date the individual receives notice pursuant to section
7.7 1882(v)(2)(B) of the Social Security Act from the Medicare supplement issuer during the
7.8 60-day period immediately preceding the initial Part D enrollment period and ends on the
7.9 date that is 63 days after the effective date of the individual's coverage under Medicare Part
7.10 D.

7.11 (6) In the case of an individual described in paragraph (b) but not described in this
7.12 paragraph, the guaranteed issue period begins on the effective date of disenrollment and
7.13 ends on the date that is 63 days after the effective date.

7.14 (7) For all individuals described in paragraph (b), the open enrollment period is a
7.15 guarantee issue period.

7.16 (d)(1) In the case of an individual described in paragraph (b), clause (5), or deemed to
7.17 be so described, pursuant to this paragraph, whose enrollment with an organization or
7.18 provider described in paragraph (b), clause (5), item (i), is involuntarily terminated within
7.19 the first 12 months of enrollment, and who, without an intervening enrollment, enrolls with
7.20 another such organization or provider, the subsequent enrollment is deemed to be an initial
7.21 enrollment described in paragraph (b), clause (5).

7.22 (2) In the case of an individual described in paragraph (b), clause (6), or deemed to be
7.23 so described, pursuant to this paragraph, whose enrollment with a plan or in a program
7.24 described in paragraph (b), clause (6), is involuntarily terminated within the first 12 months
7.25 of enrollment, and who, without an intervening enrollment, enrolls in another such plan or
7.26 program, the subsequent enrollment is deemed to be an initial enrollment described in

7.28 (3) For purposes of paragraph (b), clauses (5) and (6), no enrollment of an individual
7.29 with an organization or provider described in paragraph (b), clause (5), item (i), or with a
7.30 plan or in a program described in paragraph (b), clause (6), may be deemed to be an initial
7.31 enrollment under this paragraph after the two-year period beginning on the date on which
7.32 the individual first enrolled with the organization, provider, plan, or program.

7.33 (e) The Medicare supplement policy to which eligible persons are entitled under:

8.1 (1) paragraph (b), clauses (1) to (4), is any Medicare supplement policy that has a benefit
8.2 package consisting of the basic Medicare supplement plan described in section 62A.316,
8.3 paragraph (a), plus any combination of the three optional riders described in section 62A.316,
8.4 paragraph (b), clauses (1) to (3), offered by any issuer;

8.5 (2) paragraph (b), clause (5), is the same Medicare supplement policy in which the
8.6 individual was most recently previously enrolled, if available from the same issuer, or, if
8.7 not so available, any policy described in clause (1) offered by any issuer, except that after
8.8 December 31, 2005, if the individual was most recently enrolled in a Medicare supplement
8.9 policy with an outpatient prescription drug benefit, a Medicare supplement policy to which
8.10 the individual is entitled under paragraph (b), clause (5), is:

8.11 (i) the policy available from the same issuer but modified to remove outpatient
8.12 prescription drug coverage; or

8.13 (ii) at the election of the policyholder, a policy described in clause (4), except that the

8.29 the organization that terminates the contract or agreement, the issuer terminating the policy,
8.30 or the administrator of the plan being terminated, respectively, shall notify the individual
8.31 of the individual's rights under this subdivision, and of the obligations of issuers of Medicare
8.32 supplement policies under paragraph (a). The notice must be communicated
8.33 contemporaneously with the notification of termination.

9.1 (2) At the time of an event described in paragraph (b), because of which an individual
9.2 ceases enrollment under a contract or agreement, policy, or plan, the organization that offers

9.12 or limit, the individual's rights under subdivision 1h.

9.18 Subd. 4. **Prohibited policy provisions.** (a) A Medicare supplement policy or certificate
9.19 in force in the state shall not contain benefits that duplicate benefits provided by Medicare
9.20 or contain exclusions on coverage that are more restrictive than those of Medicare.
9.21 Duplication of benefits is permitted to the extent permitted under subdivision 1s, paragraph

10.3 to elicit information as to whether, as of the date of the application, the applicant has another
10.4 Medicare supplement or other health insurance policy or certificate in force or whether a
10.5 Medicare supplement policy or certificate is intended to replace any other accident and
10.6 sickness policy or certificate presently in force. A supplementary application or other form
10.7 to be signed by the applicant and agent containing the questions and statements may be
10.8 used.

10.9 "(1) You do not need more than one Medicare supplement policy or certificate.

10.10 (2) If you purchase this policy, you may want to evaluate your existing health coverage
10.11 and decide if you need multiple coverages.

10.12 (3) You may be eligible for benefits under Medicaid and may not need a Medicare
10.13 supplement policy or certificate.

10.14 (4) The benefits and premiums under your Medicare supplement policy or certificate

11.10 form, signed by the applicant, and acknowledged by the insurer, shall be returned to the
11.11 applicant by the insurer on delivery of the policy or certificate.

11.12 (d) Upon determining that a sale will involve replacement of Medicare supplement
11.13 coverage, any issuer, other than a direct response issuer, or its agent, shall furnish the
11.14 applicant, before issuance or delivery of the Medicare supplement policy or certificate, a
11.15 notice regarding replacement of Medicare supplement coverage. One copy of the notice
11.16 signed by the applicant and the agent, except where the coverage is sold without an agent,
11.17 shall be provided to the applicant and an additional signed copy shall be retained by the
11.18 issuer. A direct response issuer shall deliver to the applicant at the time of the issuance of
