

Good afternoon Honorable Chair Heintzeman and Committee members. Thank you for your time today.

If you get outdoors in Minnesota in the spring, summer, or fall, you will notice the thousands of lakes and rivers, parks, trails, recreation areas, forests, campgrounds, resorts, wildlife areas, beaches, and picnic areas enjoyed by the public, and managed and protected by state agencies, with help from local governments, lake associations, and NGOs.

If you are fortunate enough to enjoy overnight stays on state waters and in state parks in an RV, a houseboat, or another shelter of your choosing, you are required to follow rules for where and how to set up camp, and how to manage your garbage and waste. **In a nutshell, your shared outdoor experience is a privilege, and protecting it for future generations is required.**

Not so for Minnesotans in the ice belt. Since the popularity of ice fishing, winter camping, and recreation has exploded in the last decade, the Keep it Clean Coalition has seen an increase in leftovers of human activity on and around frozen public waters. Volunteers have worked tirelessly to bring awareness to a problem that should not exist and help our fellow humans change their attitudes and careless habits. We have a new **"litter on ice" law**. That's a start, but it's not enough.

The State invests our tax dollars to make public places more enjoyable and accessible. Minnesota's economy is strongly reliant on people getting out more, and there is an expectation that users, through fees and taxes, share the costs. Nothing is free in this world.

We believe that rather than go into hibernation (leaving the management of human leftovers and cleanup efforts to local communities), state agencies must take the lead in educating the public, providing resources, and implementing the same regulations for **activities on ice** as they do for public lands and waters during **ice-out activities**.

You would never leave your bags of trash or camp toilet leftovers to pollute campsites, parks or trails. You would never accept human or pet excrement on your picnic grounds. We all pay dearly to use state lands and waters and are proud to be good stewards.

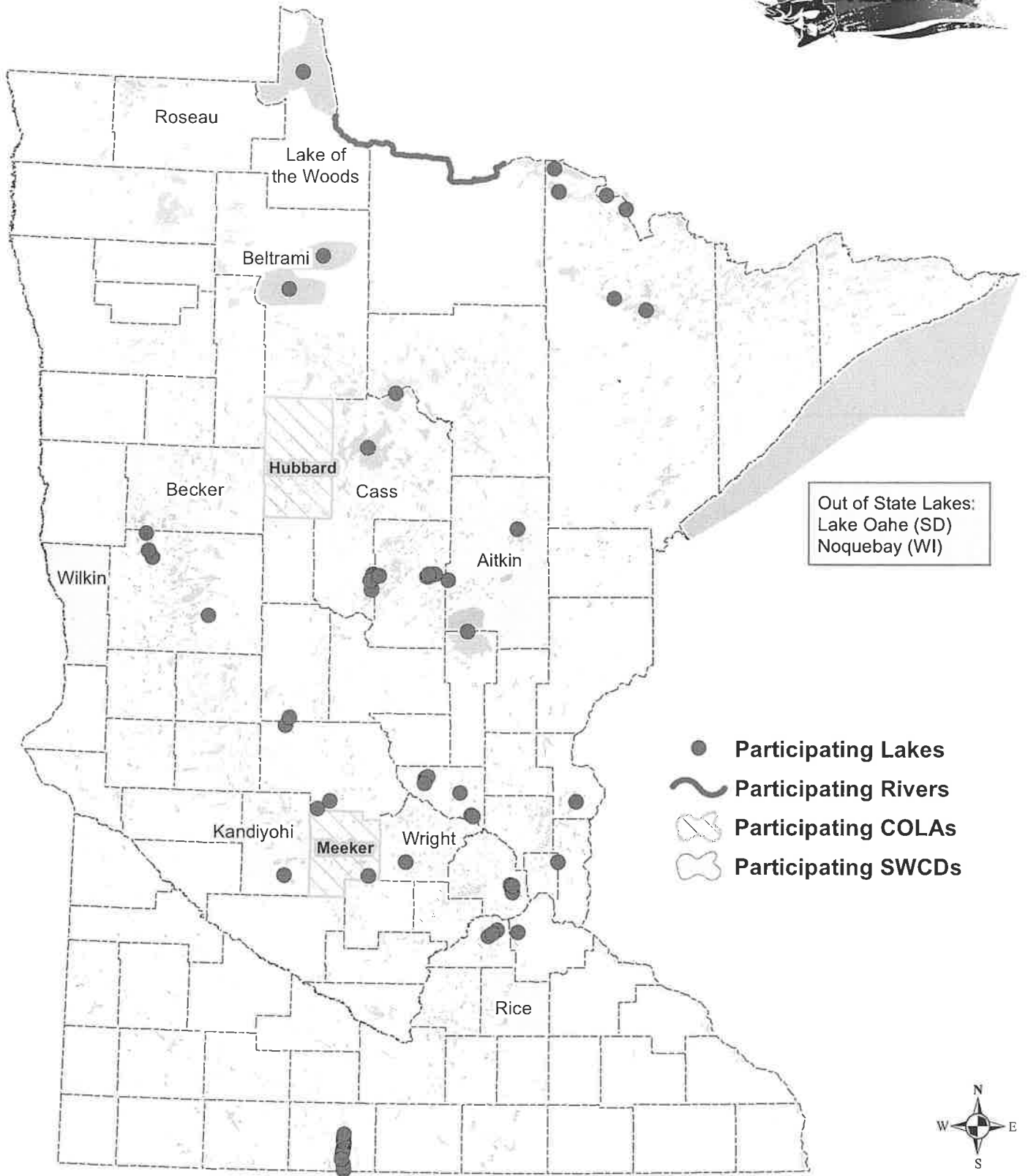
I am asking respected house members to extend management and protection of our shared resources to the ice belt. The disconnect needs to be fixed. We can't manage and protect our natural resources three seasons of the year while disregarding what goes on during winter months on our frozen waters. We must acknowledge that people travel to enjoy winter experiences, and then stay for extended amounts of time, far from our homes and our constituencies, to have unique outdoor experiences that are ingrained in Minnesota's constitution.

Please support **HF1120** and establish a **Statewide Keep it Clean Program** ensuring the professional management and community resources needed to protect and preserve Minnesota's prized public waters. **Ice is water and we must work together to keep it clean.**

Chair Heintzeman and Members of the House Environment Committee:

Conservation Minnesota urges your support for HF1120 (Myers), which would establish a Keep It Clean grant program to help protect Minnesota's rivers and lakes from winter litter and waste. This program will play a crucial role in preserving our many public waters across the state.

We are fortunate in Minnesota to be home to some of the most pristine lakes and rivers in the country, and to offer year-round outdoor recreation opportunities. In the winter months, many Minnesotans enjoy activities like ice fishing and will set up wheelhouses and other temporary shelter on the frozen water. The state has seen a major uptick in these winter activities, but with this comes an increase in leftover trash, refuse and even human waste, which is harmful to aquatic species and habitats.

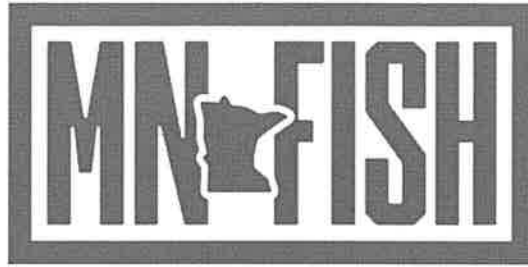
In 2023, this legislature passed the Keep it Clean Law, which prohibits leaving garbage and human waste on or under the ice of our lakes and rivers. HF1120 (Myers) builds on this work by enlisting BWSR and MPCA to administer grants for local water protection programs. These grants will support local units of government and non-government organizations in adding and updating facilities, expanding winter and spring cleanup services, and increasing overall enforcement of the Keep It Clean law.

Enabling LGUs and NGOs to implement the Keep It Clean rule with state funding ensures we have the tools available to make sure our public waters can be enjoyed by all for generations. Winter recreation is a Minnesota tradition that we must preserve, but one we must also ask people to participate in responsibly and with respect for the water and environment. These grants will bring us closer to our goal of keeping our public waters clean and safe all year long.

We strongly encourage you to support HF1120 (Myers) and the establishment of a Keep It Clean grant program.

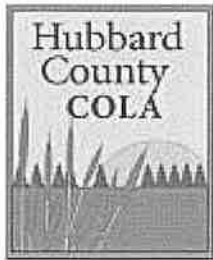

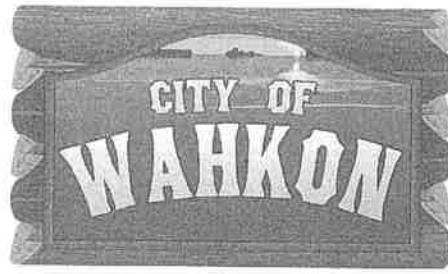



The Township Board is in full support of HF 1120, The Keep it Clean Bill.

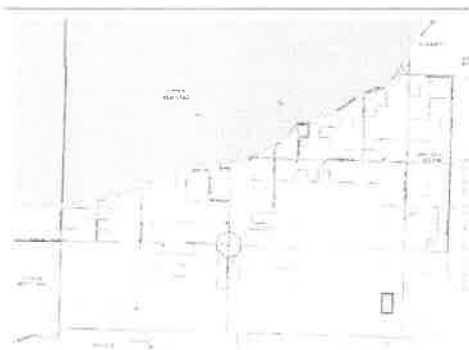

**KEEP IT CLEAN TESTIMONY**

**H. F. 1120, A bill for an act relating to natural resources; establishing Keep it Clean program; appropriating money; proposing coding for new law in Minnesota Statutes, chapter 97C.**

Good afternoon Honorable Chair Heintzeman and Committee members. Thank you for your time today.

As one of the founding members of the Keep It Clean efforts in 2012 on Lake of the Woods, the Lake of the Woods Soil and Water Conservation District Board of Supervisors considers this bill instrumental in addressing the trash and waste left on Minnesota lakes. The bill will provide state agency leadership for local efforts and funding to address local needs throughout the state.

There are obvious gaps in state agency management of garbage and trash on public waters during the winter. This gap was created by a shift in recreation that has changed the way the public utilizes their public waters. The recognition of this gap of management was the genesis for the creation of the Keep It Clean Initiative. Local efforts started on Lake of the Woods in 2012. In 2022, other lakes including Red Lake and Mille Lacs joined the Keep It Clean Initiative. Since 2022, a coalition has formed to address this issue. This coalition includes over 60 members representing soil and water conservation districts, lake associations, chain of lake associations, foundations, tourism bureaus/chamber of commerce, lake improvement districts, and others. Membership ranges from Lake of the Woods in the north to the Fairmont Chain of Lakes in the south. This is a statewide issue. Which is why state agency leadership is needed.

Under this legislation these local efforts will continue. Local efforts often can be more reactive than state agencies. State agencies have been very supportive of Keep It Clean efforts, but without this legislation, agencies are unable to fully address this increasing problem without the support and direction from the legislature.

You can protect our waters with this simple piece of legislation that makes this issue a priority for state agencies to actively address.

Mr. Chair and members of the committee,

Clean Water Action was founded in 1972 with a mission to protect the land we live on, the air we breathe, and the water we drink. Representing tens of thousands of Minnesotans, we urge your support for HF1120 (Myers), the **"Keep it Clean"** bill which is a commonsense solution to a persistent problem.

Minnesotans take great pride in our pristine natural spaces and recreational activities, especially those on and around our waterways. Unfortunately, some individuals fail to clean up after themselves, particularly during winter activities like ice fishing.

The Minnesota Pollution Control Agency (MPCA) estimates that **160,000 pounds of trash enter our waterways annually** as ice thaws, with plastic waste making up nearly a third of that total. Research from Macalester College and Friends of the Mississippi River further highlights the problem, showing an average of **four pieces of trash per 10' x 10' square** in tested metro-area lakes. As this waste breaks down, it releases **microplastics and chemicals**, which infiltrate our environment, harm aquatic life, and contaminate the food and water sources many Minnesotans depend on.

The growing prevalence of microplastics is alarming. Studies estimate that the average person now ingests large amounts of plastic each year. One study by the World Wildlife Fund estimates a person consumes an average of **five grams of microplastics per week**, this is the weight of a **credit card**. Another study out of the University of Newcastle estimates people consume up to 250 grams of microplastics in a year. Microplastics, which are full of toxic chemicals, are found in human and animal sperm, brain matter, placenta, saliva, liver, and kidney tissue. Addressing this crisis requires immediate action.

Outdoor recreation, including ice fishing, has evolved, with larger, more modern ice houses becoming increasingly popular. While these structures enhance comfort, they also bring **greater responsibility** to prevent trash, plastic, and human biowaste from polluting our waters.

The 2023 **Keep It Clean** law made it illegal to dump waste on the ice, but enforcement challenges remain. **HF1120 (Myers) strengthens these efforts by expanding jurisdictional authority, providing municipal grant funding, and ensuring the necessary resources are in place to keep our waters clean.**

We strongly support this legislation and urge the committee to pass **HF1120 (Myers)**. Thank you for your time and consideration.

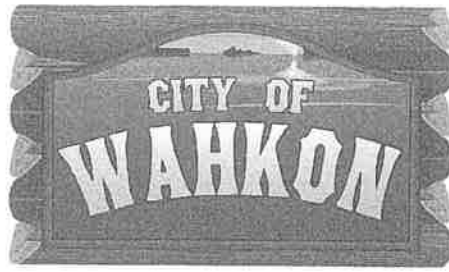
