1.3 "Sec. 9. Minnesota Statutes 2022, section 171.07, subdivision 4, is amended to read:

1.4 Subd. 4. **Identification card expiration.** (a) Except as otherwise provided in this  
1.5 subdivision, the expiration date of a Minnesota identification card is the birthday of the  
1.6 applicant in the fourth year following the date of issuance of the card.

1.7 (b) For an applicant age 65 or older:

1.8 (1) the expiration date of a Minnesota identification card is the birthday of the applicant  
1.9 in the eighth year following the date of issuance of the card; or

1.10 (2) a noncompliant identification card is valid for the lifetime of the applicant.

1.11 (c) For the purposes of paragraph (b), "Minnesota identification card" does not include  
1.12 an enhanced identification card issued to an applicant age 65 or older.

1.13 (d) The expiration date for an Under-21 identification card is the cardholder's 21st  
1.14 birthday. The commissioner shall issue an identification card to a holder of an Under-21  
1.15 identification card who applies for the card, pays the required fee, and presents proof of  
1.16 identity and age, unless the commissioner determines that the applicant is not qualified for  
1.17 the identification card.

1.18 (e) Notwithstanding paragraphs (a) to (d), the expiration date for an identification card  
1.19 issued to a person with temporary lawful status is the last day of the person's legal stay in  
1.20 the United States, or one year after issuance if the last day of the person's legal stay is not  
1.21 identified.

1.22 (f) Notwithstanding paragraphs (a) to (d), the expiration date for a noncompliant  
1.23 identification card is the earlier of the birthday of the applicant in the second year following

2.1 the date of issuance of the card or as provided in paragraph (d), if the identification card is  
2.2 issued under any of the following circumstances:

2.3 (1) the application is for first-time issuance of a Minnesota identification card, and the  
2.4 applicant has not demonstrated United States citizenship or lawful presence in the United  
2.5 States; or

2.6 (2) the applicant's most recently issued license or identification card has an expiration  
2.7 date established under this paragraph or section 171.27, subdivision 1, paragraph (e), and  
2.8 the applicant has not demonstrated United States citizenship or lawful presence in the United  
2.9 States.

2.10 Sec. 10. Minnesota Statutes 2022, section 171.27, subdivision 1, is amended to read:

2.11 Subdivision 1. **Expiration.** (a) Except as otherwise provided in this section, the expiration  
2.12 date for each driver's license is the birthday of the driver in the fourth year following the  
2.13 date of issuance of the license. The birthday of the driver shall be as indicated on the  
2.14 application for a driver's license. A license may be renewed on or before expiration or within  
2.15 one year after expiration upon application, payment of the required fee, and passing the  
2.16 examination required of all drivers for renewal. Driving privileges shall be extended or  
2.17 renewed on or preceding the expiration date of an existing driver's license unless the  
2.18 commissioner believes that the licensee is no longer qualified as a driver.

2.19 (b) The expiration date for each under-21 license shall be the 21st birthday of the licensee.  
2.20 Upon the licensee attaining the age of 21 and upon the application, payment of the required  
2.21 fee, and passing the examination required of all drivers for renewal, a driver's license shall  
2.22 be issued unless the commissioner determines that the licensee is no longer qualified as a  
2.23 driver.

2.24 (c) The expiration date for each provisional license is two years after the date of  
2.25 application for the provisional license.

2.26 (d) Notwithstanding paragraphs (a) to (c), the expiration date for a license issued to a  
2.27 person with temporary lawful status is the last day of the person's legal stay in the United  
2.28 States, or one year after issuance if the last day of the person's legal stay is not identified.

2.29 (e) Notwithstanding paragraphs (a) to (b), the expiration date for a noncompliant license  
2.30 is the earlier of the birthday of the applicant in the second year following the date of issuance  
2.31 of the license or as provided in paragraph (b), if the identification card is issued under any  
2.32 of the following circumstances:

3.1 (1) the application is for first-time issuance of a license in Minnesota, and the applicant  
3.2 has not demonstrated United States citizenship or lawful presence in the United States; or

3.3 (2) the applicant's most recently issued license or identification card has an expiration  
3.4 date established under this paragraph or section 171.07, subdivision 4, paragraph (f), and  
3.5 the applicant has not demonstrated United States citizenship or lawful presence in the United  
3.6 States."
