1.3 Page 474, after line 26, insert:

1.4 **"(a) Services for Persons with Intellectual**
1.5 **and Development Disabilities. (1) \$143,000**
1.6 **in fiscal year 2022 and \$143,000 in fiscal year**
1.7 **2023 are appropriated from the general fund**
1.8 **to the commissioner of human services for a**
1.9 **grant to an organization governed by people**
1.10 **with intellectual and developmental disabilities**
1.11 **and administering a statewide network of**
1.12 **disability groups to maintain and promote**
1.13 **self-advocacy services and supports for**
1.14 **persons with intellectual and developmental**
1.15 **disabilities throughout the state. Grant money**
1.16 **must be used for the following purposes:**
1.17 **(i) to train and support a statewide network of**
1.18 **peer-to-peer mentors for people with**
1.19 **developmental disabilities. The peer-to-peer**
1.20 **mentors shall assist people with developmental**
1.21 **disabilities with choosing service options and**
1.22 **learning advocacy skills necessary for them**
1.23 **to be fully included in their communities.**
1.24 **Grant money must also be used to develop and**
1.25 **deliver curriculum to the network of**
1.26 **peer-to-peer mentors;**

2.1 (ii) to provide outreach activities to people
2.2 with developmental disabilities, including
2.3 statewide conferences and disability
2.4 networking opportunities focused on
2.5 self-advocacy, making informed choices, and
2.6 community engagement skills;

2.7 (iii) to provide an annual leadership program
2.8 for persons with intellectual and
2.9 developmental disabilities; and

2.10 (iv) to pay for administrative and general
2.11 operating costs associated with managing and
2.12 maintaining facilities, program delivery,
2.13 evaluation, staff, and technology.

2.14 (2) \$105,000 in fiscal year 2022 and \$105,000
2.15 in fiscal year 2023 are appropriated from the
2.16 general fund to the commissioner of human
2.17 services for a grant to an organization
2.18 governed by people with intellectual and
2.19 developmental disabilities and administering
2.20 a statewide network of disability groups to be
2.21 used for subgrants to organizations in
2.22 Minnesota to conduct outreach to persons
2.23 working and living in institutional settings to
2.24 provide education and information about
2.25 community options. Grant money must be
2.26 used to deliver peer-led skill training sessions
2.27 in six regions of the state to help people with
2.28 intellectual and developmental disabilities
2.29 understand community service options related
2.30 to:
