 - HF575 (Huot): Notary publics authorized to perform civil marriages.
 - HF702 (Becker-Finn): Cities and towns allowed to require additional licensing for hotels
 - <u>HF1350 (Bolden)</u>: Cities of the first class provided authority to impose ordinances on land or fee dedication on permit applications.
 - <u>HF1359 (Freiberg)</u>: Towns and political subdivision authorized to established inflow and infiltration prevention programs and make loans or grants to property owners
 - **HF1863 (Long):** Major political party permitted to file petition to prevent improper designation by candidates name on official ballot.
- 4. HF2577 (Schultz): State forecast required to include inflation rate.
- 5. <u>HF2545 (Lee)</u>: Legislative Coordinating Commission funding provided for translation services, and money appropriated.
