# Our Customers

- 3.1 million individual income tax filers
- Over 800,000 property tax refund filers
- 87 counties and over 800 licensed property tax assessors
- More than 500,000 businesses
- Over 370,000 sales tax filers



## Administering Minnesota's Tax Code

The Minnesota Department of Revenue helps Minnesota taxpayers understand and meet their obligations under the law.

We received more than 6 million payments, issued approximately 3.5 million tax refunds, and collected more than \$33 billion in tax revenue across all divisions in 2021.

We consult and confer with the governor regarding taxation, and recommend to the legislature appropriate changes in law necessary to carry out the mission and improve the performance of the department.



## **Delivering for Minnesotans**

- Processed more than 6.3 million unique tax returns.
- Adjusted nearly 540,000 tax returns impacted by changes made to the treatment of Unemployment Insurance compensation and/or Paycheck Protection Program loan forgiveness, issuing over \$300 million in the form of refunds or a reduction in taxes.
- Issued more than one million direct payments, totaling \$500 million, to Minnesotans who worked on the frontlines during the COVID-19 pandemic.
- Implemented cost savings in operational areas across the agency through centralization of common administrative services and supplies.
- Continued working with taxpayers experiencing financial hardship and who are concerned about paying tax debt or other agency debt to discuss available options.

#### Outreach

- We established a new Office of Public Engagement, focused on building relationships with communities, with an emphasis on reaching underrepresented populations.
- We help our customers find free tax help through our Volunteer Income Tax Assistance program.

- Virtual Room and Audit Room offer a secure, online collaboration space for our customers to communicate with us and share information.

#### Return of In-Person Services

Our St. Paul office is back to its normal hours and services. Taxpayers can submit returns, make payments, and get tax forms and instructions at our service desk. We continue to follow the latest COVID-19 guidance from the Minnesota Department of Health.
