1.5 **HELP AMERICA VOTE ACT COMPLIANCE**

1.6 Section 1. [204C.135] PROVISIONAL BALLOTS.

1.7 Subdivision 1. Casting provisional ballots. (a) A voter who registered on election day  
1.8 pursuant to section 201.061, subdivision 3, is entitled to cast a provisional ballot.

1.9 (b) A voter seeking to cast a provisional ballot must sign a provisional ballot roster or  
1.10 a provisional voter signature certificate and complete the voter registration application on  
1.11 the provisional ballot envelope. The voter registration application may be completed by an  
1.12 electronic roster and affixed to the provisional ballot envelope. The voter must also swear  
1.13 or affirm in writing that the voter is eligible to vote, has not voted previously in the same  
1.14 election, and meets the criteria for registering to vote in the precinct in which the voter  
1.15 appears.

1.16 (c) Once the voter has completed the provisional ballot envelope, the voter must be  
1.17 allowed to cast a provisional ballot. The provisional ballot must be in the same form as the  
1.18 official ballot available in the precinct on election day. A completed provisional ballot shall  
1.19 be sealed in a secrecy envelope. The secrecy envelope shall be sealed inside the voter's  
1.20 provisional ballot envelope and deposited by the voter in a secure, sealed provisional ballot  
1.21 box. Completed provisional ballots must not be combined with other voted ballots in the  
1.22 polling place.

2.1 (d) The secretary of state must prescribe the form of the secrecy and provisional ballot  
2.2 envelopes. The provisional ballot envelope must be a color other than that provided for  
2.3 absentee ballot envelopes and must be prominently labeled "Provisional Ballot Envelope."

2.4 (e) Provisional ballots and related documentation shall be delivered to and securely  
2.5 maintained by the county auditor or municipal clerk in the same manner as required for  
2.6 other election materials under sections 204C.27 and 204C.28.

2.7 **Subd. 2. Accepting or rejecting provisional ballot envelopes; verified registrations.** (a)  
2.8 Beginning four days after the election and finishing no later than seven days after the election,  
2.9 the county auditor or municipal clerk must process each applicant's provisional ballot  
2.10 envelope. If the applicant's registration has been verified, the voter's provisional ballot  
2.11 envelope must be accepted. The county auditor or municipal clerk must mark the provisional  
2.12 ballot envelope "Accepted" and initial or sign the envelope below the word "Accepted." If  
2.13 the applicant's registration is not verified, the provisional ballot envelope must be rejected.  
2.14 If a provisional ballot envelope is rejected, the county auditor or municipal clerk must mark  
2.15 the provisional ballot envelope "Rejected," initial or sign it below the word "Rejected," and  
2.16 list the reason for rejection on the envelope. The county auditor or municipal clerk must  
2.17 promptly record in the statewide voter registration system that a voter's provisional ballot  
2.18 envelope has been accepted or rejected.

2.19 (b) The county auditor or municipal clerk must mail the voter a written notice of  
2.20 provisional ballot rejection between six and ten weeks following the election. The notice  
2.21 must include the reason for rejection and the name of the appropriate election official to  
2.22 whom the voter may direct further questions, along with appropriate contact information.

2.23 (c) A provisional ballot envelope marked "Rejected" may not be opened or subject to  
2.24 further review except in an election contest filed pursuant to chapter 209.

2.25 **Subd. 3. Provisional ballots; reconciliation.** On the seventh day after the election and  
2.26 prior to counting any provisional ballots in the final vote totals from a precinct, the county  
2.27 auditor or municipal clerk must verify that the number of signatures appearing on the  
2.28 provisional ballot roster from that precinct is equal to or greater than the number of  
2.29 provisional ballots submitted by voters in the precinct on election day. Any discrepancy  
2.30 must be resolved before the provisional ballots from the precinct may be counted. Excess  
2.31 provisional ballots must be randomly withdrawn from the accepted provisional ballots in  
2.32 the manner required by section 204C.20, subdivision 2.

2.33 **Subd. 4. Counting provisional ballots.** Once the reconciliation process required by  
2.34 subdivision 3 is completed, accepted provisional ballot envelopes must be opened; duplicated

3.1 as needed in the manner provided in section 206.86, subdivision 5; initialed by the members  
3.2 of the ballot board; and deposited in the appropriate ballot box. If more than one ballot is  
3.3 enclosed in the ballot envelope, the ballots must be spoiled and must not be counted.

#### 3.7 **171.072 TRIBAL IDENTIFICATION CARD.**

3.8 (a) If a Minnesota identification card is deemed an acceptable form of identification in  
3.9 Minnesota Statutes or Rules, a tribal identification card is also an acceptable form of  
3.10 identification. A tribal identification card is a primary document for purposes of Minnesota  
3.11 Rules, part 7410.0400, and successor rules, when an applicant applies for a noncompliant  
3.12 license or identification card.

3.13 (b) For purposes of this section, "tribal identification card" means an unexpired  
3.14 identification card issued by a Minnesota tribal government of a tribe recognized by the  
3.15 Bureau of Indian Affairs, United States Department of the Interior, that contains the legal  
3.16 name, date of birth, signature, and picture of the enrolled tribal member.

3.17 (c) The tribal identification card must contain security features that make it as impervious  
3.18 to alteration as is reasonably practicable in its design and quality of material and technology.  
3.19 The security features must use materials that are not readily available to the general public.  
3.20 The tribal identification card must not be susceptible to reproduction by photocopying or  
3.21 simulation and must be highly resistant to data or photograph substitution and other  
3.22 tampering.

7.3 Subdivision 1. **Entry of registration information.** (a) At the time a voter registration  
7.4 application is properly completed, submitted, and received in accordance with sections  
7.5 201.061 and 201.071, the county auditor shall enter the information contained on it into the  
7.6 statewide registration system. Voter registration applications completed before election day  
7.7 must be entered into the statewide registration system within ten days after they have been  
7.8 submitted to the county auditor, but no later than three days after the election. Voter
