2.16 **Subdivision 1. Transition to standard eligibility for medical assistance and**
2.17 **MinnesotaCare.** (a) \$4,517,000 in fiscal year 2024 is appropriated from the general fund
2.18 to the commissioner of human services for medical assistance.

2.19 (b) \$21,953,000 in fiscal year 2024 and \$1,323,000 in fiscal year 2025 are appropriated
2.20 from the general fund to the commissioner of human services to administer the transition
2.21 to standard medical assistance and MinnesotaCare eligibility functions after March 31,
2.22 2023. This is a onetime appropriation.

2.23 (c) \$1,827,000 in fiscal year 2024 is appropriated from the general fund to the
2.24 commissioner of human services for systems costs to implement the transition to standard
2.25 medical assistance and MinnesotaCare eligibility functions and the suspension of
2.26 MinnesotaCare premiums.

2.27 (d) \$36,000,000 in fiscal year 2024 is appropriated from the general fund to the
2.28 commissioner of human services for grants to counties to provide supplemental funding to
2.29 assist counties with resuming medical assistance renewals after March 31, 2023. The
2.30 commissioner must distribute the entire amount of this appropriation to the counties in
2.31 proportion to each county's March 2023 share of statewide enrollment in Minnesota health
2.32 care programs other than MinnesotaCare.

3.1 Subd. 2. Grants to navigator organizations. \$4,936,000 in fiscal year 2024 is
3.2 appropriated from the health care access fund to the commissioner of human services for
3.3 grants to organizations with a MNsure grant services navigator assistor contract in good
3.4 standing as of June 30, 2023. The grant payment to each organization must be in proportion
3.5 to the number of medical assistance and MinnesotaCare enrollees each organization assisted
3.6 that resulted in a successful enrollment in the second quarter of fiscal years 2020 and 2022,
3.7 as determined by MNsure's navigator payment process. This is a onetime appropriation and
3.8 is available until June 30, 2025."
