#### **CONSTITUTIONAL AMENDMENT**

# Section 1. CONSTITUTIONAL AMENDMENT PROPOSED.

An amendment to the Minnesota Constitution is proposed to the people. If the amendment is adopted, article XI, section 14, will read:

Sec. 14. A permanent environment and natural resources trust fund is and a housing fund are established in the state treasury. Loans may be made of up to five percent of the principal of the fund for water system improvements as provided by law. The assets of the environment and natural resources trust fund shall be appropriated by law for the public purpose of protection, conservation, preservation, and enhancement of the state's air, water, land, fish, wildlife, and other natural resources and for addressing climate change. The assets of the environment and natural resources trust fund shall not be used to pay the principal or interest of any bonds. The assets of the environment and natural resources trust fund shall not be used to pay for any costs related to the construction, repair, improvement, or operation of any facility or system that processes wastewater, but may be used to pay for research related to wastewater. The amount appropriated from the environment and natural resources trust fund each year of a biennium, commencing on July 1 in each odd-numbered year and ending on and including June 30 in the next odd-numbered year, may be up to 5-1/2 percent of the market value of the fund on June 30 one year before the start of the biennium. Not <del>less than 40</del> The assets of the housing fund shall be appropriated to provide housing, improve housing affordability, and increase homeownership. Until the year 2050, 50 percent of the net proceeds from any state-operated lottery must be credited to the environment and natural
