

1.1 moves to amend H.F. No. 5274 as follows:

1.2 Page 1, line 17, after the period, insert "A card game must include no more than seven
1.3 player seats, or ten player seats in the case of poker, and one human dealer at a shared,
1.4 physical table."

1.5 Page 2, after line 8, insert:

1.6 "Sec. Minnesota Statutes 2022, section 240.01, is amended by adding a subdivision to
1.7 read:

1.8 Subd. 8a. **Historical horse racing.** "Historical horse racing" means any horse race that
1.9 was previously conducted at a licensed racetrack, concluded with results, and concluded
1.10 without scratches, disqualifications, or dead-heat finishes."

1.11 Page 2, line 12, delete "on a single horse race"

1.12 Page 2, line 13, delete everything after the period

1.13 Page 2, delete lines 14 and 15 and insert "Pari-mutuel betting shall not include betting
1.14 on a race that has occurred in the past or is considered historical horse racing or where
1.15 bettors are not wagering on the same live or simulcast horse race or bettors do not share in
1.16 the total amount of bets taken."

1.17 Page 2, line 20, delete "A table shall not include electronic table games."

1.18 Page 2, after line 20, insert:

1.19 "Sec. **[240.071] PROHIBITED ACTS.**

1.20 A licensed racetrack shall only conduct horse racing and may be authorized to operate
1.21 a card club in accordance with this chapter. A licensed racetrack shall not conduct or provide

2.1 for play any other forms of gambling, including but not limited to historical horse racing,
2.2 slot machines, video games of chance, and other gambling devices.

2.3 Sec. **[240.231] LIMITATIONS ON RULEMAKING AND OTHER AUTHORITY.**

2.4 The commission's rulemaking and other authority, whether derived from section 240.23
2.5 or other sections in this chapter, shall only pertain to horse racing and card games at a card
2.6 club as expressly authorized in this chapter and shall not include the authority to expand
2.7 gambling, nor the authority to approve or regulate historical horse racing, slot machines,
2.8 video games of chance, and other gambling devices, by means of rulemaking, a contested
2.9 case hearing, the review and approval of a plan of operation or proposed or amended plan
2.10 of operation, the approval of any proposal or request, or any other commission or agency
2.11 action."

2.12 Page 2, line 29, after the semicolon, insert "and"

2.13 Page 3, delete lines 1 to 10 and insert:

2.14 "(4) no inclusion of any historical horse racing, or any other form of gambling that is
2.15 not expressly authorized for racetracks under this chapter."

2.16 Renumber the sections in sequence and correct internal references

2.17 Amend the title as follows:

2.18 Page 1, line 3, after "betting;" insert "prohibiting the authorization of historical horse
2.19 racing and other games;"
