3.2 (a) The secretary of state must place separate questions on the ballot at the 2024 state
3.3 general election related to final adoption of the state flag and state seal designs approved
3.4 by the State Emblems Redesign Commission. Except as provided in this section, the questions
3.5 must be placed on the ballot and the results of the election canvassed in the same manner
3.6 as provided by law for a proposed state constitutional amendment. The questions submitted
3.7 must be:

3.8 (1) "Shall the state flag design approved by the State Emblems Redesign Commission
3.9 be adopted as the official flag of the state of Minnesota, effective May 11, 2025?

3.10 Yes

3.11 No "; and

3.12 (2) "Shall the state seal design approved by the State Emblems Redesign Commission
3.13 be adopted as the official Great Seal of the State of Minnesota, effective May 11, 2025?

3.14 Yes

3.15 No "

3.16 (b) The secretary of state must provide each county auditor or municipal clerk with
3.17 sufficient copies of a reproduction of the designs for the state flag and state seal, printed in
3.18 color, so that examples can be made available for public inspection in each polling place.
3.19 The county auditor or municipal clerk must ensure that these reproductions are placed in a
3.20 conspicuous location in the polling place so that voters may view them prior to casting a
3.21 ballot.

3.22 (c) If the majority of voters voting at the election vote yes on a question, the question
3.23 is approved and the design referenced in that question is finally adopted as the official flag
3.24 or official seal of the state of Minnesota, as applicable."
