Testimony in support of HF 1450 (Hansen) in Agricultural Finance and Policy Committee

Chair M. Sundin, Vice Chair S. Vang and Committee Members:

My name is Lori Cox, owner / operator of Roots Return Heritage Farm in Carver writing **in support of HF1450**.

Our small farm has produced perennial fruits, annual vegetables and herbs without synthetic chemical use for the last 6 years. We have utilized continual no-till cover crop rotations and organic methods for soil health and plant nutrients and will continue to do so. This season we're leasing our farm to 4 newer producers expanding their markets.

The agricultural areas around me in Carver county have not been difficult to read when dicamba damage for years has occurred. The unmistakable damage to the bean leaves themselves, discoloration, acres full of cupping and slowing of growth has saddened me that it not only effects the producer, but their neighbors as well. I would be up in arms should the farm next to us provide this type of application and damage to our crops. There should never be one crop surviving at the expense of another in food, fiber, and fuel production. Sadly, that is what has been allowed with dicamba herbicide.

A report comparing the 2012 and 2017 USDA Ag Census for MN tells us chemical costs to farms increased, however number of farms (consolidation) decreased. Consequently, # of acres of herbicide use increased as well. More land getting more herbicide, including dicamba. Overuse of any herbicide causes genetic mutations in weeds (by nature, to survive), causing chemical resistance. Dicamba is called out by the EPA creating resistance to a very threatening weed nationally, Palmer Amaranth. There are other ways of farming to education oneself about vs constantly bowing to agricultural chemical companies ensuring this year's growth and profit intact by tying the promise to their seed & chemical cocktail mix. Companies too eager to continue taking farmer's profits without ensuring no harm to them or their neighbors today or in the future.

Since dicamba needs to be applied in the 3-10mp range, I looked at average windspeed in my county of Carver. MDA has cutoff dicamba applications by June 30. The graph shows my county's average windspeed from May to the end of June is both over, and just under 10mph. No wonder I've seen so much damage. [Average Weather in Carver, Minnesota, United States, Year Round - Weather Spark](#). Average rainfall during peak application time was also high, adding to humid conditions hard to overcome for 'safe' dicamba applications. The same can be said for heat spikes, going over the limit for ideal application conditions.

Additionally, a May 2020 press release stated dicamba was found by National Institutes of Health (NIH) to have increased cancer risks. [National Institutes of Health Study Links Dicamba, Increased Cancer Risks \(biologicaldiversity.org\)](#). This doesn't mention the overall effects of damage to

surrounding flora and fauna on field edges, neighboring fields, non-farmed fields, beneficial and endangered insect populations, or neighboring crops.

Searching MDAs database in my county for registered/licensed private chemical applicators (not commercial), **123 out of 309 applicators are currently in compliance as of 3/1/21 (=just over 1/3)**. This tells me a solid % of chemical applicators throughout MN are not licensed to apply agricultural chemicals. Surely, there could be listed those who no longer apply, have retired, or are even deceased. However, with those that should be in compliance, what should be done and where are the consequences? A quick review of the House and Senate Agricultural Committee’s members also noted some expirations. Again, these could be due to reasoning listed above. (Spreadsheet below)

MDAs reports of dicamba damage statewide 2017 and 2018: During 2017, MDA received 249 complaints, conducted 56 official investigations in 49 of MN’s 87 counties = over ½ the counties in the state. In 2018 received only 53 complaints, attributed to implementing a cutoff date of June 20. [Dicamba - Damage & Complaints | Minnesota Department of Agriculture \(state.mn.us\)](https://www.state.mn.us/ag/dicamba/). In 2019 MDA had 6,656 people attend dicamba training, and in 2020 they had 4,292. They do not yet have stats for 2021, nor does MDA provide a cutoff for when they should have received training. They instead defer to the June 30 cutoff date. No one can define if this is less dicamba use, less attention and attendance to training, or other anomaly.
