There is a core of staff that have worked at HICR for several years and know each client well and on a daily basis display true skill and wisdom.

We have been thrilled to see Colin thrive and mature, becoming more independent, with regular responsibilities in keeping his room neat, helping with food prep and cleanup, doing his laundry and positively relating to his fellow housemates, all under the diligent guidance of the staff at HICR. With 12 clients all requiring this help and direction, we have been very grateful and quite amazed at the workload the staff at HICR carries.... and we have been very impressed.

When COVID hit, the whole group had to stay quarantined, adding to an already very heavy load of responsibility for the staff. Yet they carried on and our son and the others came through just fine.

However, with some recent staff changes HICR is now experiencing a shortage of staff. Our son is not able to get to the library to check out books or go to the store for a treat when he has been rewarded for a task well done, because it requires a staff person to take him. If there is not enough staff to stay back with the others, Colin doesn't get to go. This is happening all the time at HICR now.

Having come through COVID, now is such an important time to rebuild, encourage and strengthen the clients at HICR by getting them out in the community, taking part in activities and renewing confidence in their relationships with one another.

We want to see this amazing facility continue to impact our sons and daughters, giving them all the opportunities they deserve. This can happen if you will consider providing the increase in funding by passing HF 568.

Hello Everyone,

I am guardian and sister to a person living in an icf in Arlington which has 12 residents and licensed for 13. This icf receives the lowest funding in the state, nearly 50 percent less than the average icf. An icf is supposed to be a higher level of care than family foster care, but yet Arlington receives the same amount, \$119 per diem as a very able bodied person at family foster care would. Current ratio at Arlington one staff to six people required minimum. Family foster would require one to four ratio. Doesn't make sense! My sister as well as all the others have no one to one time, limited if any social outings, which is part of their programs. With limited per diem, only the minimum gets done, like meals, meds etc. Foster care allows for individual assessments and programs, allocating staffing accordingly. At least if icf paint a broad brush for per diem, it should be enough to provide for adequate staffing to support more than the very basic needs. Clients should be able to have individual time, going to a movie, bowling etc. Currently, everywhere they go they are together, work, church, leisure time, dining time at their home, everyone needs breaks for roommates. I fully support the bill presented to increase funding. It is long overdue. regards,
