HF 1833 (Kresha) Refundable sales and use tax exemption provided for construction materials for projects for Aitkin Public Schools.

Chair Gomez renewed her motion that HF1106, as amended, be laid over for possible inclusion in the Tax Omnibus Bill.

HF1681 (Davids) Maximum amount of outstanding debt allowed for the state agricultural society increased, and sale tax exemption for certain construction materials provided.

Chair Davids moved HF1681 before the committee.

Representative Davids moved the H01681A1 Amendment. **THE MOTION PREVAILED AND THE AMENDMENT WAS ADOPTED.**

HF2197 (Robbins) Individual income tax; child credit marriage penalty eliminated and credit phaseout increased, and working family credit limited based on earned income to taxpayers with qualifying children.


Chair Davids took HF2197 off the table for renewed discussion.
