1.3 "Section 1. Minnesota Statutes 2022, section 135A.012, is amended to read:

1.4 **135A.012 HIGHER EDUCATION ATTAINMENT GOAL.**

1.5 Subdivision 1. **Purpose.** This section sets a goal for postsecondary education and  
1.6 workforce training credential attainment for Minnesota residents.

1.7 Subd. 2. **Postsecondary credentials.** The number of Minnesota residents ages 25 to 44  
1.8 years who hold postsecondary ~~degrees or certificates~~ or industry-recognized credentials  
1.9 should be increased to at least 70 percent by 2025.

1.10 Subd. 3. **Rights not created.** The attainment goal in this section is not to the exclusion  
1.11 of any other goals and does not confer a right or create a claim for any person.

1.12 Subd. 4. **Data development and analyses.** The Office of Higher Education shall work  
1.13 with the state demographer's office to measure progress towards the attainment of the goal  
1.14 specified in subdivision 2. The United States Census Bureau data shall be used to calculate  
1.15 the number of individuals in the state who hold a postsecondary degree. The Office of  
1.16 Higher Education, demographer's office, ~~and~~ the Department of Employment and Economic  
1.17 Development, and the Department of Labor and Industry shall develop a methodology to  
1.18 estimate the number of individuals that hold a ~~certificate~~ credential awarded by a  
1.19 postsecondary institution or recognized by an industry authority as their highest ~~educational~~  
1.20 credential using data available at the time that the analysis is completed.

1.21 Subd. 5. **Reporting.** (a) Beginning in 2016 and every year thereafter, the Office of  
1.22 Higher Education, in collaboration with the state demographer's office, shall, by October  
1.23 15, report to the chairs and ranking minority members of the legislative committees with

2.1 primary jurisdiction over higher education policy and finance on the progress towards  
2.2 meeting or exceeding the goal of this section.

2.3 (b) Meeting and maintaining the goal of 70 percent of Minnesota residents ages 25 to  
2.4 44 years holding a postsecondary ~~degree or certificate~~ or industry-recognized credential  
2.5 will likely be difficult without achieving attainment rates that are comparable across all race  
2.6 and ethnicity groups. The Office of Higher Education shall utilize benchmarks of 30 percent  
2.7 or higher and 50 percent or higher to report progress by race and ethnicity groups toward  
2.8 meeting the educational attainment rate goal of 70 percent.

2.10 Subd. 2. **Eligibility for grants.** (a) An applicant is eligible to be considered for a grant,  
2.11 regardless of the applicant's sex, creed, race, color, national origin, or ancestry, under sections  
2.12 136A.095 to 136A.131 if the office finds that the applicant:

2.13 (1) is a resident of the state of Minnesota;

2.14 (2) is a graduate of a secondary school or its equivalent, or is 17 years of age or over,  
2.15 and has met all requirements for admission as a student to an eligible college or technical  
2.16 college of choice as defined in sections 136A.095 to 136A.131;

3.1 (2) for a serious health condition, while under the care of a medical professional, that

3.6 Subd. 18. **Data.** (a) An eligible institution whose students are eligible to receive funding

3.8 and federal and state financial aid.

3.9 (b) An institution or its agent must provide to the office aggregate and distributional  
3.10 financial or other data as determined by the commissioner that is directly related to the  
3.11 responsibilities of the office under this chapter. The commissioner may only request aggregate  
3.12 and distributional data after establishing and consulting with a data advisory task force to

3.17 a foster grant based on the federal need analysis. Applicants are encouraged to apply for all  
3.18 other sources of financial aid. The amount of the foster grant must be equal to the applicant's  
3.19 recognized cost of attendance after deducting:

3.20 (1) the student aid index as calculated by the federal need analysis;

3.21 (2) the amount of a federal Pell Grant award for which the applicant is eligible;

3.22 (3) the amount of the state grant;

3.23 (4) the Federal Supplemental Educational Opportunity Grant;

3.24 (5) the sum of all Tribal scholarships;

3.25 (6) the amount of any other state and federal gift aid;

6.13 of its programs must apply to the office to establish that the school or program meets the  
6.14 requirements of an exemption. An exemption for the school or program expires two years  
6.15 from the date of approval or when a school adds a new program or makes a modification  
6.16 equal to or greater than 25 percent to an existing educational program. If a school is  
6.17 reapplying for an exemption, the application must be submitted to the office 90 days before
