Chair Noor moved to adopt the H4338A13 amendment to the H4338DE1. THE AMENDMENT WAS ADOPTED.


Chair Noor moved to adopt the H4338A14 amendment to the H4338DE1. THE AMENDMENT WAS ADOPTED.


