2-6	H.F. 1379, 2nd eng., as modified	Baker	Authorizes the use of nonopioid directives to instruct health care providers to not administer or prescribe an opioid to a patient.
8, 9	H.F. 1289, modified	Stephenson	Requires social media platforms to have a mental health warning label appear when users access the platform; authorizes the attorney general to investigate and bring actions for violations of the warning label requirements.
