Dear Chair Fisher and Members of the Human Service Policy Committee:

My name is Alex Lancaster, residing in Rochester, MN. I am writing you in support of HF 3712. As a direct care provider in a family foster care home for over seven years, it is important to me to see this bill get passed.

In my facility, I have taken on the responsibility of caring for people who are severely physically disabled, including being hoyer-dependent and electric-wheelchair bound permanently. I employ multiple full-time and part-time staff to share the responsibilities of caring for these individuals with almost every single aspect of their daily living needs. Their direct care needs are extensive, labor-intensive, and require staff assistance through almost all hours of their waking day. Switching to a flat rate payment model for compensation would require our facility to shut down its' practices in the context in which they are currently provided, thus displacing the individuals being served due to an inability to financially carry the burden of ensuring our employees have proper salaries for the difficult and important work they do alongside me. I cannot physically care for these individuals alone as it would be unsafe and unethical to do so.

Additionally, all three individuals we currently serve have had multiple placements in alternative residential settings in Minnesota that have all resulted in neglect, abuse, or an inability to properly care for their medical and health needs. In my home, as the license holder and primary care provider, I have helped each individual meet goals they never thought were possible at their prior placements. This has included improving their health, finding work, gaining important relationships, engaging in hobbies or recreation of their choice, and staving off serious chronic issues like persistent wounds, inability to sleep, and excessive digestive complications that cripples a person's ability to live the life they desire. The consistency and continuity of care that I provide is only obtainable due to the superior model that FRS is. The individuals that live with me often offer words of gratitude and relief that they have finally found a family home with a provider who can meet their needs so consistently. Even the mention of them moving into a different type of residential setting triggers traumas and fears of their past placements and how they struggled to have even their most basic humanistic needs met. These are needs that we take for granted every single day because we can walk to a bathroom, make a meal for ourselves, take a shower, or even just hold a toothbrush or a comb. Knowing they can rely on me and my staff allows them to meet their basic physiological and safety needs, as well as expand their engagement in other essential parts of life that all humans desire and deserve.

I appreciate your time hearing my perspective and thank you for taking on the responsibility of making important decisions that have significant impact on our community and so many vulnerable lives.

My name is Angela Strasser from Farmington. I am writing you in support of HF 3712.

As an FRS provider for the last 5 years, it's important to the individuals I support to see HF 3712 bill get passed. My name is Angela Strasser, I reside in Farmington, MN, and support three disabled adults in a Foster Care setting, referred to as an FRS. We are a residential home that is part of a thriving community in Dakota County.

My entire adult life has been supporting the disabled community in one capacity or another. I have supported individuals while in institutions and celebrated when the same individuals were able to choose the community in which they wanted to live and work. I moved to Minnesota in 1999 due to Minnesota's leadership and direction of this change. I decided to open our home in 2019 to complex need individuals who were unsuccessful with placement within other programs. We provide intensive services to individuals, both complex medical and severe mental health related. These individuals deal with trauma. They need additional love and support as they were not successful in other settings. They were in and out of crisis, over medicated, stuck in a hospital bed without guidance and case managers scrambling to find anyone to place them. Together, in our home, we have been able to provide support and guidance to reduce their fears, uncertainties, and breakthrough some of the trauma they have not dealt with in the past. The continuity of care is superior. Medication reductions, weight loss, nutrition, a variety of therapies that would have never been researched or discovered had they not resided in our home and the overall reassurance that we are the same people that will be there for them daily. They don't worry about who will help them in the shower, who will help them through an anxiety attack or when the voices start will they be disregarded. We will be the same individuals who will work through their toughest days and celebrate their best days. I could type endless pages of how we have been successful, their guardians and case managers can tell you as well. The difference is our commitment to them residing in our home and being there through it all. Having structure to meet their needs, their goals and support their dreams. It's exhausting and we are always on our toes as we experience a variety of curve balls during our day. It could be the Amazon delivery guy who looks like the person who previously abused them or a noise that happened in the grocery store that triggered an outburst. We are there for them through everything, 24/7, 365 days. The same people, always!

This is important to the individuals we support, me and our FRS community because the individuals we support would lose that security if the tier rate goes into effect. It will throw the entire system on its back and individuals will be looking for placement again because we will be unable to operate with such low rates and the inability to request exceptions. This is not a cookie cutter program. Everyone has their own challenges and abilities and to help individuals move forward in their life we are exceptionally important to the system. In conversations with other residential providers, there are approximately 1168, 70% of said providers would not be able to continue and would need to look for other employment. It would be beyond devastating. Please come to our homes, talk to the individuals supported and ask them what impact we have had on their entire life, their extended family, and the overall community in which they chose to live. We need to be able to share the truth in the value we have to Minnesota. We wear may hats, have endless paperwork just like corporate settings and we are also their full-time care providers. The clock doesn't stop for us, ever! We continue to ensure all their needs are meet, exceeded and for their next steps to be addressed, without FRS providers the state will experience a whole new set of challenges in an already compromised workforce.

My spouse and I have been Family Residential service providers for 12 years. I grew up in a family that provided family foster care. My spouse has worked in the human services field for over 40 years. Our combined experience in this field allowed us to take on a more challenging population. It is imperative that family providers are allowed some additional time to show how the flat rate, as currently proposed, will force family providers out.

The environment of a family atmosphere gave our individuals the stability and consistency they need. The staffing crisis that the human services field is currently experiencing for the Direct Support Professional role makes consistency almost nonexistent in the individuals' lives. This unpredictability of who they can rely on, on a day to day basis has an extremely negative effect on the individual's quality of services and their quality of living. Whenever we had staff call in sick my spouse and I were always there to fill in where needed. Again, offering some consistency in the resident's life. If the flat rate goes into effect, family residential services will most likely become nonexistent. What will happen to all the people currently being served, where will they move to and what is the impact on them?

As family providers we are always available it is a 24/7 commitment. The level of care our individuals require, also make it necessary to hire outside help. I am reaching out to express my full support for HF 3712 and to stress the critical importance of maintaining current rates for family foster care providers. With two years of experience in adult foster care, I have encountered firsthand the complexities involved in caring for individuals with varied and highneeds conditions.

One of my residents is facing behavioral challenges, including incidents of smearing feces on walls, that were beyond the management capabilities of his previous assisted living facility, resulting in escalating behaviors. In essence, he is a 34-year-old male with a complex medical history encompassing schizophrenia, schizoaffective disorder, Huntington's disease, generalized anxiety disorder, traumatic brain injury, attention-deficit hyperactivity disorder, antisocial personality disorder, and polysubstance abuse. He transitioned from his former residence due to behavioral issues. His difficult placement stems from a history of assault and the tragic loss of family members to Huntington's disease, including his mother when he was 11 years old, as well as his brother, sister, and uncle. Raised by his father and stepmother, who still reside in Minnesota, he shares a strong bond with them. Presently, he is under commitment and Jarvis oversight, he grapples with multiple chronic health conditions that can be overwhelming to manage. He previously resided at Nagel Assisted Living (Sunflower Communities) in the memory care unit, where he received care from a behavioral health case manager, psychiatrist, primary care physician, and neurologist. He is eager to maintain access to the Community Access for Disability Inclusion (CADI) waiver program.

I am especially concerned about the potential implications of the proposed rate changes for family foster care providers. The exclusion of FFCs from the DWRS and the inability to request rate exceptions could lead to significant rate reductions, jeopardizing the quality of care available to individuals with high needs, like the individual mentioned.

I implore you to consider the widespread impact of these rate changes on providers and individuals in need of family foster care services. By supporting the delay in payment methodology changes and the establishment of an advisory task force to thoroughly analyze the consequences of the rate adjustment, we can ensure that individuals with distinct requirements receive the necessary support they deserve.

Thank you for your dedication to this cause and for your continuous efforts to enhance the lives of those in need. I am optimistic that your actions will lead to positive outcomes that safeguard the well-being of individuals grappling with complex health conditions.

I extend my gratitude for your tireless service and dedication in the legislature. Your efforts are truly making a difference.

My name is Maura O'Connor, and I am the proud auntie and guardian to my two adult disabled nephews ages 45 and 43. I am writing in support of HF 3712 and ask that you also support said house file.

I am writing in regard to my nephew Shawn (43), who is in an FRS placement in Dakota County. Shawn has Autism, PTSD and was emotionally and behaviorally abused as a child. Shawn has lived in 2 different group homes prior to being placed in his present FRS home. In 2015 I moved Shawn to a group home that appeared more appropriate for his needs and was very "person centered." This group home was so person centered he was allowed to stay in his bedroom and in bed for up to 20 hours per day. The only time he left his room was when he ate, took meds or needed to address his hygiene needs. After a year he gained over 50 pounds, became withdrawn, combative, paranoid, and appeared to give up. I contacted his county social worker requesting a

change of placement and was introduced to the FRS community of services.

As a retired special educator and administrator, I am well aware of the needs and complexities of serving adults like Shawn. When he moved into his FSR, every movement needed to be micromanaged 24/7 365 days per year. For example, he would need to be told to pull out his chair, sit, pull in his chair, pick up his fork/spoon, gather food onto his utensil, put it into his mouth, chew and swallow. This needed to be done for every meal and snack for over a month. He was non-verbal, would not look you in the eye, and needed help in every aspect of his life. It has taken us over four years for him to express some of his needs and wants only within the confines of his FRS (Shawn was verbal until he moved into his 2nd group home) Every time he responds without prompting is a cause for celebration.

Shawn needs support and guidance 24/7 365 days per year, he needs a home with staff that are willing to find therapies for his emotional and mental health needs, follow through with behavior modification, maintain a healthy weight, making sure the meds are appropriate and lastly learning what parents are to act like, which he never knew.

I became aware that this past Minnesota Legislation session passed a law, HF2847, that will impact FRS homes in moving them to a new tier system and giving them a flat rate of care. My nephew's needs are greatly different than the other two gentleman who live in the same FRS home. He is not able to hold a job, communicate within the community and has avoidance behaviors when having to leave his home. His roommates are much more independent and to compare them as the same is ludicrous. Were you aware that no FRS representatives were on the said task force when this legislation was

being discussed? You were misled when you were told that FRS members were consulted and your DHS Licensing Director, Mary Kelsey, has also not spoken truth to this matter. I am very disappointed as an auntie, guardian, and taxpayer that this is how laws are created in this state when it comes to our most vulnerable community members.

As of today, there are approximately 1168 FRS providers in this state and when questioned 70% stated they would not be able to continue to provide their service thus sending numerous adults into uncertainty. Yes, there are group homes and many of them are closing homes because of cost and not being able to staff them. A DHS employee was overheard saying "We don't want those kinds of people living near us", what a crock coming from DHS. I have also heard that many corporate providers are "searching for anyone with a heartbeat". Please don't roll your eyes or chuckle as this is what is happening within your communities.

HF 2847 said it would save hundreds of thousands of dollars if FRSs were moved to a flat rate, really? If FRS providers close where will these individuals get placed. Presently, numerous vulnerable adults are receiving care in hospitals. How is this cost effective? Again, as a tax payor I am appalled as this is not appropriate for anyone. I am willing to sit down with you, have a virtual meeting, have you meet my nephew and watch what happens at his FRS.

Honestly, I don't know where Shawn and I would be without the FRS he is in right now. Their support, parenting, communication, and love for Shawn is above and beyond what he ever received within the group home community. We need more FRSs not less.

I am asking you to pass HR 3712 not just for my nephew, however for all this FRSs that will be impacted. We in Minnesota can and must do better.

My name is Mieso Koji an Adult Foster Care Provider in Dakota Co. Mn. I am writing you in support of HF 3712. As an adult foster home for the last 4 years and 3 months, it is very important to me to see this bill get passed. My wife Genet is an LPN with experience of over 16 years and I am an RN with over 13 years of experience. We both took care of service recipients in our home in the state of Oregon before we moved to Minnesota in 2019. Here in Mn, our first service recipients moved in on Nov 3rd 2019. Prior to that he was at his own apartment where PCA comes in and provided support during the day, put him in bed at night and back the following morning at 9:00 am. This service recipient is a diabetic, uses a wheelchair for mobility, incontinent of bowel and bladder, uses suprapubic catheter, Hoyer-Lift for transfers. At his apartment, when PCA is sick or late, he would remain in his bed with no access to food, personal cares or medication. Because of all those inadequate cares, he had skin breakdown, malnourished and was receiving nutritional boost to maintain his weight. After he moved with us, in three months, no skin concern or needs for extra nutritional supplement.

Our 2nd service recipient came from his mom's house on April 5th 2020. This individual is on medication for seizure and would get clusters of seizure in a week at his home. Since he moved with us for over 3 years and 9 months, we have not witnessed any episode of seizure. We did not do any magic but strictly followed his neurologist's order and administered his medication on time. No excuses for error.

Our 3rd service recipient who uses a wheelchair for all her mobility needs and requires Tube-Feeding for her nutritional support moved on August 17, 2020. On arrival, she weighed 70 pounds. In four months, she gained 26 pounds. We only followed her nutritionist's order and delivered per schedule.

With the high care needs of our service recipients, the flat rate would not meet our means to provide the proper care they require and the proposed bill would push us out of the care we currently providing at home. With the flat rate no incentive for us as an LPN, and RN professionals, we would be forced to seek employment in the healthcare industry and get a reasonable perks and health insurance for our family. These service recipients truly consider this is their home and the flat rate bill would misplace them from a place they truly consider a home. One service recipient's family jokingly commented "Where have you been all these years?" referring to those years his brother was in his own apartment under PCA cares. The proposed flat rate would impair the cares we provide with passion and compassion to our service recipients.

My name is Sandra Donohue from Minneapolis. I am writing to you in support of HF 3712.

I became a FRS provider in 2004. Because my home was handicapped accessible, we were unique and could take people needing wheelchairs for mobility. Over the next 20-year period, and because the people we supported tended to be those with progressive diseases, we focused our home on those needing hospital level of care. We have supported over 20 people in our 20 years of fostering adults.

We have had people on vents, having tracheostomies, g-tubes, colostomies, ileostomies, straight catheters, pubic catheters, supra-pubic catheters, wounds and pressure sores. The people we support come with all types of complex medical needs like MS, paraplegia, quadriplegia, ALS, Cancer, and we provide hospice services at end-of-life so that they can stay at home and die with dignity.

In 2022, my daughter took over my 245A program. She has been working with me since she was 15 years old. She was 35 years old when she moved herself, her fiancé, and her young son into our home so she could take over care.

We have a doctor that supports us by coming to the home once per month (more if necessary) and we have access to him 24/7 through a medical portal in case we have needs after normal business hours. In 2023, we hired a full-time registered nurse to oversee our medication administration program and we added Therap to our software arsenal to ensure we are doing the best job we can in meeting the 245D requirements for both medication administration and goal tracking.

The people that we hire (because our clients need additional staffing per their CSSP's including awake staff and 1:1 staffing) become extended family to us. Their kids are included in that. We share holidays together, we share kid's birthdays together, celebrations like weddings, baby showers, life-happenings together because we are a family. In fact, we have a mother-daughter and mother-son working for us going back the full 20 years I have been a 245D/245A licensee.

Our program is completely person-centered. It is one of the foundations of who we are as a program. The people we support are in full charge of what they want their best life to look like, not force-fed programming because of being short-staffed or because that's the corporate way of doing things. Our clientele come directly from nursing homes, hospitals, and parental homes. We are a one-of-a-kind program and when we have an opening, it is filled within days of when I announce it.

I strive to make each person we support feel as if this is not only our home, but their home as well, that we are part of their extended family for as long as they are with us. Of the people that have passed away in our care, we still speak to their families and continue to include them in all of our summer and fall festivities. I have included a

letter from a daughter whose dad passed away after 12 years of living with me (Attachment 1), a Facebook shout-out from a daughter of a person who lived with us for over 6 years after her dad passed (Attachment 2) and from a case manager who I have worked with for several years (Attachment 3).

Since my daughter took over the 245A program I ran for almost 20 years, I have devoted myself to working with programs that already have their 245A license, but either have applied for or don't qualify to get their 245D license. Using a satellite practice and the same person-centered programming we do in the home I and now my daughter own, we support a total of 29 individuals in 18 homes across 8 counties in Minnesota. I took on a partner, Angela Strasser, in 2023, and she and I are working together to support the people in those homes along with the providers who run them.

With the push to be person-centered and provide individual programming so that the people we support can live a quality life of their choosing, it is difficult, as a provider, to hear that person-centeredness only goes as far as programming, but is not used as the foundation of the rates we are paid.

The people we support are not alike – they are not all the same. I have a gentleman we support currently that has a tracheostomy, g-tube, is incontinent of both urine and bowel and has the cognitive level of a toddler in a 29-year-old's body. His current language is pinching and pulling hair as he doesn't use language to tell us something is wrong or that he doesn't feel good. Because of his cognitive level, he does not understand to let go and we have had multiple situations where we have had to pull someone's hair out because he won't disengage, and we can't use a scissors for fear of cutting him. He must be micro-prompted for his every action and we have to direct him in his every task, or we can't get them done.

If this bill isn't passed, where does he go? We will not be able to sustain our programming as we will not be able to hire staffing, nursing and pay our bills. Currently, when we file for an exception using DHS-5820 (attached), we can usually get additional monies above what is already built into the DWRS framework for the following categories:

- 1. Average hourly wage of staff providing direct care
- 2. Wage for staff who are generally asleep, but available to respond to unplanned events during the night
- 3. **Absense** is the overhead cost adjustment based on costs still present even when the person is not there and the provider cannot bill **Utilization** is costs associated with costs to maintain a licensed home such as licensing fees, etc.

It is unlikely we can get additional monies above what is already built into the DWRS framework for the following categories:

- 1. Costs for a provider to supply health, dental or life insurance, retirement benefits, wellness programs, etc.
- Costs to provide access to the community or care in the home such as supplies/equipment, not available through MA, reinforcements outlined in the CSSP, expenses related to staff costs for accessing community, etc.
- 3. Overhead costs related to providing the service, such as conferences, fees related to licensing, background checks, city or business licenses, record retention and storage costs, training and recruitment of program staff specific to the extraordinary needs of the person
- 4. Standard overall costs common to all businesses, such as staff wages/benefits, banking fees, office utilities, office equipment, phone, etc.

5. Cost related to providing transportation related to the person accessing the community in either a standard or adapted program vehicle

We need to level the playing field for FRS's as we deliver the same services that CRS homes offer, have the same rules, regulations, and state mandates that CRS homes must follow, all the while providing the people we support with a family, love, continuity of care, we do it with less staffing, no corporate entity to do all the paperwork so the load is heavier because we have to do the direct support as well as the paperwork needed to stay compliant. We need a seat at the table of whatever task force or advisory committee is set up that affects us including Waiver Reimagine, the DWRS Advisory Committee, and the one being proposed in HF 3712.

If you go to a flat-rate system and you take away our ability to file exceptions on top of it, of the almost 1,800 FRS homes currently operating in Minnesota, over 70% of them will have no choice but to close. Where are the 29 people I support with my 245D going to go? What about our flagship program where the people we support come directly to us from hospitals and nursing homes that can't handle their level of care long-term? What are you going to do to accommodate the wishes of the people that want to live in a family home rather than an institutional setting when we can no longer afford to operate?

I encourage you to talk to any of the case managers or social workers I work with and they will tell you that it is FRS homes accepting people needing the highest level of care in both mental and physical health for various reasons including staff shortages, yet those providing those services are in constant fear of being shut down because of the need to hire supplemental staff to provide the services that the people we support need and deserve.

I encourage you to talk to the guardians and case managers of the people we support. Ask them what impact we have had on their lives, their extended family, and the overall community in which they chose to live. We need to be seen as adding a valuable service to the State of Minnesota, not feel as if we are stuck in a mud bog just trying to survive and worried every second that the people we love are going to be removed from our homes.

I encourage you to come see our flagship home and talk to the people we support, hear what they have to say about their previous placements compared to the care they get in our home.

Chair Fischer and Members of the Human Service Policy Committee I want to sincerely thank you for your time and the work you do at the legislature.

In 2020 I had a resident who had no place to live and all other providers refused to support but I brought her to my facility from a motel in Bloomington and was providing Support 1:1 24 hours but paid only for 16 hours and I did not complain about it since I am strong believer of providing support for just being human being.

The other resident I had was someone who does not properly use bathroom, does not know how to set up doctor appointment, can not use medical ride because of anxiety and cannot sit by himself for even an hour without staff support.
