Thank you for the opportunity to share my thoughts and experience regarding this matter. My name is Angie Hanson and I work as a secretary at the Chisago Lakes Middle School. I'd like to share some information as the why I'm in favor of the SHIELD ACT.

The Chisago Lakes Middle School is sorely outdated in means of safety and building updates. Unfortunately we are the only school that doesn't have the same safety measures as the other buildings in the district.

To enter the building, visitors must only press a button. After that, the visitor walks directly onto campus without entering a secure and safe area first. They have free range to go anywhere in the school.

It's incredibly scary to think that if an intruder were to enter the building and attack me, there would be no other staff member to alert other staff or students. The only "barricade" I have is a roll down metal window that does virtually nothing for my safety. Additionally, the button I press to begin the process of a lockdown procedure doesn't alert the additional office staff that I am in danger. On top of that, the button I would have to press is on the far left of my office and the rope I would need to pull down to close the metal window is on the right side of my office. Where every second is precious, it would take too much time to be able to roll the window down.

In the last three years we have had to go into lockdown numerous times. It's a different and scary world we live in now.

I implore each committee member to vote in favor of the SHIELD ACT. We are in desperate need of added safety and security measures.
