2.6 Subdivision 1. **Definition.** A school district or charter school library or school library

2.9 (1) ensure every student has equitable access to resources and is able to locate, access,
2.10 and use on-site resources that are organized and cataloged;

2.11 (2) have a collection development policy that includes but is not limited to materials
2.12 selection and de-selection, a challenged materials procedure, and an intellectual and academic
2.13 freedom statement;

2.14 (3) be housed in a central location that provides an environment for expanded learning
2.15 to meet the unique needs and interests of individual students; and

2.17 Subd. 2. **Services.** The school district or charter school library or school library media
2.18 center must employ a licensed school library media specialist or licensed school librarian
2.19 who:

2.20 (1) provides instruction for students;

2.21 (2) provides staff training on the use of new resources and equipment;

2.22 (3) provides instructional support for and collaboration with teachers of all disciplines;

2.23 (4) participates in school-wide technology and communications planning and promotes
2.24 its integration into all instructional programs; and

2.25 (5) models and supports the ethical use of information, adherence to copyright laws, and
2.26 respect for intellectual property."
