We are grateful to Sen. Morrison and Rep. Frazier, for moving very important election reform to create thoughtful intentional space for key debate on Ranked Choice Voting.

Minnesota is home to over 18,000 statewide Common Cause MN multipartisan members and despite belonging to various MN party affiliations, or not being affiliated, the one thing they've come together to do is support our work ensuring our Republic's democracy is safeguarded, our elections continue to reflect the will of Minnesotans and everyone's vote counts.

We believe democracy is how a free society resolves its differences. And to do that well, we must all agree the process is fair, produces equitable outcomes, and reflects our communities, our values, and our priorities. Nobody wins all the time, but if the process is fair, at least we can trust it.

The provisions pertaining to the creation of a RCV task force has now grown to approximately 32 members to study improvements to the election system, assess requirements for implementation of RCV and recommend statewide standards.

We've asked our base to reach out to committee members and share their thoughts on the proposed RCV Task Force. As of this written statement, there have been approximately 2,100 written letters to members. Many of our members have some difficulties with writing or English is not their primary language, they asked for help, and we provided a writing tool. Make no mistake thought, when you read their letters, you will see they have their own views on this issue. Please do not dismiss their messages if you see them repeated. I promised them I would share that with you both.

Ranked choice voting puts Minnesota voters in charge. Common Cause has supported RCV in New York, Oregon and California.

Currently, we ask members of the committee, Sen. Morrison and Rep. Fraizer to reconsider the following:

• The idea of the task force is a good one. The ranking majority and minority leaders already pick 4 voting task force members. Under the new provisions, they get another 8 members they are able to handpick without these appointees having to go through an open, transparent and competitive process. We respectfully ask that politicians handpicked appointees be replaced by more election officials, county auditors and elections administration staff to best align the Task Force recommendations with a positive outcome in the use of RCV for state and Federal elections. We cannot risk our elections with partisan dynamics hijacking the integrity of what should be a nonpartisan space.

Key factors we consider when assessing proposed RCV reforms from the administrative process side are 1) Equipment, 2) Outreach, 3) Audits and 4) Budget. Other things we also look for is:

 whether there is equitable representation that is meaningful in the composition of who is making the decisions,



- whether there is parity in power among those decision makers,
- are members mentioned relevant to the process and/or matter they are leading; do they have special knowledge.
- whether the process maximizes opportunity for transparent, and
- does the public have access to information, voting and other relevant information.
- does the public get to interact with the task force or participate in a public and open process or is it a closed body.

Common Cause is grateful to everyone who've worked diligently to be thoughtful and intentional in ensuring RCV is responsibly debated and considered. RCV is a valuable reform. We are grateful to our democracy partners, FairVoteMN, who have tirelessly championed this work biennium after biennium. It is an exciting time for pro-democracy reforms in Minnesota.

Thank you for your dedication to all Minnesotans as you work in committee.
